Travelling and Subsistence Allowances to Councillors

REGULATIONS, DATED 5TH APRIL 1973, MADE BY THE MINISTRY OF DEVELOP-MENT UNDER SECTION 36 OF THE LOCAL GOVERNMENT ACT (NORTHERN IRELAND) 1972 WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Development on behalf of the Secretary of State and in exercise of the powers conferred on it by section 36 of the Local Government Act (Northern Ireland) 1972(a) (hereinafter referred to as "the Act") and of every other power enabling it in that behalf and with the approval of the Ministry of Finance hereby makes the following regulations:—

Citation, commencement and revocation

1. These regulations may be cited as the Local Government (Travelling and Subsistence Allowances to Councillors) Regulations (Northern Ireland) 1973 and shall come into operation on 30th May 1973 and shall cease to have effect on 1st October 1973.

Travelling and subsistence expenses

2. District councils may make payments to councillors by way of travelling and subsistence allowances in accordance with the provisions of the Local Government (Allowances to Members) Regulations (Northern Ireland) 1970(b) and for that purpose the definitions of the words "body" and "member" in Article 2 of those Regulations shall be taken to include a district council as defined in section 1(3) of the Act, and any committee or sub-committee of such a council, and councillors as defined in section 36(2) of the Act respectively.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations provide that for the period from the first election of councillors to new district councils until 1st October 1973 (at which date such district councils are to assume their full functions) such councillors may be paid travelling and subsistence allowances on the same rates and subject to the same conditions as are applicable to members of existing local authorities.
