## FOYLE FISHERIES

### Fovle Area (Dealers' Registers) Regulations 1973

REGULATIONS, DATED 27TH MARCH 1973, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR AGRICULTURE AND FISHERIES IN THE IRISH REPUBLIC UNDER SECTION 13 OF THE FOYLE FISH-ERIES ACT 1952 AND OF THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND) 1952.

The Foyle Fisheries Commission hereinafter referred to as "the Commission" in exercise of its powers under section 13 of the Foyle Fisheries Act 1952, section 13 of the Foyle Fisheries Act (Northern Ireland) 1952(a), section 163 of the Fisheries (Consolidation) Act 1959 and section 120 of the Fisheries Act (Northern Ireland) 1966(b), hereby makes the following regulations:—

- 1. These Regulations may be cited as the Foyle Area (Dealers' Registers) Regulations 1973, and shall come into force on the 1st day of May 1973.
  - 2. In these Regulations—
  - "fishing season" means any period during which angling or netting is authorised by Regulation;
  - "Foyle Area" has the meaning given to it by section 3 of the Foyle Fisheries Act 1952 and section 3 of the Foyle Fisheries Act (Northern Ireland) 1952.
- 3. The Register to be kept by licence holders in accordance with section 163 of the Fisheries (Consolidation) Act 1959 and section 114 of the Fisheries Act (Northern Ireland) 1966 shall be in the form specified in the Schedule hereto and shall be maintained in duplicate.
- 4. Every licence holder or person keeping a Register in the Foyle Area shall, not later than three days after the expiration of every week which or part of which is in the fishing season of any year, send to the Commission the duplicate copy or copies of all the entries which have been made in the Register for that week or part of a week.
- 5. If no entries have been made in a Register in any week which or part of which is in the fishing season of any year, the licence holder or person keeping the Register shall, not later than three days after the expiration of such week or part of a week, advise the Commission in writing that he made no purchases or sales of salmon during the said period.
- 6. The Foyle Area (Dealers' Registers) Regulations 1968(c) are hereby revoked.
