ROAD TRAFFIC

Speed Limits

ORDER, DATED 5TH JULY 1973, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 43(4) OF THE ROAD TRAFFIC ACT (NORTHERN IRELAND) 1970.

The Ministry of Home Affairs on behalf of the Secretary of State and in exercise of the powers conferred on it by section 43(4) of the Road Traffic Act (Northern Ireland) 1970(a) (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf hereby orders and directs as follows:—

Citation and commencement

1. This Order may be cited as the Roads (Speed Limit) (No. 2) Order (Northern Ireland) 1973 and shall come into operation on 1st August 1973.

Speed restrictions on certain roads

2. Each of the lengths of road specified in the Schedule shall be a restricted road for the purposes of section 43 of the Act.

EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport.)

This Order has the effect of applying a 30 mph speed limit to various lengths of road in Counties Antrim, Down, Londonderry and Tyrone.
