**FOYLE FISHERIES****Foyle Area (Weekly Close Time) (River Roe) Regulations 1973**

REGULATIONS, DATED 14TH JUNE 1973, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR AGRICULTURE AND FISHERIES IN THE IRISH REPUBLIC UNDER SECTION 13 OF THE FOYLE FISHERIES ACT 1952 AND OF THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND) 1952.

The Foyle Fisheries Commission in exercise of its powers under sections 13 and 28 of the Foyle Fisheries Act 1952 and sections 13 and 27 of the Foyle Fisheries Act (Northern Ireland) 1952(a) hereby makes the following regulations:—

1. These Regulations may be cited as the Foyle Area (Weekly Close Time) (River Roe) Regulations 1973 and shall come into force on the 1st day of July 1973.

2. The Weekly Close Time in the tidal waters of the River Roe for the purpose of section 28 of the Foyle Fisheries Act 1952 and section 27 of the Foyle Fisheries Act (Northern Ireland) 1952 shall begin at 06.00 hours on Saturday and end at 18.00 hours on the following Tuesday.

3. Article 2 of the Foyle Area (Weekly Close Time) Regulations 1970(b) is hereby amended by the deletion of the words “, the River Foyle, and the River Roe” and the substitution therefor the words “and the River Foyle”.

4. The Foyle Area (Suspension of Fishing) Regulations 1972(c) shall not apply to the tidal waters of the River Roe.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations, but is intended to indicate their general purport.)*

These regulations, by amending the Foyle Area (Weekly Close Time) Regulations 1970, make provision for a separate 84 hours weekly close time period for the River Roe. The regulations also stipulate that the Foyle Area (Suspension of Fishing) Regulations 1972 shall not apply to the River Roe.
