NATIONAL INSURANCE (INDUSTRIAL INJURIES)

Hospital In-Patients

REGULATIONS, DATED 31ST AUGUST 1973, MADE BY THE INDUSTRIAL INJURIES JOINT AUTHORITY AND THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACTS (NORTHERN IRELAND) 1966 TO 1971.

The Industrial Injuries Joint Authority, in exercise of powers conferred by section 33(2)(a) of the National Insurance (Industrial Injuries) Act (Northern Ireland) 1966(a), and the Ministry of Health and Social Services on behalf of the Secretary of State, in exercise of powers conferred by section 30A(b) of that Act, and of all other powers enabling them in that behalf, hereby make the following regulations being regulations subject to negative resolution in accordance with section 80(2) of the said Act:

Citation and commencement

1. These regulations, which may be cited as the National Insurance (Industrial Injuries) (Hospital In-Patients) Amendment Regulations (Northern Ireland) 1973, shall be read as one with the National Insurance (Industrial Injuries) (Hospital In-Patients) Regulations (Northern Ireland) 1971(c) (hereinafter referred to as "the principal regulations") and shall come into operation on 3rd September 1973.

Amendment of regulation 1(2) of the principal regulations

2. In regulation 1(2) of the principal regulations for the words "the In-Patients Regulations' means the National Insurance (Hospital In-Patients) Regulations (Northern Ireland) 1961" there shall be substituted the words "the In-Patients Regulations' means the National Insurance (Hospital In-Patients) Regulations (Northern Ireland) 1973(d);".

Amendment of regulation 3(2) of the principal regulations

3. In regulation 3(2) of the principal regulations for the words "National Insurance (Overlapping Benefits) Regulations (Northern Ireland) 1961" there shall be substituted the words "National Insurance (Overlapping Benefits) Regulations (Northern Ireland) 1973(e)".

Amendment of regulation 4 of the principal regulations

4. In regulation 4 of the principal regulations for the words "regulation 6" there shall be substituted the words "regulation 7", for the words "regulation 6(7)(b)" there shall be substituted the words "regulation 7(7)(b)" and for the words "the Overlapping Benefits Regulations" there shall be substituted the words "those regulations".

Amendment of regulation 5 of the principal regulations

5.—(1) In regulation 5(1) of the principal regulations for the words "regulation 7" wherever they appear there shall be substituted the words "regulation 10", for the words "regulation 10" wherever they appear there shall be substituted the words "regulation 11" and for the words "regulation 11" wherever they appear there shall be substituted the words "regulation 11" and for the words "regulation 11" wherever they appear there shall be substituted the words "regulation 12".

(2) In regulation 5(2) of the principal regulations for the words "regulation 12" there shall be substituted the words "regulation 13" and for the words "regulation 14" there shall be substituted the words "regulation 9".

(3) In regulation 5(3) of the principal regulations for the words "regulation 10" there shall be substituted the words "regulation 11".

(4) In regulation 5(3)(b) of the principal regulations for the words "regulation 6" there shall be substituted the words "regulation 7".

Amendment of regulation 6 of the principal regulations

6. In regulation 6 of the principal regulations for the words "regulation 6(7)" there shall be substituted the words "regulation 7(7)".
