Duration of Certificates

ORDER, DATED 17th October 1973, MADE BY THE SECRETARY OF STATE UNDER SECTION 5(6) OF THE PEDLARS ACT 1871.

WHEREAS by section 5(6) of the Pedlars Act 1871(a) it is provided that the Governor of Northern Ireland may from time to time provide for the expiration of pedlars' certificates at the same period of each year and in so doing shall provide for the apportionment of the fees payable in respect of any such certificate:

AND WHEREAS by Order-in-Council dated 18th March 1873(b) it was provided that a pedlar's certificate should expire on 31st December of a year and the fee for a pedlar's certificate should be apportioned in the manner thereby directed:

AND WHEREAS by section 8 of the said Act of 1871 the Governor of Northern Ireland may direct that the register of pedlars' certificates shall be kept in the form so directed and with such particulars as may be so directed:

AND WHEREAS by direction dated 25th May 1967 the Governor of Northern Ireland directed that the said register should be in the form and contain the particulars specified in the direction:

AND WHEREAS by subsection (1)(a) of section 1 of the Northern Ireland (Temporary Provisions) Act 1972(c) it is provided that so long as that section has effect all functions which apart from that Act belong to the Governor or to the Governor in Council shall be discharged by the Secretary of State:

NOW, THEREFORE, the Secretary of State in exercise of the powers conferred on him by sections 5(6) and 8 of the said Act of 1871 and of all other powers enabling him in that behalf hereby directs and orders as follows:-

Citation

1. This Order may be cited as the Pedlars' Certificates Order (Northern Ireland) 1973.

Duration of Pedlars' Certificates

2. A Pedlar's certificate shall remain in force for one year from the date of its issue and accordingly the said Order-in-Council dated 18th March 1873 is hereby revoked.

Saving for direction as to form of and particulars in certificate

3.
