The Scottish Ministers, in exercise of the powers conferred by section 1(1) and (2) of the Food and Environment Protection Act 1985(a), and of all other powers enabling them in that behalf, hereby make the following Order:

Citation and commencement

1. This Order may be cited as the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 12) (Scotland) Revocation Order 2002 and shall come into force at 1600 hours on 19th April 2002.

Revocation

2. The Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 12) (Scotland) Order 2001(**b**) and the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 12) (Scotland) Partial Revocation Order 2002(**c**) are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order revokes the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 12) (Scotland) Order 2001 ("the principal Order") which prohibited—

- (a) fishing for or taking scallops within the area designated in the Schedule to that Order (article 4 of the principal Order);
- (b) movement of such scallops out of that area (article 5 of the principal Order); and
- (c) landing, using in the preparation or processing for supply of food of, supplying and other specified activities in relation to, such scallops from the designated area (article 6 of the principal Order).

The principal Order had been partially revoked by the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 12) (Scotland) Partial Revocation Order 2002, which is also revoked by his Order. The effect of this Order is to remove the remaining prohibitions in respect of the area of sea designated in the Schedule to the principal Order.
