# The Education (Student Loans) Amendment (Scotland) Regulations 2006

Made - - - - 6th June 2006

Laid before the Scottish Parliament 7th June 2006

Coming into force - - 1st August 2006

The Scottish Ministers, in exercise of the powers conferred by section 1(7) of and paragraph 1(1)(a) of Schedule 2 to the Education (Student Loans) Act 1990(a), and of all other powers enabling them in that behalf, hereby make the following Regulations:

#### Citation, commencement and extent

- 1.—(1) These Regulations may be cited as the Education (Student Loans) Amendment (Scotland) Regulations 2006 and shall come into force on 1st August 2006.
- (2) These Regulations shall extend to Scotland and, in so far as they extend beyond Scotland, they do so only as a matter of Scots  $Law(\mathbf{b})$ .

The functions of the Secretary of State under the Education (Student Loans) Act 1990 were transferred, in or as regards Scotland, to the Scotlish Ministers by virtue of section 53 of the Scotland Act 1998 (c.46), read with article 3 of and paragraph 11 of Schedule 1 to the Scotland Act 1998 (Functions Exercisable in or as Regards Scotland) Order 1999 (S.I. 1999/1748).

<sup>(</sup>b) These Regulations extend beyond Scotland because the functions of the Scottish Ministers are exercisable with regard to certain students who are outside Scotland, by virtue of S.I. 1999/1748.

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations, which come into force on 1st August 2006, amend the Education (Student Loans) Regulations 1998 governing loans made under the Education (Student Loans) Act 1990. These are mortgage style repayment loans made, for the most part, to students who began their courses before 1st August 1998.

These Regulations increase the maximum amounts which may be lent to students in relation to an academic year in line with inflation (regulation 2).
