**The Civil Partnership Act 2004 (Modification of Subordinate
Legislation) (Scotland) Revocation Order 2007**

The Scottish Ministers, in exercise of the powers conferred by section 259(1), (2) and (4) of the Civil Partnership Act 2004(a) and of all other powers enabling them in that behalf, hereby make the following Order:

Citation, commencement and extent

1. This Order may be cited as the Civil Partnership Act 2004 (Modification of Subordinate Legislation) (Scotland) Revocation Order 2007 and shall come into force on 1st August 2007.
2. This Order shall extend to Scotland only.

Revocation

3. The Order specified in column 1 of the Schedule is revoked to the extent specified in column 3 thereof.
