The Scottish Ministers, in exercise of the powers conferred by section 252 of the Town and Country Planning (Scotland) Act 1997(1) and of all other powers enabling them in that behalf, hereby make the following Regulations, a draft of which has, in accordance with subsection (4) of that section, been laid before, and approved by resolution of the Scottish Parliament:

Citation, commencement, interpretation and application

- 1.—(1) These Regulations may be cited as the Town and Country Planning (Fees for Applications and Deemed Applications) (Scotland) Amendment Regulations 2007 and shall come into force on 1st April 2007.
- (2) In these Regulations "the principal Regulations" means the Town and Country Planning (Fees for Applications and Deemed Applications) (Scotland) Regulations 2004(2).
 - (3) These Regulations apply to-
 - (a) applications referred to at regulation 1(2)(a) of the principal Regulations which are made on or after 1st April 2007; and
 - (b) deemed applications for planning permission in connection with an enforcement notice issued on or after 1st April 2007.
