The Housing (Scotland) Act 2006 (Repayment Charge and Discharge) Order 2007

Made	6th September 2007
Laid before the Scottish Parliament	7th September 2007
Coming into force	8th October 2007

The Scottish Ministers make the following Order in exercise of the powers conferred by section 174 of the Housing (Scotland) Act 2006(a) and all other powers enabling them to do so.

Citation and commencement

1. This Order may be cited as the Housing (Scotland) Act 2006 (Repayment Charge and Discharge) Order 2007 and comes into force on 8th October 2007.

Form of repayment charge and discharge

2. A repayment charge must be in the form set out in Schedule 1 or as close to it as circumstances permit.

3. A discharge of a repayment charge must be in the form set out in Schedule 2 or as close to it as circumstances permit.

Form of Repayment Charge

THE HOUSING (SCOTLAND) ACT 2006

REPAYMENT CHARGE
