**ROAD AND BRIDGES**

**The A9 Trunk Road (Highland Lights, Kessock Bridge) (Special Event) (Temporary Restriction of Speed) Order 2007**

*Made  
Coming into force*

*21<sup>st</sup> December 2007  
9<sup>th</sup> January 2008*

The Scottish Ministers make the following Order in exercise of the powers conferred on them by section 16A of the Road Traffic Regulation Act 1984<sup>(a)</sup> and of all other powers enabling them to do so

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted and or prohibited for the purpose of facilitating a firework display on the Kessock Bridge.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for such an event to be held otherwise than on that length of road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of an alternative route suitable for traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A9 Trunk Road (Highland Lights, Kessock Bridge) (Special Event) (Temporary Restriction of Speed) Order 2007, shall come into force at 00.01 hours on 9<sup>th</sup> January 2008 and shall cease to have effect at midnight on 14<sup>th</sup> January 2008.

## **Temporary Speed Restriction**

2. No person shall use, or permit the use of, any vehicle on that length of road specified in the Schedule at a speed exceeding 30 mph when identified as applying to a part or parts of that length of road by means of a traffic sign prescribed by the Traffic Signs Regulations and General Directions 2002(a).

That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road from its junction with the A82 Dalnottar – Inverness Trunk Road, at Longman Roundabout, Inverness northwards for a distance of 1.65km or thereby.
