The Official Statistics (Scotland) Order 2008

Made - - - - 18th March 2008

Coming into force in accordance with article 1(1)

The Scottish Ministers make the following Order in exercise of the powers conferred by section 6(1)(b)(ii) and (2) of the Statistics and Registration Service Act 2007(a) and all other powers enabling them to do so.

In accordance with section 6(3) of that Act, they have consulted the Statistics Board.

In accordance with section 65(6)(a) of that Act, a draft of this instrument has been laid before and approved by resolution of the Scottish Parliament.

Citation, commencement and extent

- 1.—(1) This Order may be cited as the Official Statistics (Scotland) Order 2008, and comes into force on the day after the day on which it is made.
- (2) It extends to Scotland, and insofar as it extends beyond Scotland, it does so only as a matter of Scots law.

Official statistics

2. Wholly Scottish devolved statistics(\mathbf{b}) produced, or to be produced, by the persons listed in the Schedule are specified as official statistics for the purposes of section $6(1)(\mathbf{b})$ of the Statistics and Registration Service Act 2007.

They are specified in addition to official statistics produced by the Statistics Board, a government department, the Scottish Administration, a Welsh ministerial authority, a Northern Ireland department, or any other person acting on behalf of the Crown, under section 6(1)(a) of the Statistics and Registration Service Act 2007, or specified in other orders under that section.
