# ROAD TRAFFIC

The A92 Trunk Road (B969 Western Avenue Junction, Glenrothes) (Temporary Prohibition of Specified Turns) Order 2008

Made 25<sup>th</sup> March 2008

Coming into force 5<sup>th</sup> April 2008

The Scottish Ministers make the following Order in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in Part 1 of the Schedule should be prohibited from making any turn specified in Part 2 of the Schedule because works are being or are proposed to be executed on or near the said length of road.

In accordance with section 14(3) of that Act, they are satisfied that there is an alternative route suitable for traffic which will be affected by this Order.

## Citation, commencement and cessation

1. This Order may be cited as the A92 Trunk Road (B969 Western Avenue Junction, Glenrothes) (Temporary Prohibition of Specified Turns) Order 2008, comes into force on 5th April 2008 and ceases to have effect at midnight on 22nd April 2008.

### Prohibition of use of vehicles

2. Subject to Articles 3 and 4 of this Order, no person shall use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule when such prohibition is identified as applying to any part or parts of the said length of road by means of one or more of the traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations and General Directions 2002(b).

## **Direction of Police Constable**

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

# **Exemption for emergency and works vehicles**

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

#### **SCHEDULE**

## PART 1

That length of the A92/A972 Kirkcaldy – Dundee Trunk Road from a point 130 metres or thereby south of the B969 Western Avenue Junction, Glenrothes northwards to a point 130 metres or thereby north of the B969 Western Avenue Junction, Glenrothes, a distance of 260 metres or thereby.

## PART 2

- 1) All right turns from the A92/A972 Kirkcaldy Dundee Trunk Road southbound carriageway to the B969 Western Avenue Junction, Glenrothes.
- 2) All left turns from the A92/A972 Kirkcaldy Dundee Trunk Road northbound carriageway to the B969 Western Avenue Junction, Glenrothes.
