ROAD TRAFFIC

The A92/A972 Trunk Road (Cadham Road and Car Wash Facility) (Prohibition of Specified Turns) Order 2008

Made 18th January 2008

Coming into force 1st February 2008

The Scottish Ministers, in exercise of the powers conferred by section 1(1) as read with sections 2(1) and 2(2) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them in that behalf, and having complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b), hereby make the following Order:

Citation and commencement

1. This Order may be cited as the A92/A972 Trunk Road (Cadham Road and Car Wash Facility) (Prohibition of Specified Turns) Order 2008 and shall come into force on $1^{\rm st}$ February 2008.

Prohibition of use of vehicles

2. Subject to Articles 3 and 4 of this Order, no person shall use, or cause or permit the use of, any vehicle on the lengths of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the said Schedule.

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the New Roads and Street Works Act 1991 (c.22), Schedule 8, paragraph 70 and amended by the Scotland Act 1998 (Consequential Modifications) Order 2001 (S.I. 2001/1400)) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scotlish Ministers by section 53 of the Scotland Act 1998 (c.46).

Permission or direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

Exemption for emergency and works vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes.

SCHEDULE

PART 1

- 1. That length of the A92/A972 Trunk Road from a point 20 metres directly north of Cadham Road (C131) junction with the A92 Trunk Road to a point 23 metres directly south of the Cadham Road (C131) junction, with the A92 Trunk Road, a distance of 43 metres or thereby.
- 2. That length of the A92/A972 Trunk Road from a point 20 metres directly north of Cadham Road (C131) junction with the A92 Trunk Road, to a point 50 metres directly south of the Cadham Road (C131) junction, with the A92 Trunk Road, a distance of 70 metres or thereby.

PART 2

- 1. All right turns from the southbound carriageway of the A922 Trunk Road into Cadham Road (C131) junction with the A92 Trunk Road.
- 2. All right turns from the southbound carriageway of the A92/A972 Trunk Road into Private Access (Car Wash Facility) on the A92 Trunk Road.
