The Scottish Ministers make the following Order in exercise of the powers conferred by section 7(1), (2) and (3) of the Diseases of Fish Act $1983(\mathbf{a})$ and all other powers enabling them to do so.

Citation, commencement and extent

1.—(1) This Order may be cited as the Registration of Fish Farming and Shellfish Farming Businesses Amendment (Scotland) Order 2008 and comes into force on 27th June 2008.

(2) This Order extends to Scotland only.

Amendment of the Registration of Fish Farming and Shellfish Farming Businesses Order 1985

2.—(1) The Registration of Fish Farming and Shellfish Farming Businesses Order 1985(**b**) is amended as follows.

(2) For Schedule 4 substitute the Schedule set out in Schedule 1 to this Order.

(3) For Schedule 5 substitute the Schedule set out in Schedule 2 to this Order.
