ROAD TRAFFIC

The A92/A972 Trunk Road (Scott Fyffe Roundabout, Dundee to Pitkerro Roundabout, Dundee) (Temporary Prohibition of Specified Turns) Order 2008

Coming into force

18th July 2008
1st August 2008

The Scottish Ministers make the following Order in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in Part 1 of the Schedule to this Order should be prohibited from making any turn specified in Part 2 of the Schedule to this Order because works are being or are proposed to be executed on or near the said length of road.

In accordance with section 14(3) of that Act, they are satisfied that there is an alternative route suitable for traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A92/A972 Trunk Road (Scott Fyffe Roundabout, Dundee to Pitkerro Roundabout, Dundee) (Temporary Prohibition of Specified Turns) Order 2008, comes into force on 1st August 2008 and ceases to have effect at midnight on 18th August 2008.

Prohibition of use of vehicles

2. Subject to Articles 3 and 4 of this Order, no person shall use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule to this Order when such prohibition is identified as applying to any part or parts of the said length of road by means of traffic signs as prescribed by Diagram 612 of the Traffic Signs Regulations and General Directions 2002(b).

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Permission or direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

Exemption for emergency and works vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

SCHEDULE

PART 1

That length of the A92/A972 Kirkcaldy – Dundee Trunk Road from a point at Scott Fyffe Roundabout, Dundee northwards to a point at Pitkerro Roundabout, Dundee, a distance of 1.3 kilometres or thereby.

PART 2

1. All right turns from the A92/A972 Kirkcaldy – Dundee Trunk Road northwards to Longtown Road, Dundee.
2. All right turns from Mid Craigie Road southwards to the A92/A972 Kirkcaldy to Dundee Trunk Road.

THE A92/A972 TRUNK ROAD (SCOTT FYFFE ROUNDABOUT, DUNDEE TO PITKERRO ROUNDABOUT, DUNDEE) (TEMPORARY PROHIBITION OF SPECIFIED TURNS) ORDER 2008

THE SCOTTISH MINISTERS give notice that they have made the above Order temporarily prohibiting traffic on that length of the A92/A972 Kirkcaldy – Dundee Trunk Road from a point at Scott Fyffe Roundabout, Dundee northwards to a point at Pitkerro Roundabout, Dundee, a distance of 1.3 kilometres or thereby from making any of the following turns:

- 1 All right turns from the A92/A972 Kirkcaldy – Dundee Trunk Road northwards to Longtown Road, Dundee.
- 2 All right turns from Mid Craigie Road southwards to the A92/A972 Kirkcaldy to Dundee Trunk Road.

The Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow the installation of ducting beneath the road surface, will be in operation from 1st August 2008 until midnight on 18th August 2008, but will only have effect in relation to such part or parts of the said length of road as are indicated by the appropriate traffic signs. The Order does not apply to works vehicles or vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.

Alternative routes for traffic in relation to the length of road affected by the Order during the prohibition will be as signposted. Detailed descriptions can be obtained at BEAR Scotland Ltd, BEAR House, Inveralmond Road, Inveralmond Industrial Estate, Perth PH1 3TW.
