## The A9 Trunk Road (Bankfoot Junction Improvement) <br> (Side Roads) Order 2008

Made - - - - 6th October 2008<br>Coming into force - - 17th October 2008

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 12(1) and (5), 70(1) and 145 of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

In accordance with section 12(3) of that Act, they are satisfied that another reasonably convenient route is available or will be provided before any road is stopped up pursuant to this Order.

In accordance with section 71(3) of that Act, they are satisfied that another access will be provided before the access is stopped up.

In accordance with sections $20 \mathrm{~A}(\mathbf{b})$ and $55 \mathrm{~A}(\mathbf{c})$ of that Act, they have determined that the project falls within Annex II to Council Directive $85 / 337 /$ EEC(d) on the assessment of the effects of certain public and private projects on the environment but having regard to the selection criteria contained in Annex III it should not be made subject to an environmental impact assessment in accordance with the Directive.

They have complied with the requirements of Part I of Schedule 1(e) to that Act.

## Citation, commencement and interpretation

1. (1) This Order may be cited as the A9 Trunk Road (Bankfoot Junction Improvement) (Side Roads) Order 2008 and shall come into force on $17^{\text {th }}$ October 2008.
(2) In this Order "the plan folio" means the plan folio numbered NW/A9/BANKFOOT/SRO/EO and entitled "The A9 Trunk Road (Bankfoot Junction Improvement) (Side Roads) Order 2008", signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.

## Side roads and means of access

2. The Scottish Ministers as roads authority are authorised-
(a) to construct those lengths of road (hereinafter referred to as "the new side roads") along the routes described in Schedule 1;
(b) to improve those lengths of road described in Schedule 2;
(c) to stop up those lengths of road described in Schedule 3 when the new side roads are open for the purposes of through traffic;
(d) to stop up that private means of access described in Schedule 4 when the new means of access described in paragraph 8 of Schedule 5 has been provided; and
(e) to provide those new means of access described in Schedule 5.

## Statutory Undertakers

3. Where immediately before the date this Order comes into force there is under, in, on, over, along or across any of the lengths of road described in Schedules 2 and 3 any apparatus of a statutory undertaker, any rights of the statutory undertaker in respect of such apparatus shall be preserved.

## Transfer of Roads

4. On $1^{\text {st }}$ April next after the date on which the new side roads are all open for the purposes of through traffic, the new side roads shall be transferred to Perth \& Kinross Council(a) as roads authority for those roads.

## Revocation of Previous Orders

5. The A9 Trunk Road (Bankfoot Junction Improvement) (Side Roads) Order 2003(a) is hereby revoked.

3. From a point 44 metres or thereby east, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB in a generally south, south-westerly then west, south-westerly direction for a distance of 52 metres or thereby to a point 54 metres or thereby south, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB as shown by stipple and numbered " 3 " on plan SR1 in the plan folio.
4. From a point 434 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY, in a generally south, southwesterly direction for a distance of 119 metres or thereby to a point 538 metres or thereby south of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by stipple and numbered " 4 " on plan SR2 in the plan folio.
5. From a point 375 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally south-westerly direction for a distance of 120 metres or thereby and then in a generally south, south-easterly direction for a distance of 17 metres or thereby to a point 431 metres or thereby south of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 $4 D Y$ as shown by stipple and numbered " 5 " on plan SR2 in the plan folio.
6. From a point 388 metres or thereby south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally west, south-westerly direction for a distance of 58 metres or thereby to a point 381 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by stipple and numbered " 6 " on plan SR2 in the plan folio.
7. From a point 392 metres or thereby south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally west, south-westerly direction for a distance of 51 metres or thereby to a point 380 metres or thereby south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by stipple and numbered " 7 " on plan SR2 in the plan folio.

2. From a point 30 metres or thereby south, south-west of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB in a generally south-easterly and then in an easterly direction for a distance of 87 metres or thereby to a point 76 metres or thereby south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB as shown by cross hatching and numbered " 9 " on plan SR1 in the plan folio.
3. From a point 82 metres or thereby east, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB in a generally north-easterly direction for a distance of 11 metres or thereby to a point 87 metres or thereby east, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB as shown by cross hatching and numbered " 10 " on plan SR1 in the plan folio.

7. From a point 394 metres or thereby south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally west, south-westerly direction for a distance of 119 metres or thereby to a point 382 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by cross hatching and numbered " 14 " on plan SR2 in the plan folio.

2. That length of the existing private access track serving Ardonachie Farm, Bankfoot, Perth, PH1 4DY from a point 549 metres or thereby south of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally east, north-easterly direction for a distance of 19 metres or thereby to a point 544 metres or thereby south of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 $4 D Y$ as shown by zebra hatching and numbered " 16 " on plan SR2 in the plan folio.
3. That length of the existing Pitcairngreen - Stewart Tower Road (C408) from a point 435 metres or thereby south of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally south, south-westerly direction for a distance of 104 metres or thereby to a point 528 metres or thereby south of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by zebra hatching and numbered " 17 " on plan SR2 in the plan folio.
4. That length of the existing Pitcairngreen - Stewart Tower Road (C408) from a point 381 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally south-westerly direction for a distance of 116 metres or thereby to a point 431 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by zebra hatching and numbered " 18 " on plan SR2 in the plan folio.
5. That length of the existing Pitcairngreen - Stewart Tower Road (C408) from a point 380 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY in a generally west, south-westerly direction for a distance of 47 metres or thereby to a point 375 metres or thereby south, south-east of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by zebra hatching and numbered " 19 " on plan SR2 in the plan folio.

## PRIVATE MEANS OF ACCESS TO BE STOPPED UP

The private means of access on the north side of the existing Pitcairngreen - Stewart Tower Road (C408) at a point 540 metres or thereby south of the south-western-most corner of the building known as Broompark Cottage, Bankfoot, Perth, PH1 4DY as shown by a solid black bar and numbered " 20 " on plan SR2 in the plan folio.

## NEW MEANS OF ACCESS TO BE PROVIDED

1. From a point 76 metres or thereby south, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB in a generally south-westerly direction for a distance of 11 metres or thereby to a point 78 metres or thereby south, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB as shown by single hatching and numbered " 21 " on plan SR1 in the plan folio.
2. From a point 65 metres or thereby south, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB in a generally southerly direction for a distance of 20 metres or thereby to a point 83 metres or thereby south, south-east of the south-eastern-most corner of the building known as Hilton Bungalow, Bankfoot, Perth, PH1 4EB as shown by single hatching and numbered " 22 " on plan SR1 in the plan folio.
3.
