**ROAD TRAFFIC**

The A82 Trunk Road (Invermoriston to Fort Augustus, Portclair) (Temporary Prohibition of Traffic, Temporary Prohibition of Overtaking and Temporary Speed Restriction) Order 2008

*30<sup>th</sup> October 2008*

*Coming into force*

*10<sup>th</sup> November 2008*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 14(1) and (4), 2(1), (2) and (3), and 4(1) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

**1.** This Order may be cited as the A82 Trunk Road (Invermoriston to Fort Augustus, Portclair) (Temporary Prohibition of Traffic, Temporary Prohibition of Overtaking and Temporary Speed Restriction) Order 2008, comes into force on 10<sup>th</sup> November 2008 and ceases to have effect at midnight on 27th March 2009.

**Temporary prohibition on use of vehicles**

**2.** Subject to Article 6, no person shall use, or permit the use of, any vehicle on the length of road specified in the Schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(b).

### **Temporary prohibition on use by pedestrians**

**3.** Subject to Article 6, no pedestrians shall use that length of road specified in the Schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in Diagram 7010.1 and 625.1 of the Traffic Signs Regulations 2002.

### **Temporary prohibition on overtaking**

**4.–1)** Subject to paragraph (2) of this Article, no person shall use, or permit the use of, any vehicle in such a way that it overtakes any other moving vehicle on the length of road specified in the Schedule when a prohibition is identified as applying to a part or parts of that length of road by means of a traffic sign prescribed in Diagram 632 of the Traffic Signs Regulations 2002.

(2) Nothing in paragraph (1) of this Article shall prohibit any person from using, or permitting the use of, any vehicle in such a way that it overtakes a cycle, motor cycle, tricycle or any other vehicle not being a motor vehicle in accordance with section 140 of the Road Traffic Regulation Act 1984(a).

### **Temporary speed restriction**

**5..** No person shall use or permit the use of, any vehicle on the length of road specified in the Schedule to this Order at a speed exceeding 40 miles per hour when identified as applying to a part or parts of the length of road by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002. .

### **Exemption for emergency and works vehicles**

**6.** Nothing in Article 2 of this Order shall apply to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.

### **Exemption for workers**

**7.** Nothing in Article 3 of this Order shall apply to a person carrying out a duty in relation to the works.

That length of the A82 Dalnottar – Inverness Trunk Road from a point 3.7 kilometres or thereby south of the A887/A82 Invermoriston junction southwards to a point 5.6 kilometres or thereby north of the B862/A82 junction in Fort Augustus, a distance of 1 kilometre or thereby.
