ROAD TRAFFIC

**The A84 Trunk Road (Main Street and Leny Road, Callander)
(Temporary Prohibition of Waiting, Loading and Unloading)
Order 2012**

Made - - - - 24th January 2012

Coming into force - - 6th February 2012

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be prohibited from waiting, loading and unloading because works are being or are proposed to be executed on or near that length of road.

Citation, commencement and cessation

1. This Order may be cited as the A84 Trunk Road (Main Street and Leny Road, Callander) (Temporary Prohibition of Waiting, Loading and Unloading) Order 2012, comes into force on 6th February 2012 and ceases to have effect on 30th March 2012.

Temporary prohibition

2. No person shall cause or permit any vehicle to wait, load or unload at any time on the length of road specified in the Schedule, when such prohibition is identified as applying to any part or parts of that length of road by means of traffic signs prescribed in Diagrams 636 and 636.1 of the Traffic Signs Regulations 2002(b).

Exceptions

3. This Order does not apply to anything done with the permission or upon the direction of a police constable in uniform.

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the New Roads and Street Works Act 1991, Schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

4. This Order does not apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle while being used for carrying out the works.

SCHEDULE

Article 2

That length of the A84/A85 Stirling – Crianlarich Trunk Road from its junction with Murdiston Avenue northwestwards to its junction with the north access to Leny Feus, a distance of 1.65 kilometres or thereby.
