# Act of Sederunt (Fees of Sheriff Officers) (Amendment) (No. 2) 2012

Made - - - - 10th December 2012

Laid before the Scottish Parliament 12th December 2012

Coming into force - - 28th January 2013

The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 40 of the Sheriff Courts (Scotland) Act 1907(a), section 6 of the Execution of Diligence (Scotland) Act 1926(b) and of all other powers enabling them in that behalf, do hereby enact and declare:

#### Citation and commencement

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Sheriff Officers) (Amendment) (No. 2) 2012 and comes into force on 28th January 2013.
  - (2) A certified copy of this Act of Sederunt is to be inserted in the Books of Sederunt.

### **Amendment of fees**

- **2.**—(1) Subject to subparagraph (2) below, for the Table of Fees in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) (No. 2) 2002(c) substitute the Table of Fees in the Schedule to this Act of Sederunt.
- (2) Subparagraph (1) shall apply only to work carried out by a sheriff officer on or after 28th January 2013 but shall not affect the fees payable as respects any work so carried out before that date.
