The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 40 of the Sheriff Courts (Scotland) Act 1907(**a**), section 6 of the Execution of Diligence (Scotland) Act 1926(**b**) and of all other powers enabling them in that behalf(**c**), do hereby enact and declare:

Citation and commencement

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Sheriff Officers) 2013 and comes into force on 27th January 2014.
 - (2) A certified copy of this Act of Sederunt is to be inserted in the Books of Sederunt.

Amendment of fees

2. For the Table of Fees in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) (No. 2) 2002(**d**) substitute the Table of Fees in the Schedule to this Act of Sederunt.

Savings

3. Paragraph 2 does not affect the fees payable as respects any work carried out before 27th January 2014.
