TRANSPOSITION NOTE

The Concession Contracts (Scotland) Regulations 2016 ("the Regulations") bring into force provisions to comply with the obligations of the relevant Articles of Directive 2014/23/EU of the European Parliament and of the Council on procurement for the award of concession contracts in Scotland.
