TRANSPOSITION NOTE

The provisions in Part II (environmental impact assessment) of the Flood Risk Management (Flood Protection Schemes, Potentially Vulnerable Areas and Local Plan Districts) (Scotland) Regulations 2010⁽¹⁾, as amended by the Flood Risk Management (Flood Protection Schemes, Potentially Vulnerable Areas and Local Plan Districts) (Scotland) Regulations 2017 ("the Amended Regulations") implement Directive 2011/92/EU of the European Parliament and of the Council on the assessment of the effects of certain public and private projects on the environment⁽²⁾ ("the Directive") in so far as it applies in relation to flood protection schemes.

Section 60 of the Flood Risk Management (Scotland) Act 2009 ("the Act") makes provision in relation to flood protection schemes. A flood protection scheme is a scheme by a local authority for the management of flood risk. A proposed flood protection scheme must, among other things, contain a description of the operations the local authority proposes to carry out. Schedule 2 of the Act makes further provision about the making of flood protection schemes.

The Amended Regulations supplement the provisions in section 60 and schedule 2 of the Act to ensure that, where any such scheme contains a description of operations which constitute a project in Annex I or II of the Directive, the requirements of the Directive are met. The table below sets out how the Amended Regulations transpose the relevant Articles of the Directive in so far as it applies in relation to flood protection schemes in Scotland.
