ROAD TRAFFIC

The A82 Trunk Road (Glendoe Road, Fort Augustus) (Temporary Vehicle Width Restriction) Order 2017

Made - - - 8th June 2017

Coming into force - - 18th June 2017

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement, cessation and interpretation

- **1.**—(1) This Order may be cited as the A82 Trunk Road (Glendoe Road, Fort Augustus) (Temporary Vehicle Width Restriction) Order 2017, comes into force on 18th June 2017 and ceases to have effect on 4th July 2017.
 - (2) In this Order "A82" means the A82 Dalnottar to Inverness Trunk Road.

Vehicle Width Restriction

2. No person may use or permit the use of, any vehicle on the length of road specified in the schedule if the width of the vehicle exceeds 2.6 metres, when such restriction is identified as applying to any part or parts of that length of road by means of a traffic sign as prescribed in item 26 (diagram 629A – vehicles exceeding width indicated prohibited) of Part 2 of schedule 3 of the Traffic Signs Regulations and General Directions 2016(**b**).

Exemptions

- **3.** No prohibition imposed by this Order applies to—
 - (a) a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes; or
 - (b) a vehicle being used for carrying out the works.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A82 Dalnottar – Inverness Trunk Road from a point 4.3 kilometres or thereby northeast of its junction with the B862 Glendoe Road, Fort Augustus in a north eastwards direction to a point 6.3 kilometres or thereby northeast of that junction with the B862 Glendoe Road, Fort Augustus, a distance of 2 kilometres or thereby.
