**The ILF Scotland (Miscellaneous Listings) Order 2018**

**Citation and commencement**

1. This Order may be cited as the ILF Scotland (Miscellaneous Listings) Order 2018 and comes into force on 28th June 2018.

**Freedom of Information (Scotland) Act 2002**

2.—(1) The Freedom of Information (Scotland) Act 2002 is amended in accordance with paragraph (2).

(2) In Part 7 of schedule 1 (Scottish public authorities: others) after paragraph 67ZA(1) insert—  
“67ZB ILF Scotland(2).”.

**Public Appointments and Public Bodies etc. (Scotland) Act 2003**

3.—(1) The Public Appointments and Public Bodies etc. (Scotland) Act 2003 is amended in accordance with paragraph (2).

(2) In schedule 2 (the specified authorities)(3), under the heading “Executive Bodies”, after the entry relating to Historic Environment Scotland insert—  
“ILF Scotland”.

**Equality Act 2010**

4.—(1) The Equality Act 2010 is amended in accordance with paragraph (2).

(2) In Part 3 of schedule 19 (public authorities: relevant Scottish authorities)(4), at the end insert—

“Other body added on 28th June 2018  
ILF Scotland.”.

**Public Records (Scotland) Act 2011**

5.—(1) The Public Records (Scotland) Act 2011 is amended in accordance with paragraph (2).

(2) In the schedule (authorities to which Part 1 applies)(5), under the heading “Others”, after the entry relating to Highlands and Islands Enterprise insert—  
“ILF Scotland”.

(2) ILF Scotland is a company limited by guarantee, registered under number SC500075.  
(3) Schedule 2 was relevantly amended by paragraph 4(a) of schedule 6 of the 2014 Act.  
(4) Part 3 of schedule 19 has been relevantly amended by [S.S.I. 2015/83](#).  
(5) The schedule has been amended but none of the amendments are relevant to this Order.

## **Children and Young People (Scotland) Act 2014**

6.—(1) The Children and Young People (Scotland) Act 2014 is modified in accordance with paragraphs (2) to (4).

(2) In schedule 1 (authorities to which section 2 applies)(**6**), at the end insert—  
“21 ILF Scotland”.

(3) In schedule 3 (listed authorities)(**7**), at the end insert—  
“17 ILF Scotland”.

(4) In schedule 4 (corporate parents)(**8**), at the end insert—  
“26 ILF Scotland”.
