ROAD TRAFFIC

The M8/A8 Trunk Road (Baillieston to Bargeddie) (Temporary Prohibition on Use of Road) Order 2018

Made - - - - 4th September 2018

Coming into force - - 8th September 2018

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 16A of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the lengths of road specified in the schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M8/A8 Trunk Road (Baillieston to Bargeddie) (Temporary Prohibition on Use of Road) Order 2018, comes into force on 8th September 2018 and ceases to have effect on 10th September 2018.

Prohibition on use of vehicles

2. No person may use or permit the use of, any vehicle on a length of road, or a part or parts of a length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 - position of the barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(**b**).

Exemptions

- 3. No prohibition imposed by this Order applies to—
 - (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
 - (b) a vehicle being used for facilitating the holding of the relevant event.

SCHEDULE

Article 2

SPECIFIED LENGTHS OF ROAD

- **1.** That length of the M8/A8 Edinburgh Greenock Trunk Road, being the eastbound off slip at Junction 8 to the Bargeddie Roundabout, a distance of 730 metres or thereby.
- **2.** That length of the M8/A8 Edinburgh Greenock Trunk Road, being the eastbound carriageway of the A8 from a point 69 metres or thereby southeast of the point where the centreline of that carriageway intersects with the extended centreline of the road known as Swinton Avenue, Baillieston, to a point where the circulatory carriageway of the Bargeddie Roundabout diverges to the eastbound carriageway of the A89 Coatbridge Road, a distance of 1.44 kilometres or thereby.
