The South of Scotland Enterprise (Transfer of Property and Liabilities) (Scotland) Regulations 2020

The Scottish Ministers make the following Regulations in exercise of the powers conferred by section 20(2) of the South of Scotland Enterprise Act 2019(a) and all other powers enabling them to do so.

Citation and commencement

1. These Regulations may be cited as the South of Scotland Enterprise (Transfer of Property and Liabilities) (Scotland) Regulations 2020 and come into force on 1 June 2020.

Interpretation

2. In these Regulations—

“Scottish Enterprise” means Scottish Enterprise established under the Enterprise and New Towns (Scotland) Act 1990(b).

Transfer of property, rights, liabilities and obligations

3. The transferring property and liabilities of Scottish Enterprise for the purposes of section 20(2) of the South of Scotland Enterprise Act 2019 are—

- (a) all rights and interests belonging to Scottish Enterprise in any land and corporeal moveable property situated in the South of Scotland,
- (b) all rights and interests (other than rights or interests in land or corporeal moveable property) belonging to Scottish Enterprise so far as those relate to the South of Scotland other than those relating to the national purposes of Scottish Enterprise, and

(a) 2019 asp 9.
(b) 1990 c.35.

- (c) all those liabilities and obligations pertaining to the South of Scotland to which Scottish Enterprise is subject other than those relating to the national purposes of Scottish Enterprise.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations identify, for the purposes of section 20(2) of the South of Scotland Enterprise Act 2019, the transferring property and liabilities of Scottish Enterprise. Section 20(1) of that Act provides that the transferring property and liabilities of Scottish Enterprise are transferred to South of Scotland Enterprise. The appointed day for coming into force of section 20(1) is 1 June 2020, by virtue of S.S.I. 2019/308, as amended by S.S.I. 2020/85.

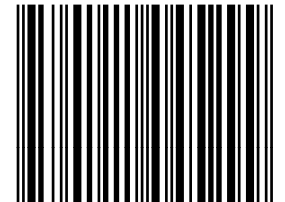
