

Transposition Note

Transposing Commission Implementing Directive (EU) 2019/1813

1. Commission Implementing Directive (EU) 2019/1813 ("the Amending Directive") amends Commission Implementing Directive 2014/96/EU ("the Principal Directive"). The Principal Directive sets down certain requirements for the labelling, sealing and packaging of officially certified fruit plant propagating material, officially certified fruit plants that are intended for fruit production, and propagating material and fruit that qualifies as *Conformitas Agraria Communatis* ("CAC") material. The requirements that are set down by the Principal Directive include the colour that labels of officially certified categories of propagating material and fruit plants must be, and the information that must be contained in the supplier's document that must accompany CAC material ("the Supplier's Document"). Both the Principal Directive and the Amending Directive fall within the scope of and are made under Council Directive 2008/90/EC.
2. The Principal Directive is transposed into domestic law by the Marketing of Fruit Plant and Propagating Material (Scotland) Regulations 2017 ("the Principal SSI"). The Marketing of Fruit Plant and Propagating Material (Scotland) Amendment Regulations 2020 ("the Amending SSI") amends the Principal SSI to reflect the changes made to the Principal Directive by the Amending Directive. The Amending SSI clarifies the colour that labels of officially certified categories of propagating material and fruit plants must be, reduces the amount of information that must be included in the Supplier's Document, requires that a Supplier's Document that is affixed in the form of a label to CAC material must be yellow in colour, and makes transitional provision that permits for a limited time the continued use of Supplier's Documents that do not conform with the new colour requirements.
