**The Animals, Food and Feed (EU Exit)
(Scotland) (Amendment) Regulations 2020**

Amendment of secondary legislation in exercise of powers
under section 2(2) of the European Communities Act 1972

Amendment of the Official Feed and Food Controls (Miscellaneous Amendments) (Scotland) Regulations 2020

4.—(1) The Official Feed and Food Controls (Miscellaneous Amendments) (Scotland) Regulations 2020(1) are amended as follows.

(2) In regulation 4 (amendment of the Official Feed and Food Controls (Scotland) Regulations 2009)—

- (a) in paragraph (2)(a), after “Decision 2007/275(2)”. insert ““Directive 2004/41(3)”,”,
- (b) in paragraph (11), for “EU” substitute “Community”,
- (c) in paragraph (13), after “to” insert “relevant”.

(3) In schedule 1, in the new schedule 1 (definitions of Community Legislation) inserted by that schedule—

- (a) in the definition of “Decision 2007/275” for “97/781” substitute “97/78(4)”,
- (b) after the definition of “Decision 2007/275” insert ““Directive 2004/41” means [Directive 2004/41/EC](#) of the European Parliament and of the Council repealing certain Directives concerning food hygiene and health conditions for the production and placing on the market of certain products of animal origin intended for human consumption and amending Council Directives [89/662/EEC](#) and [92/118/EEC](#) and Council [Decision 95/408/EC\(5\)](#)”,
- (c) in the definition of “Regulation 2017/625” omit “, 2015/1375(6)”,
- (d) in the definition of “Regulation 2019/1793” before “(EC) No. 178/2002” omit “20”,
- (e) in the definition of “Regulation 2020/466” after “during” insert “certain”.

(4) In schedule 4, in the new schedule 6 (specified import provisions) inserted by that schedule, in the table omit the entries for—

- (a) Article 2(1)(d) of Regulation 2019/2123(7),
