Advancing equality of opportunity	X			<p>As indicated above, there is a negative impact on women as the protection measures affected by this SSI relates to domestic abuse, which impacts disproportionately on women.</p> <p>There is evidence of increased incidence of domestic abuse during pregnancy (see, for example, 9 Victims of Crime - Scottish Government Equality Outcomes: Pregnancy and Maternity Evidence Review - gov.scot (www.gov.scot)).</p> <p>However, the negative impact of this SSI is limited as these protection measures were little used even before Brexit and in this SSI we have retained provisions (eg in relation to the recognition of incoming civil protection orders) where possible.</p>

¹ In respect of this protected characteristic, a body subject to the Public Sector Equality Duty (which includes Scottish Government) only needs to comply with the first need of the duty (to eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under the Equality Act 2010) and only in relation to work. This is because the parts of the Act covering services and public functions, premises, education etc. do not apply to that protected characteristic. Equality impact assessment within the Scottish Government does not require assessment against the protected characteristic of Marriage and Civil Partnership unless the policy or practice relates to work, for example HR policies and practices.

Describing how Equality Impact analysis has shaped the policy making process

This EQIA notes that domestic abuse has a disproportionate impact on women.

As indicated elsewhere in the EQIA, the Scottish Government regrets the departure of the UK from the EU. Following this departure, the EU measures can no longer operate as they previously did.

In practice, the impact is relatively low as the measures were not often used even before Brexit. Statistics held by the Scottish Government suggest that there have been eight European Protection Measures for civil: seven in 2017-18 and one in 2019-20. The statistics do not show whether these were incoming or outgoing orders.

There has been one European Protection order for criminal, which was registered in 2017-18 financial year. This was outgoing.

Given that the EU measures are designed to combat domestic abuse, the Scottish Government has considered if any aspects of them can continue. The Scottish Government considers that civil protection measures granted in EU member states under the EU regulation can continue to be recognise and enforced, under the same procedure as they are now, in Scotland. This SSI makes appropriate provision accordingly.

In addition, section 3J of the Victims and Witnesses (Scotland) Act 2014 provides that if a complaint is made to a Police Officer in Scotland about an offence or alleged offence in the EU and criminal proceedings for that offence or alleged offence cannot be raised in Scotland, the Chief Constable has to send details of the complaint to the relevant EU Member State. In order that Victims' rights remain protected, the wording in section 3J of the 2014 Act has been amended slightly to reflect the UK is no longer an EU Member State while ensuring the substance of the provision remains in place.

Monitoring and Review

The Scottish Government will continue to closely monitor the impact of leaving the EU on women.
