## PART IV

### SUPPLEMENTAL

#### 16 Certain expenses to be paid by Diocesan Board of Finance.

(1) The following expenses, that is to say—

- (a) any expenses incurred for the purpose of enabling a [<sup>F1</sup>diocesan committee of enquiry or] provincial tribunal to discharge its functions under this Measure;
- (b) any travelling or other personal expenses reasonably incurred by the members of such a [<sup>F1</sup>committee or] tribunal for the purpose of or in connection with the exercise of the functions of the [<sup>F1</sup>committee or] tribunal under this Measure;
- (c) any such expenses reasonably incurred by an incumbent in connection with an enquiry under this Measure which concerns him;
- (d) any such expenses reasonably incurred by an archdeacon under section 2 of this Measure;
- (e) any such expenses reasonably incurred by any person in connection with his attendance at a meeting of a [<sup>F1</sup>committee or] tribunal conducting an enquiry under this Measure, being a meeting which he was entitled, or invited by the [<sup>F1</sup>committee or] tribunal, [<sup>F1</sup>as the case may be,] to attend or which he attended as a witness; [<sup>F2</sup>and
- (f) any fee payable to the chairman of the tribunal which conducted the enquiry,][<sup>F1</sup>and
- (g) in the case of any other enquiry under this Measure, any fee payable to a barrister or solicitor appointed to advise and assist the committee which conducted the enquiry,]

shall be paid by the Diocesan Board of Finance.
