PERSONAL ALLOWANCES

(3)(3) Couple— (a) where both members are aged less than 18 and— (i) at least one of them is treated as responsible for a child; or (ii) had they not been members of a couple, each would have qualified for income support under regulation 4ZA or income-related employment and support allowance; or (iii) the claimant's partner satisfies the requirements of section 3(1)(f)(iii) of the Jobseekers Act 1995 (prescribed circumstances for persons aged 16 but less than 18); or	(3) (a) £84.95;
