**Introduction**

**Citation and commencement**

**1.** These Regulations may be cited as the State Aid (Agriculture and Fisheries) (Amendment) (EU Exit) Regulations 2019 and come into force on exit day.

## PART 2

### Amendments to Commission Regulation (EU) No 702/2014

#### **Amendments to the agricultural block exemption regulation**

2. Commission Regulation (EU) No 702/2014 declaring certain categories of aid in the agricultural and forestry sectors and in rural areas compatible with the internal market in application of Articles 107 and 108 of the Treaty on the Functioning of the European Union is amended in accordance with this Part.

#### **References to Articles of the Treaty and certain other EU instruments**

1. In this Regulation—
  - (a) a reference to Article 107(1) or 108(3) of the Treaty is a reference to that Article as it has effect in domestic law by virtue of section 4 of the European Union (Withdrawal) Act 2018 and regulation 3(1) and (2) of the state aid regulations;
  - (b) a reference to Article 107(2) or (3) of the Treaty is to be read in accordance with regulation 3(3)(b) of the state aid regulations;
  - (c) a reference to NUTS is a reference to the Nomenclature of Territorial Units for Statistics, as laid down in Regulation (EC) No 1059/2003 of the European Parliament and of the Council on the establishment of a common classification of territorial units for statistics (NUTS), as it had effect immediately before exit day.

### *Article 2B*

#### **Competent authority**

1. Subject to paragraphs 2 to 5, for the purposes of this Regulation the competent authority is the Secretary of State.

2. In relation to Scotland, in respect of areas within devolved competence, the competent authority is the Scottish Ministers.

In this paragraph, “devolved competence” is to be read in accordance with section 54 of the Scotland Act 1998.

3. In relation to Wales, in respect of functions conferred or imposed under section 56 of the Government of Wales Act 2006, the competent authority is the Welsh Ministers.

4. In relation to Northern Ireland, in respect of functions conferred under sections 22 or 23 of the Northern Ireland Act 1998, the competent authority is the Department of Agriculture, Environment and Rural Affairs.

5. Where prior to exit day the relevant function was delegated to another person or body, the competent authority is that person or body.

6. This Article is without prejudice to any power for the competent authority to delegate functions.”.

    - (bb) omit the words from “and regardless” to the end;
  - (ii) in the second sentence, for “Member State concerned” substitute “United Kingdom”;
- (e) in paragraphs 6, 7 and 8 omit “national” each place it occurs.

#### **Article 4 (Calculation of gross grant equivalent)**

**76.** In Article 4—

- (a) in paragraph 3(a), omit “under its domestic law”;
- (b) in paragraph 6—
  - (i) in point (a), omit “under its domestic law”;
  - (ii) in point (c), for “Commission notice” substitute “CMA statement of policy”;
  - (iii) in point (d)(i), for the words from “Commission under” to the end substitute “CMA under the state aid regulations and accepted by the CMA as being in line with the CMA statement of policy on State aid in the form of guarantees, or any successor statement of policy”.

#### **Article 5 (Cumulation)**

**77.** In Article 5—

- (a) in paragraphs 1 and 2, for “Member State” substitute “aid grantor”;
- (b) in paragraph 3, for “Commission” in both places it occurs substitute “CMA”.

#### **Article 6 (Monitoring)**

**78.** In Article 6—

- (a) in paragraph 1—
  - (i) for “a Member State” in the first place it occurs substitute “an aid grantor”;
  - (ii) omit “and publication reference in the Official Journal of the European Union”;
  - (iii) for “Member State” in each place it occurs substitute “aid grantor”;
  - (iv) omit “national”;
- (b) in paragraph 2—
  - (i) for “a Member State” substitute “the United Kingdom”;
  - (ii) for “that Member State” substitute “the United Kingdom”;
- (c) in paragraph 3—
  - (i) for “A Member State” substitute “An aid grantor”;
  - (ii) omit “national”.

#### **Article 7 (Transitional provisions)**

**79.** In Article 7—

- (a) in paragraph 1, omit the second sentence;
- (b) omit paragraph 4.

## **Article 8 (Entry into force and period of application)**

**80.**—(1) In Article 8, omit “It shall apply until 31 December 2020.”.

(2) After Article 8, omit the words from “This Regulation” to “Member States”.

#### **Amendment to Regulation (EU) No 1303/2013 of the European Parliament and of the Council**

**82.** After Article 2(13) of Regulation (EU) No 1303/2013 of the European Parliament and of the Council laying down common provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund and the European Maritime and Fisheries Fund insert—

“(13A) in this Regulation, a reference to Article 107(1) of the TFEU is a reference to that Article as it has effect in domestic law by virtue of section 4 of the European Union (Withdrawal) Act 2018 and regulation 3(1) and (2) of the State Aid (EU Exit) Regulations 2019;”.

#### **Amendments to Regulation (EU) No 1305/2013 of the European Parliament and of the Council**

**83.** In Article 81 of Regulation (EU) No 1305/2013 of the European Parliament and of the Council on support for rural development by the European Agricultural Fund for Rural Development (EAFRD)—

- (a) for “Articles 107, 108, and 109” in both places it occurs substitute “Articles 107(1), (2) and (3) and Article 108(3)”;
- (b) omit “by Member States” in both places it occurs;
- (c) in paragraph 2—
  - (i) omit “national”;
  - (ii) for “within the scope of Article 42 TFEU” substitute “for the production of and trade in agricultural products”.
- (d) after paragraph 2 insert—

“3. In this Article—

- (a) a reference to Article 107(1) or 108(3) of the TFEU is a reference to that Article as it has effect in domestic law by virtue of section 4 of the European Union (Withdrawal) Act 2018 and regulation 3(1) and (2) of the state aid regulations;
- (b) a reference to Article 107(2) or (3) of the TFEU is to be read in accordance with regulation 3(3)(b) of the state aid regulations;
- (c) “the state aid regulations” means the State Aid (EU Exit) Regulations 2019.”.



## **Amendments to Regulation (EU) No 1307/2013 of the European Parliament and of the Council**

**84.** In Article 13 of Regulation (EU) No 1307/2013 of the European Parliament and of the Council establishing rules for direct payments to farmers under support schemes within the framework of the common agricultural policy—

- (a) the existing text becomes paragraph 1;
- (b) in that paragraph—
  - (i) for “Articles 107, 108, and 109” substitute “Articles 107(1), (2) and (3) and Article 108(3)”;
  - (ii) omit “by Member States”;
- (c) after that paragraph insert—
  - “2. In this Article—
    - (a) a reference to Article 107(1) or 108(3) of the TFEU is a reference to that Article as it has effect in domestic law by virtue of section 4 of the European Union (Withdrawal) Act 2018 and regulation 3(1) and (2) of the state aid regulations;
    - (b) a reference to Article 107(2) or (3) of the TFEU is to be read in accordance with regulation 3(3)(b) of the state aid regulations;
    - (c) “the state aid regulations” means the State Aid (EU Exit) Regulations 2019.”.

## **Amendment to Commission Implementing Regulation (EU) No 808/2014**

**85.** In Annex 1 to Commission Implementing Regulation (EU) No 808/2014 laying down rules for the application of Regulation (EU) No 1305/2013 of the European Parliament and of the Council on support for rural development by the European Agricultural Fund for Rural Development (EAFRD), in point 13, after the second paragraph insert—

“In the second paragraph, the reference to Article 108(3) of the Treaty is a reference to that Article as it has effect in domestic law by virtue of section 4 of the European Union (Withdrawal) Act 2018 and regulation 3(1) and (2) of the State Aid (EU Exit) Regulations 2019.”.

### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations are made in exercise of the powers conferred by the European Union (Withdrawal) Act 2018 (c. 16) in order to address failures of retained EU law to operate effectively and other deficiencies (in particular under section 8(2)(a), (b), (c) and (g)) arising from the withdrawal of the United Kingdom from the European Union.

These Regulations make amendments to legislation in the field of agricultural and fisheries exemptions to the State aid rules under Articles 107 and 108 of the Treaty on the Functioning of the European Union. They correct direct deficiencies in EU legislation which exempts certain categories of subsidies from the general prohibitions and notification requirements for State aid. Part 2 amends the Agricultural Block Exemption Regulation, Part 3 amends the Agricultural De Minimis Regulation, Part 4 amends the Fisheries Block Exemption Regulation and Part 5 amends the Fisheries De Minimis Regulation. Part 6 corrects deficiencies in provisions relating to the application of the State aid regime to payments made under Regulation (EU) No 1303/2013 of the European Parliament and of the Council, Regulation (EU) No 1305/2013 of the European

Parliament and of the Council, Regulation (EU) No 1307/2013 of the European Parliament and of the Council, and Commission Implementing Regulation (EU) No 808/2014 respectively.

An impact assessment has not been produced for this instrument as no, or no significant, impact on the private or voluntary sector is foreseen.
