(9) <ul style="list-style-type: none"> (a) £27.44 in respect of each child or young person in respect of whom the conditions specified in paragraph 15A are satisfied; (b) £17.75 in respect of each person who is neither— <ul style="list-style-type: none"> (i) a child or young person; nor (ii) a member of a couple or a polygamous marriage, in respect of whom the conditions specified in paragraph 15A are satisfied; (c) £25.35 where the claimant is a member of a couple or a polygamous marriage and the conditions specified in paragraph 15A are satisfied in respect of a member of that couple or polygamous marriage.
