An Act to amend the references to the Highways Act 1980 in the South Yorkshire Act 1980. [27th July 1981]

WHEREAS under the Local Government Act 1972 the 1972 c. 70. South Yorkshire County Council are entrusted with the general management and administration of the county of South Yorkshire; and by the South Yorkshire Act 1980 the 1980 c. xxxvii. powers of the said county council, the district councils and the parish councils in the said county were extended and enlarged:

And whereas the South Yorkshire Act 1980 includes references to the Highways Act 1980 in a variety of contexts: 1980 c. 66.

And whereas certain of these references are incorrect and it is expedient that the same be corrected as by this Act provided:

And whereas it is expedient that the other provisions contained in this Act should be enacted:

And whereas the purposes of this Act cannot be effected without the authority of Parliament:

And whereas in relation to the promotion of the Bill for this Act the requirements of section 239 of the Local Government Act 1972 have been observed:

May it therefore please Your Majesty, that it may be enacted, and be it enacted, by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—
