

## CHAPTER xv.

An Act to confer further powers upon the Urban Electric Supply Company Limited with respect to their electric lighting undertakings in the urban districts of Weybridge and Walton-upon-Thames respectively and for other purposes.

WHEREAS under the Weybridge Electric Lighting Order 1900 confirmed by the Electric Lighting Orders Confirmation (No. 5) Act 1900 (hereinafter referred to as "the Weybridge Order") the Urban Electric Supply Company Limited (hereinafter referred to as "the Company") are authorised to supply electricity within the urban district of Weybridge and for the purposes of such supply to break up streets and roads within that urban district:

And whereas under the Walton-upon-Thames Electric Lighting Order 1904 confirmed by the Electric Lighting Orders Confirmation (No. 4) Act 1904 (hereinafter referred to as "the Walton Order") the Company are authorised to supply electricity within the urban district of Walton-upon-Thames and for the purposes of such supply to break up streets and roads within that urban district:

And whereas the Company have erected a generating station at Thames Street within the urban district of Weybridge from which electricity can conveniently be supplied to and within the urban district of Walton-upon-Thames but the Company are not empowered to break up streets and roads in the said urban district of Weybridge or to exercise any of the powers conferred upon them by or under the Weybridge Order for the purpose of supplying electricity within the said urban district of Walton-upon-Thames:

And whereas it is expedient that such disability be removed and the Company be empowered to supply electricity to and within the said urban district of Walton-upon-Thames from the said generating station or any other generating stations of the Company situate in the said urban district of Weybridge:

And whereas the purposes of this Act cannot be effected without the authority of Parliament:

May it therefore please Your Majesty that it may be enacted and be it enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows (that is to say):—

Short title.

1. This Act may be cited as the Weybridge and Walton-upon-.Thames Electric Supply Act 1905.

Interpretation.

- 2. In this Act unless the context otherwise requires—
  - "The Weybridge area" means the area of supply for the purposes of the Weybridge Order;
  - "The Walton area" means the area of supply for the purposes of the Walton Order;
  - "Electric line" has the meaning assigned to it by the Electric Lighting Act 1882;
  - "Energy" has the meaning assigned to it in the schedule to the Electric Lighting (Clauses) Act 1899.

Extension of powers of Weybridge Order.

3. The purposes for which the Company may exercise the powers conferred upon them by or under the Electric Lighting Acts 1882 and 1888 and the Weybridge Order and the Acts wholly or in part incorporated therewith respectively shall be deemed to include the purpose of from time to time connecting the generating station of the Company at Thames Street Weybridge or any other generating station of the Company in the Weybridge area with their electric lines in the Walton area and of supplying energy within the Walton area from any such station or stations and the Company may exercise such powers accordingly and may use any electric lines laid down by them in the Weybridge area under such powers as so extended for supplying energy in the Walton area and the laying down and construction of any electric lines or works which have prior to the passing of this Act been laid down or constructed by the Company within the Weybridge area for

such purpose as aforesaid is hereby ratified and confirmed and the A.D. 1905. Company may for such purpose maintain and use the same and exercise in that behalf any of the powers so conferred upon them.

4. The Company shall deliver to the Registrar of Joint Stock Copy of Act Companies a printed copy of this Act and he shall retain and to be regisregister the same and if such copy is not so delivered within three months from the passing of this Act the Company shall incur a penalty not exceeding two pounds for every day after the expiration of those three months during which the default continues and any director or manager of the Company who knowingly and wilfully authorises such default shall incur the like penalty Every penalty under this section shall be recoverable summarily.

There shall be paid to the registrar by the Company on such copy being registered the like fee as is for the time being payable under the Companies Act 1862 on registration of any document other than a memorandum of association.

5. All costs charges expenses and liabilities of and preliminary Costs of Act. to and incidental to the preparing for obtaining and passing of this Act or otherwise in relation thereto shall be borne and paid by the Company.
