CHAPTER x.

An Act to confirm a Provisional Order of the A.D. 1937.

Minister of Health relating to the Waltham

Joint Hospital District. [25th March 1937.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a provisional order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Short title. Health Provisional Order Confirmation (Waltham Joint Hospital District) Act 1937.

Waltham Order.

WALTHAM JOINT HOSPITAL DISTRICT.

Provisional order altering certain confirming Acts.

WHEREAS by virtue of the Waltham Joint Hospital Orders 1902 and 1907 (in this order called "the hospital orders") which were confirmed by Parliament as amended by the Essex (Chigwell and Witham) Review Order 1933 the Essex Review Order 1934 and the Waltham Joint Hospital Amendment Order 1935 the urban districts of Chigwell Chingford and Waltham Holy Cross constitute a united district called the Waltham Joint Hospital District of which the governing body is the Waltham Joint Hospital Board (in this order called "the joint board") consisting of three ex-officio members and eight elective members representing the councils of the said urban districts;

And whereas it is expedient that the urban districts of Epping and Wanstead and Woodford and the rural district of Epping (in this order called "the added districts") should be included in the united district aforesaid and that the hospital orders amended as aforesaid should be altered as in this order provided:

Now therefore the Minister of Health in pursuance of the powers given to him by section 297 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Date of operation.

1. This order shall come into operation on the first day of April nineteen hundred and thirty-seven:

Provided that sections 5 10 11 and 12 of this order shall come into operation on the date of the Act of Parliament confirming this order.

Extension of united district.

2. The Waltham Joint Hospital District shall be extended so as to include the added districts and subject to the provisions of this order references in the hospital orders to the constituent districts shall be deemed to include the added districts and references in those orders to the constituent authorities shall be deemed to include the councils of the added districts.

3. The joint board shall consist of six ex-officio members and eighteen elective members and the ex-officio members shall be the persons described in column 3 of the schedule to this order and the number of elective members to be elected by each of the constituent authorities shall be that set opposite the name of the constituent authority in column 4 of that schedule.

Waltham Order.

Ex-officio and elective members of joint board.

4. The hospital orders shall have effect as if the schedule Substitution to this order were substituted for the schedule to the Waltham Joint Hospital Order 1902.

of new schedule.

5. The urban district council of Waltham Holy Cross shall at a meeting to be held before the first day of April nineteen hundred and thirty-seven by a majority of votes or in the case of an equality of votes by the casting vote of the presiding Holy Cross chairman select from the members then representing the said urban district on the joint board two persons who shall continue to be members of the joint board until the day on which they would have retired from office if this order had not been made and the remaining member shall cease to hold office on the date aforesaid.

Reduction in representation of Waltham urban district council.

6. The provisions of article X of the Waltham Joint Hospital Election of Order 1902 shall apply to the first elections by the councils of the added districts of the elective members and to the election by the council of the urban district of Chingford of the two additional elective members to represent those councils on the joint board as if the election related to the filling of vacancies occurring at the commencement of this order.

additional elective members.

7. If on the application of the joint board or any constituent authority it appears to the Minister of Health that the population of any constituent district has so varied as to render the representation of the constituent authority therefor on the joint board inadequate or excessive he may by order to be published as he authorities. shall direct provide for such variation in the representation on the joint board of all or any of the constituent authorities as he may think fit.

Power of Minister to vary representation of constituent

8. Article XI of the Waltham Joint Hospital Order 1902 Meetings. shall have effect as if the words "six members shall constitute a quorum" were therein substituted for the words "three members shall constitute a quorum."

9.—(1) Paragraph (ii) of article IV of the order of 1907 Cost of shall cease to have effect and paragraph (b) of subdivision (1) of article XX of the order of 1902 shall have effect as originally enacted.

Adjustment of property liabilities &c. 23 & 24

10. The provisions of section 151 (Financial adjustments) of the Local Government Act 1933 shall have effect in relation to this order as if the alteration of the united district effected by this order were an alteration of areas or authorities made by Geo. 5. c. 51. an order under Part VI of that Act.

Inquiries and expenses.

11. The Minister of Health may hold any inquiry which he may deem necessary for the purposes of this order and section 290 of the Local Government Act 1933 shall apply as if the joint board were a local authority.

Short and collective titles.

12. This order may be cited as the Waltham Joint Hospital Order 1937 and the hospital orders the Waltham Joint Hospital Amendment Order 1935 and this order may be cited together as the Waltham Joint Hospital Orders 1902 to 1937.
