

CHAPTER i

An Act to confirm a Provisional Order under the Private Legislation Procedure (Scotland) Act 1936, relating to the Royal College of Physicians and Surgeons of Glasgow. [6th December 1962.]

HEREAS the Provisional Order set forth in the schedule hereunto annexed has been made by the Secretary of State under the provisions of the Private Legislation Procedure (Scotland) Act 1936, and it is requisite that the said Order should be confirmed by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

- 1. The Provisional Order contained in the schedule hereunto Confirmation annexed is hereby confirmed.

- 2. This Act may be cited as the Royal College of Physicians Short title, and Surgeons of Glasgow Order Confirmation Act 1962.

SCHEDULE

ROYAL COLLEGE OF PHYSICIANS AND SURGEONS OF GLASGOW

Provisional Order to change the name of The Royal Faculty of Physicians and Surgeons of Glasgow to The Royal College of Physicians and Surgeons of Glasgow; and to enact provisions consequent thereon and as to the administration of the said College; and for other purposes.

Whereas the Surgeons and Professors of Medicine in Glasgow (now known as "The Royal Faculty of Physicians and Surgeons of Glasgow" and hereinafter referred to as "the Faculty") were incorporated by Royal Charter granted by His Majesty King James the Sixth of Scotland, under the Privy Seal of that Kingdom, on the twenty-ninth day of November, fifteen hundred and ninety-nine, and the said Charter was ratified by an Act of the Scottish Parliament passed upon the eleventh day of September, sixteen hundred and seventy-two:

And whereas by the Act 13 & 14 Vict. c. xx being an "Act for better regulating the Privileges of the Faculty of Physicians and Surgeons of Glasgow, and amending their Charter of Incorporation", certain provisions were made for the said purposes and it was also provided that nothing therein contained should prevent the Faculty from altering the rules and regulations theretofore made by the Faculty under the powers contained in the said Charter or from making such new rules and regulations as might be necessary for carrying into effect the purposes of the said Charter and of the said Act:

And whereas in the year nineteen hundred and nine His late Majesty King Edward the Seventh graciously consented to the Faculty being known as "The Royal Faculty of Physicians and Surgeons of Glasgow":

And whereas in view of the fact that the continued use of the name "Faculty" tends to lead to confusion and misunderstanding it is expedient that the name of the Faculty should be changed as provided in this Order and that consequent on such change the provisions contained in this Order should be enacted:

And whereas Her Majesty has been graciously pleased to assent to the Faculty, in the event of this Order being confirmed by Parliament, continuing to use the title "Royal" and being known accordingly as "The Royal College of Physicians and Surgeons of Glasgow":

And whereas the purposes aforesaid cannot be effected without an order of the Secretary of State confirmed by Parliament under the provisions of the Private Legislation Procedure (Scotland) Act, 1936:

Now therefore in pursuance of the powers contained in the last-mentioned Act the Secretary of State orders as follows:—

1. This Order may be cited as the Royal College of Physicians and Surgeons of Glasgow Order, 1962, and this Order and the Act 13 & 14

Short title and citation.

Vict. c. xx (so far as relating to the Faculty and to the College) may be cited together as the Royal College of Physicians and Surgeons of Glasgow Acts, 1850 and 1962.

2. In this Order unless there be something in the context repugnant Interpretation to such construction the following words and expressions shall have the meanings hereinafter respectively assigned to them, that is to say:—

"Act of 1672" means the Act passed by the Scottish Parliament on the eleventh day of September, sixteen hundred and seventy-two;

"Act of 1850" means the Act 13 & 14 Vict. c. xx;

- "byelaws" means the byelaws of the College for the time being in force;
- "Charter" means the Royal Charter granted by His Majesty King James the Sixth of Scotland on the twenty-ninth day of November fifteen hundred and ninety-nine;

"College" means the Royal College of Physicians and Surgeons of Glasgow;

"commencement of this Order" means the date of the passing of the Act confirming this Order;

"council" means the council of the College appointed and acting in terms of the regulations;

"existing regulations" means the regulations made by the Faculty under the powers of the Charter and the Act of 1850 and in force immediately before the commencement of this Order;

"Faculty" means the Royal Faculty of Physicians and Surgeons of Glasgow;

"fellow" means a person who has become, pursuant to the provisions of this Order, or who has been admitted a fellow of the College;

"licentiate" means a person who has been granted after examination the licence of the Faculty or of the College;

"licentiate in dental surgery" means a person who has been granted after examination the licence in dental surgery of the Faculty or of the College;

"member" means a person who has become, pursuant to the provisions of this Order, or who has been admitted a member of the College;

"president," "visitor," "honorary secretary," "honorary treasurer," "honorary librarian," "clerk" and "registrar" mean the persons for the time being holding the respective offices of president, visitor, honorary secretary, honorary treasurer, honorary librarian, clerk and registrar of the College;

"qua physician" where used in relation to a fellow or member of the Faculty or of the College refers to a person who (a) was elected as a fellow of the Faculty before the commencement of this Order and became a fellow or member of the College by virtue of the provisions of this Order, or (b) was elected as a fellow or member in accordance with the provisions of this Order and the regulations, in either case by reason of his having qualified in medicine;

"qua surgeon" where used in relation to a fellow of the Faculty or of the College refers to a person who (a) was elected as a

fellow of the Faculty before the commencement of this Order and became a fellow of the College by virtue of the provisions of this Order or (b) was elected as a fellow of the College in accordance with the provisions of this Order and the regulations, in either case by reason of his having qualified in surgery;

"regulations" means the regulations of the College set out in the First Schedule to this Order as the same may from time to

time be amended.

Change of name of the Faculty.

- 3.—(1) After the commencement of this Order the name of the Faculty shall be changed to and the Faculty shall be known as "The Royal College of Physicians and Surgeons of Glasgow" and all the powers, rights and privileges granted to or vested in and the duties and obligations laid or imposed upon the Surgeons and Professors of Medicine in Glasgow or the Faculty by the Charter, the Act of 1672 and the Act of 1850 or any other enactment shall be deemed to be powers, rights and privileges granted to and duties and obligations laid or imposed upon the College, and any references to the Faculty and to the fellows, members, licentiates and licentiates in dental surgery of the Faculty in the Act of 1850 or in any other enactment or in any rules, regulations or byelaws made thereunder shall be deemed to be references to the College or to the fellows, members, licentiates or licentiates in dental surgery of the College as the case may be and without prejudice to the foregoing generality all references in the Medical Act, 1956, to the Faculty shall be deemed to be references to the College and the Third Schedule to the said Act shall have effect as if for the word "Fellowship" in reference to the fellowship of the Faculty in the Third Column thereof there were substituted the words "Fellowship, membership."
- (2) Any reference to the Faculty in any deed, contract or document (including any will, codicil or other testamentary writing or bequest) whether executed before or after the commencement of this Order shall be deemed to be a reference to the College, and in particular and without prejudice to the foregoing generality the change of name shall not affect any rights or obligations of the Faculty nor render defective any legal proceedings by or against the Faculty and any legal proceedings that might have been continued or commenced by or against the Faculty may be continued or commenced by or against the College; and further any bequest which would take effect in favour of the Faculty under the will or other mortis causa writing of any person whether dying before or after the commencement of this Order and which may not have then taken effect shall be deemed to have been made to the College and shall take effect in favour of the College as fully and effectually as it would have taken effect in favour of the Faculty had this Order not been confirmed.
- (3) Nothing in this section shall affect the rights of any person entitled immediately before the commencement of this Order to have his qualification as a licentiate of the Faculty entered in the registers kept in pursuance of the Medical Act, 1956, or as a licentiate in dental surgery of the Faculty entered in the register kept in pursuance of the Dentists Act, 1957, but whose qualification as a licentiate, or as a licentiate in dental surgery as the case may be, was not entered in the appropriate registers at the commencement of this Order or confer on

any such person any such rights not possessed by him immediately before the commencement of this Order.

4. Except as provided by section 6 (Temporary continuance of Regulations certain existing regulations) of this Order, the existing regulations are hereby revoked and the regulations shall be the regulations of the College and shall continue in force unless altered, amended or extended or revoked by the College under the powers vested in them.

5. Notwithstanding the revocation of the existing regulations—

(1) the president, the visitor, the honorary secretary, the honorary treasurer and the honorary librarian of the Faculty holding office immediately before the commencement of this Order shall continue in office and shall exercise all the powers and duties conferred respectively on the president, the visitor, the honorary secretary, the honorary treasurer and the honorary librarian of the College by this Order and by the regulations until the election of office-bearers next following the commencement of this Order;

Saving for existing office-bearers.

- the councillors of the Faculty (other than such office-bearers as aforesaid and members of the council elected by the licentiates of the Faculty and the licentiates in dental surgery of the Faculty) holding office immediately before the commencement of this Order shall continue in office as councillors of the College as if they had been elected in accordance with the provisions of this Order and of the regulations until such time as they would have gone out of office if the existing regulations had not been revoked;
- the members of the council of the Faculty elected by the licentiates of the Faculty and the licentiates in dental surgery of the Faculty respectively holding office immediately before the commencement of this Order shall continue in office as councillors of the College as if they had been elected in accordance with the provisions of this Order and of the regulations until the respective dates on which meetings of licentiates and licentiates in dental surgery are first held after the commencement of this Order in accordance with the provisions of this Order and of the regulations to elect fellows or members to the office of councillor.

6. Notwithstanding anything in section 4 (Regulations) of this Temporary Order the existing regulations with respect to the following matters, certain existing namely:—meetings of the Faculty, election procedure, examination regulations. procedure, admission procedure and ceremony, the granting of licences in medicine, surgery and midwifery and in dental surgery and of diplomas, the finance of the Faculty, the library of the Faculty, the duties of the honorary secretary and other officers of the Faculty, committees of the Faculty and of the council and professional conduct, shall (except in so far as dealt with in the regulations), subject to the substitution for the references therein to the Faculty of references to the College and with all other necessary modifications and adaptations, continue in force until byelaws with respect to such matters are made by the College under the powers vested in them.

7. Subject to the provisions of this Order—

(1) (a) all persons who immediately before the commencement physician to be of this Order were fellows of the Faculty qua physician and fellows or

Fellows of the Faculty qua members of the College qua physician,

whose names are set out in the Second Schedule to this Order shall be fellows of the College qua physician; and

- (b) all other persons who were fellows of the Faculty qua physician immediately before the commencement of this Order and all persons who after the commencement of this Order are, pursuant to the regulations, elected as members of the College by reason of their qualification in medicine shall be members of the College qua physician unless elected as fellows of the College qua physician pursuant to the regulations;
- (2) all persons who are fellows of the College qua physician shall be entitled to use after their names the letters "F.R.C.P. (Glasg.)" and all members of the College qua physician shall be entitled to use after their names the letters "M.R.C.P. (Glasg.)".

- 8.—(1) Subject to the provisions of this Order all persons who immediately before the commencement of this Order were fellows of the Faculty qua surgeon shall be fellows of the College qua surgeon and all persons who after the commencement of this Order are, pursuant to the regulations, elected as fellows of the College by reason of their qualification in surgery shall be fellows of the College qua surgeon.
- (2) All persons who are fellows of the College qua surgeon shall be entitled to use after their names the letters "F.R.C.S. (Glasg.)".
- 9.—(1) Every person who immediately before the commencement of this Order was a fellow of the Faculty and who was entitled to have his qualification as such entered in the registers kept in pursuance of the Medical Act, 1956, shall be entitled to have his qualification entered in the said registers (a) as a fellow of the College in the case of a person who was a fellow of the Faculty qua surgeon or whose name is set out in the Second Schedule to this Order, or (b) as a member of the College in the case of a person who was a fellow of the Faculty qua physician immediately before the commencement of this Order and who pursuant to the provisions of this Order is a member of the College, and the registrar of the General Medical Council and the registrars of the branch councils referred to in the Medical Act, 1956, are hereby respectively authorised to register such qualifications accordingly.
- (2) Nothing in this section shall affect the right of any fellow of the Faculty, who before the commencement of this Order was entitled to have his qualification as such entered in the registers kept in pursuance of the Medical Act, 1956, but whose qualification was not so entered, to have his qualification as a fellow of Faculty entered in the said registers.

Honorary fellows.

10. Honorary fellows elected in terms of the regulations shall be entitled to use after their names the letters "Hon. F.R.C.P.S. (Glasg.)".

Management and administration

11. The management and administration of the College shall be under the control and in the hands of the council.

Costs of Order.

12. All costs, charges and expenses of and incidental to the preparing for, obtaining and confirming this Order and otherwise in relation thereto shall be paid by the College.

CHAPTER I

THE COLLEGE AND THE COMMON SEAL

1. The College shall consist of the fellows and members.

The College.

- 2. The business of the College shall be under the control of the Business of fellows and members acting through a council constituted in accordance College to be with the regulations hereinafter set forth. The College shall make under control such byelaws as it may see fit for the carrying out of these regulations of council. and for the administration of the College and shall have power to amend or add to the regulations and the said byelaws.
- 3. The College shall have power to grant such licences and diplomas College to grant licences as it shall from time to time ordain.

and diplomas. The College shall also have power to co-operate with the other colleges of physicians or of surgeons in Scotland, England and Ireland in conducting examinations for such conjoint diplomas as from time

4. The College shall have a common seal which shall be in the The common custody of the registrar and shall be by him affixed to such documents seal. as the College, the president or the council may instruct, accompanied by the signatures of two of the office-bearers specified in chapter IV hereof.

CHAPTER II

Admission to the College

1. The fellowship or membership of the College may be granted Qualifications to those who, possessing a qualification registrable in the British for the medical register or being graduates in medicine and surgery of those fellowship universities or medical colleges recognised by the council for the of College. purpose, comply with the requirements of the regulations hereinafter set forth.

2. The admission of members and fellows shall be by examination Admission of and subsequent election as a member qua physician or as a fellow qua members qua surgeon. Candidates who qualify for admission in medicine shall be fellows qua eligible for election as members qua physician. Candidates who surgeon. qualify for admission in the subject of surgery shall be eligible for election as fellows qua surgeon.

3. Before admission to the examination for the membership qua Examination physician a candidate shall produce evidence satisfactory to the for the council—

membership qua physician.

- (1) of personal character and professional status;
- (2) of having held a qualification or degree as specified in paragraph 1 of this chapter for two or more years. (If no pre-registration clinical post has been held, the minimum period of time shall be three years);
- (3) of having spent one of those years in full-time clinical work in a hospital approved by the council, and one other year in medical work approved by the council.

1st Sch. :

The examination shall consist of such written, clinical and oral examinations as the council may from time to time determine.

Examination for the fellowship qua surgeon.

- 4. Candidates for the fellowship qua surgeon must pass a primary examination and a final examination:—
 - (a) Before admission to the primary examination a candidate (1) shall be approved by the council, having produced evidence satisfactory to the council of holding a qualification or degree as specified in paragraph 1 of this chapter; and (2) shall declare that he has not, within the three months prior to the date of the examination for which he intends to appear, presented himself for the primary fellowship examination of the College or of any of the colleges mentioned in subparagraph (b) hereof in the subjects of this examination.

The primary examination shall consist of a written examination and an oral examination in each of the following subjects (a) anatomy, (b) physiology and (c) pathology and bacteriology.

- (b) A candidate shall be granted exemption from the primary examination on production of evidence that he has, after May 1951, passed the primary fellowship examination of the Royal College of Surgeons of Edinburgh, or of the Royal College of Surgeons of England, or of the Royal College of Surgeons in Ireland, or of the Royal Australasian College of Surgeons, or of the College of Physicians, Surgeons and Gynaecologists of South Africa or such other examinations as the Council shall from time to time approve; or that, having obtained a higher Australasian degree with a suitable primary examination, he has been exempted from the primary examination of the Royal Australasian College of Surgeons.
- (c) Before admission to the final examination a candidate shall produce evidence satisfactory to the council (1) of personal character and professional status; (2) of having held a qualification or degree as specified in paragraph 1 of this chapter for two or more years. (If no pre-registration clinical post has been held, the minimum period of time required shall be three years); (3) of having spent one of these years in full-time clinical work in a hospital approved for this purpose by the council; (4) of having spent one other year in the study of surgery or allied sciences; and (5) either of having passed the primary examination or of having been granted exemption therefrom in terms of sub-paragraph (b) of this paragraph:

The final examination shall consist of such written, clinical and oral examinations as the council may from time to time determine.

Examination for the fellowship qua surgeon (special subjects).

5. A Candidate may submit himself for examination in one of the following special subjects in the final examination; obstetrics and gynaecology; ophthalmology; oto-rhino-laryngology. Such a candidate shall produce evidence satisfactory to the council of having fulfilled the conditions required for admission to the final examination

as defined in sub-paragraph (c) of the preceding paragraph except that for item (3) thereof there shall be substituted "of having spent one of these years in full-time clinical work in a hospital or department devoted to the specialty and approved for this purpose by the council."

IST SCH. --cont.

The final examination for such a candidate shall consist of such written, oral and clinical examinations in the special subject and in such medicine and surgery as is related to the special subject, all as the council may from time to time determine.

6. The council shall have power to exempt from the whole or exemption from any part of the examinations hereinbefore mentioned any candidate examinations whose published work or whose attainments shall in its opinion justify for admission this concession.

Special to membership qua physician or fellowship qua surgeon.

7. The results of the examinations of candidates for membership Procedure for qua physician and the final examinations for the fellowship qua election of surgeon shall be considered by boards of examiners appointed by members qua the council, who shall report thereon to the council. Thereafter the fellows qua council shall report the names of the successful candidates to the surgeon. next meeting of the College.

Election shall be by ballot of the College and two-thirds of the votes cast must be in favour of admission. The voting shall take place on the same day as that on which the report of the council is submitted to the College.

8. (a) The fellowship qua physician of the College may be Admission to the granted, without further examination, to such members qua physician fellowship qua of the college as may be elected by the council on the recommendation physician. of a fellowship committee, appointed partly by the College and partly by the council. The council shall on recommendation aforesaid also have power to elect to the fellowship qua physician any senior member of the medical profession whose published work and attainments are in its opinion of such distinction as to justify such election, and candidates for such election to the fellowship qua physician shall be nominated in the usual manner and before admission shall pay the appropriate members' and fellows' election fees.

- (b) All fellows qua physician shall have the right to nominate members for the fellowship qua physician and shall receive, not more than two months nor less than one month before each statutory meeting of the said fellowship committee, a notice inviting nominations.
- (c) The council shall have power to elect as fellows qua physician only persons recommended by the fellowship committee.
- 9. Following election as a fellow qua physician, fellow qua surgeon Ceremony of or member qua physician, the successful candidate may be admitted admission of at any subsequent meeting of the College or of the council.

fellows and members.

10. The College may institute an annual or other subscription upon Powers to levy the fellows and members and such subscription may vary according to subscriptions. residence or other circumstances of each fellow or member, and the College may alter or discontinue such subscription.

CHAPTER III

THE HONORARY FELLOWSHIP

Honorary fellows may be elected by the College.

1. The College may confer the rank of honorary fellow on any person distinguished in the profession or, in special circumstances, on any distinguished person. A proposal to admit to the honorary fellowship must be signed by six fellows or members and lie upon the table for two months and thereafter the election shall be by ballot of the College and two-thirds of the votes cast must be in favour of election.

Signed acceptance of honorary fellowship to be inserted in register of fellows.

2. The signed acceptance of the honorary fellowship shall be inserted in the register of fellows in such manner as the council may determine. A diploma shall in due course be sent to the honorary fellow.

Honorary fellows not to have vote, etc.

3. Honorary fellows shall have no right to vote at meetings of the College or in any way to participate in its management provided that the election of an ordinary fellow as an honorary fellow shall in no way debar him from the rights and privileges of an ordinary fellow.

CHAPTER IV

OFFICE-BEARERS, COUNCIL AND REPRESENTATIVES

Office-bearers of the College.

- 1. The council of the College shall comprise—
 - (a) The following office-bearers, namely, a president, a visitor, an honorary secretary, an honorary treasurer and an honorary librarian;
 - (b) eight councillors of whom six shall be elected by the fellows and members who are resident in the British Isles, one by the licentiates and one by the licentiates in dental surgery as hereinafter provided; and
 - (c) the representative of the College on the General Medical Council.

At least one of the six councillors elected by the said fellows and members shall be a fellow or member whose consulting room, hospital or other place at which or from which he conducts the principal part of his practice is situated more than twenty miles by road from the general post office, Glasgow.

Certain officebearers to be elected annually. 2. The president, the visitor, the honorary secretary, the honorary treasurer and the honorary librarian shall be elected annually. The president and the visitor shall, at the annual meeting of the College, each nominate an inspector of drugs.

Election of councillors.

3. Each year before the annual meeting of the College there shall be elected one or more councillors who shall serve for four years and who, thereafter, shall not be eligible for re-election for a period of one year.

4. The election to the offices of president, visitor, honorary secretary, honorary treasurer, honorary librarian and councillors, other than —cont. councillors elected by the licentiates and by the licentiates in dental effice-bearers surgery, shall, except in the case of election to fill a casual vacancy other than or a vacancy to be filled in terms of paragraph 10 hereof, be by councillors postal vote of the fellows and members who are resident in the British elected by Isles.

1st Sch. licentiates to be by postal vote.

5. The member of the General Medical Council to be chosen by the Election of College in accordance with the provisions of the Medical Act, 1956, representative shall be a fellow or member of the College and shall be elected by the College.

to the General Medical Council.

- 6. The member of the General Dental Council to be nominated by the Election of College in accordance with the provisions of the Dentists Act, 1957, representative shall be a fellow or member of the College and shall be elected by the Dental Council. College for a term not exceeding five years.
- 7. In the event of a member of the council elected by the fellows As to members and members resident in the British Isles being appointed to any of council office in respect of which he is ex-officio a member of the council members and thereby causing a vacancy in the council, the College shall elect ex-officio, another fellow or member to be a member of the council. The election in such case shall not be by postal ballot.

11. All representatives of the College on public bodies or trusts Election of shall be elected by the College.

12. Candidates nominated for any office shall not canvass fellows Canvassing by or members in promotion of their candidature.

CHAPTER V

MEETINGS OF COLLEGE

Meetings.

1. Meetings of the fellows and members (hereinafter referred to as "meetings of the College") shall be called and the procedure to be followed thereat shall be in accordance with the provisions of the byelaws.

Quorum of the College.

2. Twelve fellows or members, duly convened, shall constitute a quorum and shall have power to transact all business regularly brought forward at any meeting of the College. In the absence of both the president and the visitor at any meeting of the College the fellows and members present shall appoint a chairman who, at that meeting, shall be vested with the powers of the president.

Business of the College not to be published without consent.

3. The business and financial affairs of the College, either in relation to itself or to other bodies associated with it, shall not be communicated to the newspapers or journals, or published in any form, unless by the authority or with the consent of the College or the council.

CHAPTER VI

Powers and duties of office-bearers and council

Office-Bearers

Powers of president.

1. The president shall have power to convene all meetings of the College, of the licentiates, of the licentiates in dental surgery, of the council and of the examining boards of the College and when present he shall preside. Besides having a deliberative vote he shall in all cases of equality have a casting vote. He shall be ex-officio a member of all committees appointed by the College or the council. In all important matters he shall consult the council and follow its advice unless or until the College shall otherwise instruct.

Powers of visitor.

2. The visitor shall exercise all the powers and privileges of the president, when from any cause the president is absent or unable to discharge the duties of his office.

Powers and duties of honorary secretary, honorary treasurer and honorary librarian.

3. The honorary secretary, the honorary treasurer and the honorary librarian shall have such powers and duties as may be prescribed by the College.

Powers and duties of council.

The Council

4. The council shall be a consultative and executive body and shall consider matters remitted to it by the College, watch over the interests of the College, and, when considered necessary, make recommendations in respect of the business of the College, carry into effect all resolutions of the College involving executive action, and in the intervals between meetings of the College act in all matters requiring immediate attention. The council shall have charge of and be responsible to the College for the College buildings and all their contents.

The council shall meet at such times as the president, or two-thirds of the members thereof, may deem fit. Five of its members shall be a quorum. In the absence of both the President and the visitor at any meeting the members present shall appoint a chairman.

CHAPTER VII COMMITTEES

1. It shall be competent to the College or to the council to appoint Appointment such standing or ad hoc committees as they may see fit. The powers of committees. and duties of all standing committees shall be as stated in the byelaws.

CHAPTER VIII

RETIRING ALLOWANCES

1. The College may grant such honoraria or retiring or super-Retiring annuation allowances to employees leaving its employment or rendering allowances, etc. special services as it shall from time to time see fit and may attach such terms and conditions thereto as it shall from time to time consider expedient and may make such provision therefor by insurance or by instituting a superannuation or reserve fund or otherwise as it shall from time to time see fit.
