# **CHAPTER vi**

An Act to confirm a Scheme of the Charity Commissioners and the Minister of Education for the application or management of the United Charities of Nathaniel Waterhouse, and other Charities, in the County Borough of Halifax. [2nd June 1960.]

HEREAS the Charity Commissioners in their Report to Her Majesty of their proceedings during the year one thousand nine hundred and fifty-nine reported that they had approved and certified jointly with the Minister of Education a Scheme for the application or management of the following Charities in the County Borough of Halifax:—

- 1. The United Charities of Nathaniel Waterhouse;
- 2. The Charity known as the Afternoon Lecturer's Fund;
- 3. The Waterhouse Educational Foundation.

And whereas it is expedient that the Scheme as the same is fully set out and defined in the Schedule to this Act should be confirmed:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same as follows:—

1. The said Scheme is hereby confirmed Provided always Confirmation that nothing in this Act or in the said Scheme shall be held to of Scheme. interfere with the ordinary jurisdiction over endowed charities now exercisable by the High Court of Justice, the Charity Commissioners and the Minister of Education.

United Charities of Nathaniel 8 & 9 Eliz. 2 Waterhouse, and other Charities (Halifax) Scheme Confirmation Act, 1960

Short title.

2. This Act may be cited as the United Charities of Nathaniel Waterhouse, and other Charities (Halifax) Scheme Confirmation Act, 1960.

# SCHEDULE

Scheme for the application or management of the following Charities and Foundation, in the County Borough of Halifax:—

- 1. The United Charities of Nathaniel Waterhouse, regulated by an Act of Parliament (11 and 12 Vict. c. 10) as affected by an Order made by the Charity Commissioners on the 29th April 1904 under the Board of Education Act, 1899, 62 & 63 Vict. s. 2 (2);
- 2. The Charity known as the Afternoon Lecturer's Fund;
- 3. The Waterhouse Educational Foundation, constituted by the above-mentioned Order of the Charity Commissioners of the 29th April 1904.

#### ADMINISTRATION

- 1.—(1) The above-mentioned Charities and Foundation and the endowments thereof specified in the schedule hereto and all other the endowments (if any) of the Charities and Foundation shall be administered and managed so as to give effect to the provisions of this Scheme.
- (2) The United Charities of Nathaniel Waterhouse and the endowments thereof and the Waterhouse Educational Foundation and the endowments thereof shall be administered and managed together as one Charity under the title of the United Charities of Nathaniel Waterhouse (hereinafter referred to as the United Charities).
- (3) The United Charities and the Charity known as the Afternoon Lecturer's Fund shall be administered and managed subject to and in conformity with the provisions of this Scheme under the title of the Nathaniel Waterhouse Charities (hereinafter referred to as the Charities) by the body of Governors hereinafter constituted.

#### DISSOLUTION OF CORPORATION

2. The corporation of The Governors and Trustees of the United Charities of Nathaniel Waterhouse constituted by the abovementioned Act 11 and 12 Vict. c. 10 is hereby dissolved.

#### AREA OF BENEFIT

3. In this Scheme the expression "the area of benefit" shall mean the County Borough of Halifax as constituted from time to time together with such parts of the area of the Ancient Parish of Halifax as lie outside the said County Borough.

#### VESTING

4. The land specified in the schedule hereto is hereby vested in The Official Trustee of Charity Lands for all the estate and interest therein belonging to or held in trust for the United Charities.

# INVESTMENT OF CASH

5. Sums of cash at any time belonging to the Charities and not needed for immediate working purposes shall be invested in the name of The Official Trustees of Charitable Funds unless the Charity Commissioners otherwise direct.

#### **GOVERNORS**

6. The body of Governors shall consist when complete of sixteen competent persons being—

One Ex-Officio Governor; and Fifteen Co-optative Governors.

# **Ex-officio Governor**

7. The Ex-Officio Governor shall be—
The Vicar for the time being of Halifax.

# CO-OPTATIVE GOVERNORS

8. The Co-optative Governors shall be persons residing or carrying on business in or near the area of benefit.

# FIRST CO-OPTATIVE GOVERNORS

9. The following persons shall be the first Co-optative Governors and subject to the provisions hereinafter contained for determination of governorship shall be entitled to hold office for the following periods respectively:—

Geoffrey Mitchell Butler, of Middle Pasture, Heath Lane, Halifax, Machine Tool Maker,

Aubrey Gordon Morrison Hall, of Willow Bank, Knowle Top Road, Lightcliffe, near Halifax, Manufacturer, and

Edward Anthony Spencer, of the Cottage, Trimmingham Lane, Halifax, Manufacturer,

all for six years from the date of this Scheme;

Rex Brown, of 27 The Crescent, Hipperholme, Company Director,

George Brian Collinson, of Clay House Farm, Ripponden, Solicitor, and

Eric Town, of 6 Heath Gardens, Machine Tool Maker, all in Halifax,

all for five years from the date of this Scheme;

Anthony Bateman Lewin, of The Rockery, Albert Promenade, Halifax, Electrical Engineer, and

Walter Farrar, of Heslington, Bridle Style, Shelf, Manufacturer, and

Dennis Outram Osborn, of Willow Lodge, Sowerby Bridge, Yarn Manufacturer, both in the West Riding of the County of York,

all for four years from the date of this Scheme;

Harold Ingham Bearder, O.B.E., of Warley Cottage, Warley, Solicitor, and

Robert Parker Stafford, of 12 Trinity Place, Company Director both in Halifax, and

Ronald Hawley Murgatroyd, of Broadfold, Luddenden, in the West Riding of the County of York, all for three years from the date of this Scheme;

Thomas Ashworth Hoyle, of Holdsworth House, Holmsield, Worsted, Spinner,

Bernard Lucas Sutcliffe, of 9 Princes Gate, Insurance Broker, and

The Reverend Canon George Watkinson, of Woodfield, Hipperholme, Clerk in Holy Orders, all in Halifax, all for two years from the date of this Scheme.

# FUTURE CO-OPTATIVE GOVERNORS

10. Every future Co-optative Governor shall be appointed for a term of five years by a resolution of the Governors passed at a special meeting.

# DECLARATION BY GOVERNORS

11. No person shall be entitled to act as a Governor whether on a first or on any subsequent entry into office until after signing in the minute book of the Governors a declaration of acceptance and of willingness to act in the trusts of this Scheme.

# DETERMINATION OF GOVERNORSHIP

12. Any Co-optative Governor who ceases to be qualified as aforesaid or who is absent from all meetings of the Governors during a period of one year and any Governor who is adjudged bankrupt or makes a composition or arrangement with his creditors or who is incapacitated from acting or who communicates in writing to the Governors a wish to resign shall cease thereupon to be a Governor.

#### VACANCIES

13. Upon the occurrence of a vacancy the Governors shall cause a note thereof to be entered in their minute book at their next meeting. Any competent Governor may be re-appointed. No vacancy in the office of Co-optative Governor shall be filled until after the lapse of one calendar month from its occurrence.

#### **MEETINGS**

14. The Governors shall hold at least two ordinary meetings in each year. A special meeting may be summoned at any time by the President Governor hereinafter mentioned or by any two Governors. Four days' notice of any meeting shall be given to all the Governors including notice of the matters to be discussed. A special meeting may be summoned to take place immediately before or after an ordinary meeting.

# FIRST MEETING

15. The first meeting of the Governors shall be summoned by Frederick Nunns Dickie, of 2 Harrison Road, Halifax, or if he fails for three calendar months after the date of this Scheme to summon a meeting by any two of the Governors.

# CHAIRMAN AND VICE-CHAIRMAN

16. The Governors at their first ordinary meeting in each year shall elect one of their number to be chairman of their meetings until the commencement of the first ordinary meeting in the second year following his appointment. The Governors if they think fit may also elect one of their number to be vice-chairman of their meetings for the same period. The chairman and vice-chairman shall always be eligible for re-election. If at any meeting neither the chairman nor the vice-chairman is present within ten minutes after the time appointed for holding the same or there is no chairman or vice-chairman the Governors present shall choose one of their number to be chairman of the meeting. The chairman shall be called the President Governor.

# Quorum

17. There shall be a quorum when five Governors are present at a meeting.

# VOTING

18. Every matter shall be determined by the majority of votes of the Governors present and voting on the question. In case of equality of votes the chairman of the meeting shall have a casting vote whether he has or has not voted previously on the same question but no Governor in any other circumstances shall give more than one vote.

#### MINUTES AND ACCOUNTS

19. A minute book and books of account shall be provided and kept by the Governors. All proper accounts in relation to the Charities shall be made out in each year and certified in such manner as the Charity Commissioners require and copies thereof shall be transmitted to the said Commissioners in compliance with the provisions of the Charitable Trusts Acts.

#### GENERAL POWER TO MAKE REGULATIONS

20. Within the limits prescribed by this Scheme the Governors shall have full power from time to time to make regulations for the management of the Charities and for the conduct of their business including the summoning of meetings, the deposit of money at a proper bank and the custody of documents.

#### CLERK

21. The Governors may appoint some fit person to be their clerk and to hold office during their pleasure and may pay to him (not being a Governor) such reasonable salary as they think fit.

# MANAGEMENT AND LETTING OF LANDS

22. The Governors shall let and otherwise manage all the lands belonging to the United Charities not required to be retained or occupied for the purposes thereof. Except with the approval of the Charity Commissioners the Governors shall give public notice of the intention to let any land in such manner as they consider most effectual for ensuring fully publicity. The Governors shall not create any tenancy in reversion after more than three years of any existing term or for more than 21 years certain or for less than the best rent obtainable without the sanction of the Charity Commissioners or a competent court.

# LEASES

23. The Governors shall provide that on the grant by them of any lease the lessee shall execute a counterpart thereof. Every lease shall contain covenants on the part of the lessee for the payment of rent and all other usual and proper covenants applicable to the property comprised therein and a proviso for re-entry on non-payment of the rent or non-performance of the covenants.

# REPAIR AND INSURANCE

24. The Governors shall keep in repair and insure for full value against fire all the buildings of the United Charities not required to be kept in repair and insured by the lessees or tenants thereof.

# PROVISION OF ALMSHOUSES

25. Subject in all respects to the approval of the Charity Commissioners the Governors may provide on the land belonging to the United Charities and having a frontage to Harrison Road in the County Borough of Halifax and in substitution for the existing almshouses of the United Charities not more than 24 almshouses to be appropriated and used in accordance with the provisions hereinafter contained together with a house which shall be appropriated and used as a residence for the Superintendent hereinafter mentioned.

#### SALE

26. Subject to the authority of a further Order or Orders of the Charity Commissioners the Governors may sell or otherwise deal with any part of the last-mentioned land not required as a site for almshouses together with any part of the existing almshouses, the school or other buildings thereon.

#### EXPENSES OF MANAGEMENT

- 27. The Governors shall first defray:—
  - (a) The cost of repairs and insurance and all other charges and outgoings payable in respect of the property of the United Charities out of the income of the United Charities;
  - (b) All the proper costs, charges and expenses of and incidental to the administration of the Charities out of the income of the Charities and as between the United Charities and the Afternoon Lecturer's Fund so far as may be rateably.

# EXTRAORDINARY REPAIR FUND

- 29.—(1) Subject to any further Order or Orders of the Charity Commissioners a fund for the extraordinary repair, improvement or rebuilding of the almshouses and other property belonging to the United Charities shall be provided and maintained as follows.
- (2) The Governors shall pay to The Official Trustees of Charitable Funds a yearly sum of not less than £500 out of the income of the United Charities and the said Official Trustees shall invest the yearly sum so paid at compound interest in the purchase in their name to the credit of an account to be entitled Extraordinary Repair Fund of any of the securities authorised by law for the investment of trust funds.

# APPLICATION OF INCOME

30. Subject to the payments aforesaid the Governors shall apply the income of the United Charities in the maintenance and upkeep of the almshouses for the time being belonging to the United Charities and subject thereto for the benefit of the poor of the area of benefit in accordance with the provisions hereinafter contained.

# GENERAL BENEFIT OF POOR

31. The Governors shall apply the income of the United Charities hereinbefore directed to be applied for the benefit of the poor of the area of benefit as they think fit for the benefit either of the poor of

the area of benefit generally or of such poor persons resident therein as they select and in particular but without prejudice to the generality of the foregoing in one or more of the following ways:—

- (1) In providing financial assistance, outfits, clothing, tools, instruments or books to assist poor persons on leaving school, university or any other educational establishment to prepare for or enter into a profession, trade or calling.
- (2) In promoting in such ways as the Governors think fit the education (including social and physical training) of poor persons.
- (3) Gifts of bedding, clothing, food, fuel, furniture or other useful articles, including comforts or other aids for the sick.
- (4) Weekly allowances of not more than 10s. 6d.
- (5) Gifts in money to relieve sickness, infirmity or distress.
- (6) Grants for the benefit of persons who are sick, infirm, convalescent or in need of rest or change of air to defray the expense of recuperative holidays or of obtaining domestic help.
- (7) Payment of travelling expenses of persons entering or leaving hospitals, convalescent homes or similar institutions or of relatives visiting the sick or infirm in such institutions.
- (8) Subscriptions to almshouses and other charitable institutions or organizations having for their object the benefit of poor persons of the area of benefit.
- (9) Subscriptions to homes or hostels for the residence or care of old, infirm or homeless persons upon terms which will ensure that their benefits are available for poor persons of the area of benefit.

# RESTRICTION

32. In applying the income of the United Charities in accordance with the provisions of the last preceding clause hereof the Governors shall not give assistance to individuals unless satisfied that such individuals are deserving and in need.

#### ALMSHOUSES

33. The almshouses from time to time belonging to the United Charities and the property occupied therewith shall be appropriated and used for the residence of almspeople in conformity with the provisions of this Scheme.

#### SAVING FOR EXISTING ALMSPEOPLE

34. Appointments of almspeople under this Scheme shall be made without prejudice to the interests of the existing almspeople.

# QUALIFICATIONS OF ALMSPEOPLE

35. The almspeople shall be poor aged persons of good character who (except in special cases to be approved by the Charity Commissioners) are resident in the area of benefit at the time of appointment.

# NOTICE OF VACANCY

36. No appointment of an almsperson shall be made by the Governors until a sufficient notice of an existing vacancy specifying the qualifications required from candidates has been published in the area of benefit by advertisement or otherwise so as to give due publicity to the intended appointment but it shall not be necessary to publish a notice if a vacancy occurs within twelve calendar months after the last notice of a vacancy has been published. Notices may be according to the form annexed hereto.

# APPLICATIONS FOR APPOINTMENT

37. All applications for appointment shall be made in writing to the Governors or their clerk in such manner as the Governors direct. Before appointing any applicant to be an almsperson the Governors shall require him or her to attend in person unless he or she is physically disabled or the Governors are of opinion that special circumstances render this unnecessary. Every applicant must be prepared with sufficient testimonials and other evidence of his or her qualification for appointment.

#### SELECTION OF ALMSPEOPLE

38. Almspeople shall be selected only after full investigation of the character and circumstances of the applicants.

#### APPOINTMENTS OF ALMSPEOPLE

39. Every appointment of an almsperson shall be made by the Governors at a special meeting.

# RECORDS

40. The Governors shall provide and keep a book in which shall be entered the name, age and description of every person appointed to be an almsperson, the date of every appointment and the date and occasion of every vacancy. They shall also keep a register of all applications for appointment.

#### ABSENCE FROM ALMSHOUSES

41. No almsperson shall be absent from the almshouses for a period exceeding 24 hours without having first notified the Superintendent, the Clerk of the Governors or one of the Governors. No almsperson shall be absent for more than 7 days at any one time or more than 28 days in any one year without the consent of the Governors.

# ROOMS NOT TO BE LET

42. No almsperson shall be permitted to let or part with the possession of the room or rooms allotted to him or her or except with the special permission of the Governors to suffer any person to share the occupation of the same or of any part thereof.

#### SUPERINTENDENT

43. The Governors shall appoint a Superintendent dismissible at their pleasure to perform such duties as may be necessary for the superintendence and care of the almspeople at such reasonable salary as they think fit and shall permit the Superintendent while she holds office to reside in the house hereinbefore appropriated for use as a residence for the Superintendent.

#### LECTURER

- 44.—(1) The Governors shall appoint upon the nomination of the Vicar for the time being of Halifax a clergyman of the Church of England dismissible at their pleasure to be the Lecturer of the Charities.
  - (2) The Lecturer may resign his appointment at any time.
- (3) The Lecturer shall be entitled to receive the clear income of the Afternoon Lecturer's Fund while he holds office as Lecturer.

# Duties of Lecturer

45. The Lecturer shall visit in sickness and otherwise as there shall be occasion the almspeople of the Charities, shall hold or provide for the holding of a religious service for the almspeople once in every week and shall perform such other duties in relation to the almspeople as the Governors may prescribe from time to time and are agreed by the Lecturer.

# REMOVAL OF ALMSPEOPLE

- 46.—(1) The following persons may be removed from being almspeople:—
  - (a) Any almsperson who in the opinion of the Governors is guilty of insobriety, insubordination, breach of regulations or immoral or improper conduct;
  - (b) Any almsperson who in the opinion of the Governors no longer has the required qualifications;
  - (c) Any almsperson who has been appointed without having the required qualifications;
  - (d) Any almsperson who is suffering from mental or other disease or infirmity rendering him or her unfit to remain an almsperson.
- (2) Upon the removal of any almsperson or Superintendent the Governors shall take possession of the room or rooms occupied by him or her.

(3) Any almsperson removed under section (1) of this clause on account of mental or other disease or infirmity may be re-appointed on recovery without previous notice being given of the vacancy and need not have the qualification as to residence.

# REGULATIONS

47. The Governors may prescribe from time to time such reasonable regulations as they consider expedient for the government of the almshouses and the almspeople but so that the same shall not be at variance or inconsistent with any of the provisions of this Scheme and by such regulations may provide that the almspeople shall render such assistance to each other and to the Superintendent as is within their power.

# APPROPRIATION OF BENEFITS

48. The appropriation of the benefits of the Charities shall be made by the Governors at meetings of their body and not separately by any individual Governor or Governors; provided that the Governors from time to time may appoint two or more members of their body to be a committee for dealing with any cases of emergency but all acts and proceedings of committees shall be reported in due course to the Governors.

# GOVERNORS NOT TO BE PERSONALLY INTERESTED

49. No Governor shall take or hold any interest in property belonging to the Charities otherwise than as a Governor for the purposes thereof and no Governor shall receive remuneration, or be interested in the supply of work or goods, at the cost of the Charities.

#### CHARITIES NOT TO RELIEVE PUBLIC FUNDS

50. The funds or income of the Charities shall not be applied in relief of rates, taxes or other public funds, but income of the United Charities applicable for the general benefit of the poor may be applied in supplementing relief or assistance provided out of public funds.

# ALTERATION OF SCHEME

51. The Charity Commissioners in the exercise of their ordinary jurisdiction may establish from time to time Schemes for the alteration of any of the provisions of this Scheme as if those provisions had been made by the founder in the case of a Charity having a founder.

# QUESTIONS UNDER SCHEME

52. Any question as to the construction of this Scheme or as to the regularity or the validity of any acts done or about to be done under this Scheme shall be determined by the Charity Commissioners upon such application made to them for the purpose as they think sufficient.

# Ch. vi

#### DATE OF SCHEME

53. The date of this Scheme shall be the date of the Act of Parliament confirming the same.

# FORM OF NOTICE

In the matter of the Nathaniel Waterhouse Charities, in the County Borough of Halifax and the Ancient Parish of Halifax, in the West Riding of the County of York.

Notice is given that a vacancy exists for an almsperson of these Charities.

Poor aged persons of good character residing in the County Borough of Halifax or in the area of the Ancient Parish of Halifax are eligible for appointment.

Application for appointment must be made in writing to at on or before the 19. Every applicant must state his or her name, address, age and occupation and must be prepared to produce sufficient testimonials and other evidence of his or her qualification for appointment and unless physically disabled to attend in person.

Note.—In special cases to be approved by the Charity Commissioners persons who do not possess the prescribed qualification as to residence may be appointed if otherwise qualified.
