# GEORGII III. REGIS.

## Cap. 18.

An Act for amending, widening, repairing, and improving the Road from or from near to the Village of Glossop, in the County of Derby, to or near to Marple Bridge, in the said County; and for making several Branches of Roads to and from the same.

[24th March 1803.]

HEREAS the Road leading from the Village of Glossop, in the County of Derby, through the several Hamlets of Glossop, Whitfield, Dinting, Simondley, Charlesworth, Chisworth, and Ludworth, to or near to Marple Bridge, in the said County of Derby, is in a very ruinous Condition, in some Parts thereof narrow and incommodious, and cannot be effectually amended, widened, altered, improved, and kept in Repair by the ordinary Course of Law: And whereas it will be of great Convenience to the Neighbourhood, and of publick Utility, if a new Branch of Road were made from and out of the said Road from or from near a Place called The Lower Fold, in the Hamlet of Ludworth. aforesaid, to Compstow Bridge, in the said County of Derby, and another new Branch of Road from and out of the present Road, at or near a certain Place called Gamesley, in the said Hamlet of Charlesworth, to or near to a Place called Runal Intake, in the Hamlet of Padfield, in the [Loc & Per.] faid

faid County, to communicate with the Turnpike Road leading from-Chapel-en-le-Frith to Enterclough Bridge, in the said County of Derby; and another new Branch of Road from or near a Place called Turnlee, in the Hamlet of Simonales, by Dinting Mill, to a Place called Woolley Bridge, in the Hamlet of Hadfield, in the Parish of Glossop, in the said County, to communicate with the Turnpike Road leading from Glossop aforesaid to Chayland's Gate, in the Township of Longdendale, in the County, Palatine of Chester: And whereas the amending, widening, altering, unproving, and keeping in Repair the said Road, and the making and maintaining the said several new Branches of Road, will greatly tend to the Improvement of the Trade and Commerce carried on in the Neighbourhood thereof, and be a great Benefit and Convenience to all Persons travelling thereon; but the several Purposes before mentioned ' cannot be effected without the Aid and Authority of Parliament: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That Thomas Andrew, George Andrew, John Bennett, Thomas Bennett, Ralph Bridge, Arthur Bostock, Robert Bennett, George Burgess, Thomas Beard, John Brocklehurst, Thomas Barker, William Chambers Bagshaw, Samuel Bagshaw, John Cooper, William Chatterton, William Carleill, Thomas Dewhurst, Thomas Dalton, Joseph Denman, Francis Eyre, Vincent Eyre, Matthere Ellison, Samuel Frith, Joseph Gould, Bernard Howard, Henry Howard, Edward Howard, John Heaton, Moses Hadfield, Joseph Hadfield, Christopher Howe Clerk, Entwistle Hague, Thomas Hadsield, Jonathan Jowett, John Isherwood, John Kershaw, Henry Kelsall, Henry Kirk, Samuel Kinder, Joseph Lyne, John Loton, Joshua Marriott, James Mander, Charles M'Niven, James Nield, Robert Newton, James Newton, Isaac Newton, Samuel Oldknow, James Platt, Parkinson, William Radthiffe, Samuel Ratcliffe, John Ratcliffe, John Reddish, John Robinson, George Roberts, Robert Robinson, James Robinson, Thomas Rhodes, William Starkie, Robert Shepley, Samuel Shepley, Ashton Ashton Shuttleworth, Robert Thornley, John Thornley, Joseph Thornley, Robert Thornley, John Turner, James Turner Clerk, James Taylor, Bache Thornhill, Harry Bache Thornbill, Nathaniel Wright, John Whitehead Clerk, James Wag staff, Ralph Wood, William Wardlow, Thomas Wood, Thomas Winterbottom, Robert Wright, and their Successors to be elected in Manner herein-after mentioned, shall be and they are hereby appointed Trustees for making, amending, widening, altering, diverting, improving, and keeping in Repair the said Road and Branches of Road, and for otherwise putting this Act in Execution.

II. And be it further enacted, That when and as often as any Trustee ing new Trus- shall become, by Bankruptcy or Insolvency, dispossessed of the Qualification herein-after mentioned, or shall cease to reside for the Space of Two Years together in any of the Counties of Derby, Chester, or Lancaster, or shall die or refuse to act, it shall be lawful for the surviving or remaining Trustees, or any Five or more of them, by Writing under their Hands, to elect One other Person living in any of the said Counties, to be a Trustee in the Room of such Trustee so diqualified to act, or ceasing to reside as aforesaid in any of the said Counties of Derby, Chester, or Lancaster, or deceased, or refusing to act; but Notice of the Time and

Place of Meeting for every such Election shall be given by the Clerk or Clerks to the said Trustees, by affixing the same in Writing upon all the Turnpike Gates then erected or to be erected in or upon the said Roads, and also by inserting the same in some Newspaper circulating in the Neighbourhood through which the said Roads pass, at least Ten Days before every such Meeting; and all Persons that shall be so elected are hereby vested with the same Powers for putting this Act in Execution as the Persons in whose Places they shall be respectively chosen were vested with; and that no Trustee or Trustees shall have Power to act in the Execution of this Act but during such Time only as he or they shall live or reside within the said Counties of Derby, Chester, or Lancaster, or One of them.

III. And be it further enacted, That no Person shall be capable of Qualification acting as a Trustee in the Execution of this Act, unless he shall be, in of Trustees. his own Right, or in the Right of his Wife, in the actual Possession or Receipt of the Rents and Profits of Lands, Tenements, or Hereditaments, of the clear yearly Value of Forty Pounds above Reprizes, or shall be Heir Apparent of a Person possessed of an Estate in such Lands, Tenements, or Hereditaments as aforesaid, of the clear yearly Value of Eighty Pounds above Reprizes, or shall be possessed of or entitled unto a Personal Estate to the Amount of Eight hundred Pounds, nor (except in administering the Oath following) before he (not being such Heir Apparent) shall have taken and subscribed the Oath following, before any Five or more of the said Trustees, who are hereby authorized and empowered to administer the same; that is to say,

A. B. do swear that I truly and bonâ fide am seised of, in my own Oath. Right, (or, in the Right of my Wife, as the Case may be), and in the actual Possession, Enjoyment, or Receipt of the Rents and Prosits

of a Real Estate in Law or Equity, of the clear yearly Value of Forty 'Pounds, (or, possessed of a Personal Estate of the Amount of Eight 'hundred Pounds).

And if any Person not being so qualified shall presume to act as a Trustee Penalty on in the Execution of this Act, except in administering such Oath as afore- Fersons acting said, or being so qualified shall act as such Trustee before he hath taken fied. and subscribed the said Oath, every such Person so offending in all of any of the Premises, shall, for every such Offence, forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same, to be recovered, with full Costs of Suit, in any of His Majesty's Courts of Record, by Action of Debt, or on the Case, or by Bill, Plaint, Suit, or Information, wherein no Essoign, Protection, or Wager of Law, or more than One Imparlance shall be allowed; and every Person so prosecuted shall prove that he is qualified as aforesaid, or otherwise shall pay the said Penalty, without any other Proof or Evidence on the Part of the Prosecution than that fuch Person hath acted as a Trustee in the Execution of this Act; and that no Trustee shall be capable of acting in the Execution of any of the Powers hereby granted during the Time he shall hold any Place of Profit under this Act; nor shall any Victualler, or Retailer of Ale, Beer, or Spirituous Liquors, or any menial Servant of any Trustee, be capable of holding any Place of Profit under this Act; but all fuch Trustees as are Justices of the Peace may act as Justices in the Execution

of this Act, notwithstanding their being Trustees, (except only in such Cases where they shall be personally interested).

Trustees may fue and be sued in the Name of their Clerk, &c.

IV. And be it further enacted, That the said Trustees may sue and be sued for or concerning any Thing to be done by virtue or in pursuance of this Act, either in the Names of Trustees as may be Parties to any Deed or Instrument in Writing, upon which any Action shall or may be brought, or in the Name of their Clerk for the Time being; and that no Action or Suit to be brought or commenced by the Direction of or against the said Trustees by virtue of this Act, in their Names or in the Name of their Clerk, shall abate or be discontinued by the Death, Incapacity, or Removal of any Trustee or Trustees, or Clerk, or by the Act of such Clerk, without the Consent of the said Trustees, or any Five or more of them; but that the Clerk for the Time being to the said Trustees, in case such Action shall be brought against or defended in the Name of such Clerk, shall be deemed to be Plaintiff or Defendant (as the Case may be) in every such Action: Provided always, that such Trustees, or Clerk in whose Name or Names any Action or Suit shall be commenced, prosecuted, or defended in pursuance of this Act, shall be fully reimburied and paid out of the Monies to arise by virtue of this Act, all such Costs, Charges, Damages, and Expences, as by the Event, or in consequence of any such Action or Proceeding, they or he shall pay, bear, expend, or be put unto, or become chargeable with, by reason of their or his being so made Plaintiffs or Defendants, Plaintiff or Defendant, as aforesaid.

First Meeting of the Trustees, &c.

V. And be it further enacted, That the said Trustees, or any Five or more of them, shall meet on Thursday the Fourteenth Day of April One thousand eight hundred and three, or as soon after as conveniently may be, at the House of Edward Pickford, in Glossop aforesaid, and proceed to the Execution of this Act; and shall then adjourn themselves, and afterwards meet yearly, some Time in the Month of August, at the Place aforesaid, or any other Place near the said Roads, as the said Trustees, or any Five or more of them, shall think proper or convenient for putting this Act in Execution; which Meeting shall be deemed a General Meeting, and at which yearly Meeting all Accounts relating to the said Trust shall be examined, settled, and adjusted; and the said Trustees, or any Five or more of them, shall, at any such Meeting, adjourn themselves to some convenient Place or Places at or near the said Roads respectively, and may make such further Adjournments from Time to Time, for putting this Act in Execution, as they shall think proper; and if it shall happen that there shall not appear at any such Meeting a sufficient Number of Trustees for the Purposes aforesaid, then and in such Case the Clerk to such Trustees, by Notice in Writing to be affixed at or on all the Turnpikes then erected on the said Roads, at least Ten Days before the next Meeting, shall appoint such Trustees to meet at the House where the last Meeting of such Trustees was appointed to be held, on that Day Three Weeks on which such last Meeting of such Trustees was appointed to have been held; and that the said Trustees at all their Meetings shall defray their own Charges and Expences; and all Orders and Determinations of the said Trustees in the Execution of this Act, shall be made at Meetings to be held in pursuance fof this Act, and not otherwise, (except as herein particularly mentioned); and no Order or Determination

Determination of the said Trustees shall be made, unless a Majority of the Trustees present at a Meeting shall concur therein, such Meeting not consisting of less than the respective Number herein mentioned, (as the Case may be); nor shall any such Order or Determination be revoked or altered at any subsequent Meeting, unless Nine Trustees shall be present. nor unless the Person or Persons applying to revoke or alter any such Order, shall give Notice thereof in Writing to the Clerk to the said Trustees, and for Want of fuch Clerk to the Person or Persons acting as Treasurer or Treasurers to the said Trustees, to be by him or them affixed and inserted in Manner herein-before mentioned, at least Ten Days previous to any fuch Meeting.

VI. And be it further enacted, That if after any Adjournment of the Meetings on said Trustees, it shall at any Time be thought necessary that an earlier Day of Meeting should be appointed than the Day appointed by such Adjournment, then and in that Case the Clerk to the said Trustees, upon an Order in Writing signed by Three or more of the acting Trustees, although not assembled at a Meeting, mentioning the Time, Place, and Purpose of such Meeting, shall forthwith give Notice thereof in the Manner before directed, and of the Time and Place which shall be mentioned in the Order of the said Trustees, (such Time being not less than Twenty Days after such Notice), and such earlier Meeting shall and may be held accordingly, and all the Proceedings of the Trustees at all such Meetings shall be as valid and effectual as they would have been in case fuch Meetings had been held in pursuance of Adjournments:

Emergencies:

VII. And be it further enacted, That the said Trustees, or any Five or Trustees may more of them, may appoint such Clerk or Clerks, Treasurer or Treas appoint Officers, &c. surers, Receiver or Receivers, Collector or Collectors of the Tolls hereby granted, and other Officers respectively, as they shall think proper; and that the faid Trustees, or any Five or more of them; shall and may, at a Meeting to be held for that Purpose, whereof Twenty Days Notice shall be given in Writing, to be affixed upon the respective Turnpikes which shall be then erected on the faid Roads, by any Writing or Writings under their respective Hands, from Time to Time, to remove fuch Clerks, Treasurers, Receivers, Collectors, Surveyors, and other Officers, as they shall see Occasion, and appoint new Ones in Cases of Death or such Removal; and the said Tolls shall be paid after the Rates herein mentioned, to such Persons as shall be so appointed to receive the same; and the said Treasurers, Receivers, Collectors, Surveyors, or other Officers, and all other Persons who shall be employed in the Receipt or Expenditure of any of the Monies arising by virtue of this Act) shall, at the said annual Meeting to be held in the Month of August in every Year, give unto such Trustees true and perfect Accounts in Writing under their respective Hands, of all the Monies which shall have been by them respectively collected or received, and how, to whom, and to what Uses the same have been paid and applied, together with proper Receipts and Vouchers for fuch Payments, and shall pay all fuch Monies as shall remain in their Hands to the said Trustees, or any Five or more of them, or to such Person or Persons, or to such Uses and Purposes as they, or any Five or more of them, shall direct and appoint; and that all such Officers and other Persons shall verify such Accounts upon Oath, (which Oath any Two of the said Trustees are hereby empowered to ad-[Loc & Per.] minister);

minister); and if any of the said Officers, or other Persons, shall not give such Account, or shall refuse to verify the same in Manner as aforesaid, that then and in either of the said Cases it shall be lawful for any Two Justices of the Peace for the County or Place where such Officer or other Person shall reside, and such Justices are hereby authorized and required to make Enquiry concerning such Default in a summary Way. as well by Confession of the Parties themselves, as by the Testimony of One or more credible Witness or Witnesses upon Oath, (which Oath the said Justices are hereby empowered and required to administer without Fee or Reward); and if any such Person shall be thereof convicted, such Justices shall commit the Party to the Common Goal of the County or Place where fuch Person shall reside, there to remain without Bail or Mainprize, until he shall give and make a true and perfect Account, and verify such Account in Manner as aforesaid; and in case any of the said Officers, or other Persons, shall refuse or neglect to pay any Sum or Sums of Money which shall appear to remain in his or their Hands, it shall be lawful for any Two Justices of the Peace for the County or Place where such Person or Persons shall live or reside, to make Enquiry touching such Neglect or Refusal in a summary Way, in Manner as aforesaid, and by Warrant under their Hands and Seals, to cause such Sums of Money as shall appear to them to be due and unpaid, to be levied by Distress and Sale of the Goods and Chattels of such Person or Persons, rendering the Overplus (if any) to the Party or Parties, after the Money remaining due, and the Charges of making such Distress and Sale shall be deducted; and if sufficient Distress cannot be found, then the faid Justices, or any Two other Justices for the respective County or Place, shall commit such Person or Persons to the Common Gaol of the County or Place where such Person shall live or reside, there to remain; without Bail or Mainprize, until he or they shall have paid over such Money in Manner as aforesaid, or compounded for the same, and paid fuch Composition Money to the said Trustees, or any Five or more of them, or to such Person or Persons as they, or any Five or more of them, shall appoint to receive the same, which Composition the said Trustees, or any Five or more of them at any Meeting, are hereby empowered to make: Provided always, that no Person shall be committed for Want of sufficient Distress, for any longer Space of Time than Six Calendar Months.

Trustees to appoint temporary Collectors.

VIII. And be it further enacted, That upon the Death, Incapacity, abfoonding, misbehaving, or Absence of any Collector or Receiver of the Tolls, any Five or more of the said Trustees, though not at a Meeting of the said Trustees appointed by virtue of this Act, shall and may lawfully discharge such Collector or Receiver who shall abscond, misbehave, or become incapable, or absent himself as aforesaid, and nominate and appoint a proper Person to be a Collector or Receiver of the said Tolls in the Stead of such Collector or Receiver so dying or being discharged, and to continue until the next Meeting of the said Trustees, which Person so nominated and appointed shall have the like Power and Authority, and be answerable and accountable in the same Manner in all Respects as the Person who shall so die or be discharged would have had or been subject to; and that if any Collector or Receiver of the said Tolls, who shall be discharged from his said Office by the said Trustees, or the Wife or Widow, or any of the Children, Family, or other Representa-

tives of any Collector or Receiver who shall die, abscond, absent himself, or be discharged, or any other Person, shall refuse or neglect to deliver up the Possession of any Toll House or Building to be erected or set up by virtue of this Act, for the Space of Fourteen Days after Demand thereof made, and Notice in Writing given or left on the Premises for that Purpose, by or under the Hands of any Five or more of the said Trustees, or their Clerk or Treasurer, then and in any of the said Cases it shall be lawful for any Justice or Justices of the Peace for the County in which fuch Toll House or Building shall be, by Warrant under his or their Hand and Seal, or Hands and Seals, to order any Constable or other Peace Officer within the same County, with such Assistance as shall be necessary, to enter such House or Building in the Day Time, and to remove the Person and Persons who shall be found therein, and the Occupier, and Occupiers thereof, together with his, her, or their Goods, out of the same, and to put the said Trustees, or any Three or more of them, or their Clerk, or their new appointed Officer, into the Possession thereof, with the Appurtenances.

IX. And be it further enacted, That out of the Monies arising by the Trustees may Tolls to be collected at each respective Turnpike, such Allowances shall allow Salaries. be made to the Collector or Collectors of the Tolls at such respective Turnpikes as the said Trustees, or any Five or more of them, shall think proper; and that out of the Monies arising by the Tolls to be collected at all the said Turnpikes, such Allowances and Compensations shall be made to the said Clerk or Clerks, Treasurer or Treasurers, Receiver or Receivers, Surveyor or Surveyors, and to such other Persons as shall be affishing in and about the Execution of this Act, as to the said Trustees, or any Five or more of them, shall seem reasonable.

X. Provided always, and be it further enacted, That the said Trustees, Treasurers to or any Five or more of them, shall take such Security from their Treasurers, Clerks, Collectors of the Tolls, and other Officers, for the due Execution of their respective Offices, as to such Trustees, or any Five or more of them, shall seem expedient.

XI. And be it further enacted, That the said Trustees, or any Five Power to erect or more of them, shall and may erect and set up, or cause to be erected and set up, so many Turnpike or Turnpikes, Toll Gate or Toll Gates, in, upon, across, or on the Side or Sides of any Part of the said several Roads and intended Branches of Road, or of any Lane or Way leading into the same respectively, as they may judge expedient; and shall and may also erect or provide a Toll House, with suitable Outbuildings and Conveniencies, at or near each Turnpike or Toll Gate; and may also inclose from the said Roads convenient Garden Spots to the said Toll Houses, as they the faid Trustees, or any Five or more of them, shall judge proper; and may cause all or any of such Turnpikes, Toll Gates, Toll Houses, and other Buildings, from Time to Time to be taken down, removed, and set up again, or altered, as they, or any Five or more of them, shall think proper.

Turnpikes.

XII. And be it further enacted, That the Property of all the Turns vesting Turns pikes and Toll Houses, and other Buildings, Weighing Engines, and houses in Fences, erected or provided in and upon or on the Sides of the said Trustees. Roads,

Roads, and of the Materials for building the same, and for repairing the said Roads, shall be vested in the said Trustees; and they, or any Five or more of them, are hereby empowered to bring Actions in the Name or Names of any One or more of them, or of their Clerk or Clerks, Treasurer or Treasurers, or to prefer Bills of Indictment against any Person or Persons who shall disturb them in the Possession thereof.

Tolls to be taken at the Bars.

XIII. And be it further enacted, That the respective Tolls following shall and may be demanded and taken by such Person or Persons as the said Trustees, or any Five or more of them, shall from Time to Time appoint for that Purpose, before any Horse or other Cattle, Cart, Waggon, or other Carriage, shall be permitted to pass through any Turnpike or Toll Gate, Turnpikes or Toll Gates, as shall or may be erected by virtue of this Act; (that is to fay),

Tolls:

For every Horse or other Beast of Draught drawing any Coach, Berlin, Landau; Hearse, Chariot, Curricle, Calash, Chaise, Chair Marine, or Chair, the Sum of Four-pence:

For every Horse or other Beast of Draught drawing any Waggon, Wain, Cart, or other such Carriage, with Wheels of the Breadth of

Six Inches or more, the Sum of Four-pence:

For every Horse or other Beast of Draught, drawing any Waggon, Wain, Cart, or other such Carriage, with Wheels of less Breadth than Six Inches, the Sum of Sixpence:

For every Horse, Mare, Gelding, Mule, or Ass, laden or unladen,

and not drawing, One Penny:

For every Drove of Oxen or Neat Cattle, the Sum of One Shilling and Three-pence per Score; and so in Proportion for any greater or less Number:

And for every Drove of Calves, Swine, Hogs, Sheep, or Lambs, the Sum of Five-pence per Score; and so in Proportion for any greater or less Number:

Double Toll to be taken on Sunday.

And that on every Sunday after the passing of this Act, there shall be demanded and taken at any of the Turnpikes or Toll Gates to be erected by virtue of this Act, by such Person or Persons so to be nominated and appointed as aforesaid, before any Horse, Cattle, or other Beast, shall be permitted to pass through the same, Double the Tolls before directed to be taken on any other Day of the Week.

For Recovery of Tolls, etc.

Which said respective Sums of Money shall be demanded and taken in the Name of or as a Toll; and if any Person or Persons subject to the Payment of any of the said Tolls, shall, after Demand thereof made, neglect or refuse to pay the same, or any Part thereof, it shall be lawful for the Person or Persons to be appointed as aforesaid, to collect such Foll, to seize and distrain any Horse, Beast, or other Cattle, or any of their Harness or Accoutrements; and if such Tolls, and the reasonable Charges of such Seizure and Distress, and of detaining and keeping the same, shall not be paid within the Space of Four Days next after such Seizure and Distress made, the Person or Persons so distraining shall and may sell the Horse, Cattle, Beast, or Things so distrained, returning the Overplus, (if any), on Demand, to the Owner thereof, after such Tolls and all reasonable Charges shall be deducted; and that all the Tolls to be collected or levied by virtue of this Act, shall be, and are hereby.

hereby vested in the said Trustees, and shall be applied and may be assigned in such Manner as herein-after mentioned.

XIV. And be it further enacted, That if any Dispute shall happen For settling about the Quantity of Tolls due, or the Charges of keeping any Diff Cerning Tolls. tress, it shall be lawful for the Collector or Person so distraining to retain fuch Distress, or the Money arising from the Sale thereof, as the Case may happen, until the Quantity of the Tolls or the Charges of the Diftress and Sale, and of keeping the Distress, as the Case may happen, be ascertained by some Justice of the Peace for the said County, who upon Application made to him for that Purpose shall examine the Matter on Oath of the Parties, or other Witness or Witnesses, and shall determine the Quantity of the Tolls due, and also assess the Charges of such Distress and Sale, and of the Collector's Attendance for that Purpose, upon the said Justice; all which said Sums as shall be so determined or assessed; shall be paid to the said Collector before he shall be obliged to return the said Distress; or the Overplus after Sale thereof, or any Part thereof.

XV. Provided always, and be it further enacted, That no Person who Tolls to be shall have paid Toll for passing through any Turnpike to be erected upon taken but the said Roads, shall be subject to any Toll for returning through such Once a Day. Turnpike the same Day before Twelve of the Clock at Night with the same Horses, or other Cattle, or with the same Coach, Chaise, Waggon, or other Carriage, but shall return Toll-free, on delivering a Note or Ticket to the Collector of the Tolls at such respective Turnpikes, which Note or Ticket such Collector is hereby required to deliver gratis on Receipt of the Tolls.

XVI. And be it further enacted, That no Toll shall be demanded or No Toll for taken for the passing of any Cattle or Carriage which shall only cross crossing the the said Roads or any of them, or shall travel on them or any of them for the Space of One hundred Yards only; unless such crossing shall be with an Intent to avoid the Payment of Toll at any of the said Turnpikes or Toll Gates, and the Payment of such Tolls shall be avoided accordingly:

XVII. Provided always, and be it further enacted, That no Toll shall Exemptions be demanded or taken for or in respect of any Horses or Carriages of from Tolles whatsoever Description employed or to be employed, in carrying the Mails of Letters or Expresses under the Authority of His Majesty's Post-Master General, either when employed in conveying, fetching, or guarding such Mails or Expresses, or in returning therefrom; nor for the Horses belonging to any Officers or Soldiers upon their March, or on Duty; nor for any Horses, Cattle, or Carriages employed in carrying or conveying the Arms or Baggage of any such Officers or Soldiers, or in carrying any sick, wounded, or disabled Officers or Soldiers; nor shall any Toll be demanded or taken of or from any Rector, Vicar, or Curate going to officiate, of returning from officiating at any Church or other Place of Divine Worship, or visiting his sick Parishioners; nor of or from any Person or Persons going to, or returning from his, her, or their Parochial Church, Chapel, or other Place of religious Worship on Sundays, or on any other Day on which Divine Worship is ordered by Authority to [Loc. & Per.]

be celebrated, or who shall be attending or going to attend, or returning from attending the Funeral of any Person or Persons who shall die or be buried in any Township, Hamlet, or Place through which any of the said Roads pass; nor for or in respect of any Cattle or Carriage laden only with Gravel, Stone, or other Materials for repairing the said Roads, or any Road in any of the Townships, Hamlets, or Places, in which the same do lie, or Dung, Mould, Marl, Soil, or Compost, of any Nature' or Kind whatsoever (Lime excepted) for manuring any Garden or other Lands or Grounds within any of the Townships, Hamlets, or Places in which any Toll Gate is or shall be erected on the said Roads, or in any of the adjoining Townships, Hamlets, or Places; or Grass, Hay, Saintfoin, Fodder, Straw, or Corn in the Straw, Turnips, or Potatoes to be laid up in the Houses, Outhouses, Barns, Yards, or Premises of the respective Inhabitants or Occupiers of Land within the said respective Townships, Hamlets, or Places, being the Growth and Produce of Land held and occupied by the respective Inhabitants or Occupiers within such respective Township, Hamlet, or Place, and carried for their own private Use and Consumption only, and not for Sale; nor for any such Cattle or Carriage going only to be, or returning after having been only so employed; nor shall any Toll be demanded or taken for any Horses or Cattle drawing any empty Carriages not used for Pleasure, and being the Property of any of the Inhabitants of fuch respective Townships, Hamlets, or Places; nor for any Cattle drawing a Carriage going with or going empty for, or returning empty after having been laden with any Flough, Harrow, or other Instrument of Husbandry also belonging to any fuch Inhabitant or Occupier; nor for any Horse or Horses, or other Cattle or Stock of any Kind, going to or from Water, Pasture, Plough, or other Work in Husbandry, or going to or returning from any Smith, or Blacksmith's Shop to be shoed; nor for any Cattle or Carriage carrying Corn to any Mill to be ground, or returning empty after having delivered such loading, or going unladen to fetch such Corn ground, or returning loaden therewith, such Corn being the Property of any Inhabitant of the Township, Hamlet, or Place where such Corn shall be ground, or of any adjoining Township, Hamlet, or Place, provided fuch Corn shall be for the Use and Consumption of such Inhabitant only, and not for Sale; nor for any Horses or Carriages travelling with Vagrants sent by legal Passes; nor of or from any Person or Persons going to vote, or returning from voting at any Election of a Member to serve in Parliament for the said County of Derby, or for the Borough of Derby on the Day before the Day or Days of such Election, or the Day after the same shall be concluded; and if any Person or Persons shall claim or take the Benefit of any of the Exemptions aforesaid, not being entitled to the same, fuch Person or Persons shall for every such Offence forfeit and pay any Sum not exceeding Five Pounds nor less than Forty Shillings.

That Cattle and Carriages laden with Lime shall be subject to Toll.

XVIII. And whereas Doubts may arise how far Cattle and Carriages laden with Lime are exempt from the Payment of Toll: And whereas there is already great Passage on the Roads hereby intended to be repaired, of Horses laden with Lime; and when the said Roads shall be repaired, amended, and widened, a considerable Addition will be had to such Passage by Carriages laden with Lime: And whereas it is but reasonable that Cattle and Carriages laden with Lime should contribute to the Expence of maintaining the said Roads; be it therefore further enacted, That nothing

nothing in the Exemption Clause herein before enacted shall extend, or be construed to extend to exempt Cattle and Carriages laden with Lime from the Payment of Toll, with which they are hereby declared to be subject and chargeable, as well as all other Cattle and Carriages travelling on the said Roads, other than and except those as are particularly mentioned and specified in the herein-before enacted Exemption Clause.

XIX. And be it further enacted, That in case any Dispute, Suit, or Bar Keeper's Litigation, shall happen to arise touching or in anywise relating to the said Tolls or the Recovery thereof, the Person or Persons appointed to collect the same, or any other Person or Persons acting by or under the Authority of the said Trustees, shall be and they and every of them are and is hereby declared to be competent to give Evidence in any such Dispute, Suit, or Litigation.

XX. Provided always, and it is hereby enacted, That no Person shall NoExemption have or claim any Benefit or Exemption from Toll for or in respect of any from Tolls for Carriages with Waggon, Cart, or other Carriage, which hath or shall have Wheels of less Breadth than Six Inches on the Bottom or Sole thereof, and upon which the Sole shall not lie flat, or so as not to deviate more than Half an inches. Inch from a flat Surface, and shall not have the Nails counter-sunk so as not to rife above the Surface; or for or in respect of any Waggons, Cart, or other Carriage which together with the Loading thereof shall be of greater Weight than is allowed by an Act made in the Thirteenth Year of the Reign of His present Majesty, relating to Turnpike Roads in this Kingdom; to Waggons, Carts, or Carriages of the same Kind respectively, and laden with such Goods as do not exempt the same from the additional Toll thereby imposed; and it shall be lawful for the said Trustees, or any Five or more of them, to order all such Waggons, Carts, or other Carriages, to be weighed in like Manner and with the same Powers and Authorities as is directed for the weighing of Carriages by the said Act made in the Thirteenth Year of His present Majesty's Reign.

XXI. And be it enacted, That if any Person shall offer or dispose of any Penalty on fuch Note or Ticket to any Person, in order to evade the Payment of the said Tolls, every Person so offering or disposing of such Note or Ticket, posing of Tickets to and the Person receiving and making use of the same, shall respectively forfeit any Sum not exceeding Forty Shillings nor less than Twenty Shillings, whereof One Moiety shall go to the Informer, and the other Moiety shall be applied in such Manner as the Penalties and Forfeitures are herein directed to be applied.

Machine, or Engine to order and cause to be erected a Turnpike Gate of Toll Gate, across the said Roads, and by Writing, signed by them or any Five or more of them, to order all or any fuch Carriage or Carriages which shall pass loaded through any such Gate or Bar, or shall come upon any of the said Roads within the Distance of Fifty Yards from any such Crane, Machine, or Engine, though the same Carriage or Carriages shall not have passed through any Toll Gate or Turnpike Gate, to be weighed together with the Loading thereof; and it shall be lawful for the said Trustees, or any Five or more of them, to order any Person or Persons to receive and take over and above the Tolls hereby granted, the following Sums of Money as additional Tolls for every Hundred Weight of One hundred and twelve Pounds to the Hundred which any Waggon, Cart, or other Carriage, together with the Loading thereof, shall weigh at any Weighing Engine erected or to be erected by virtue of this A&, over and above the Weights allowed to each of them respectively by the said Act of the Thirteenth Year of the Reign of His present Majesty: that is to say, for the First and Second Hundred of such Overweight, the Sum of Three-pence for each Hundred; for every Hundred of such Overweight above Two Hundred and not exceeding Five Hundred, the Sum of Sixpence; for every Hundred of such Overweight above Five Hundred and not exceeding Ten Hundred, the Sum of Two Shillings and Sixpence; for every Hundred of such Overweight above Ten Hundred and not exceeding Fifteen Hundred, the Sum of Five Shillings; and for every Hundred of such Overweight above Fifteen Hundred, the Sum of Twenty Shillings; which said additional Toll hereby granted and made payable, shall and may be levied and recovered in any of the Cases aforesaid upon any Person liable thereto, or upon his or her Goods or Chattels, who shall after Demand made thereof refuse or neglect to pay the same, in such Manner as any other Toll is hereby directed to be levied and recovered; and the Money arising from such additional Toll shall' be applied to the Repair of the Road where the same shall be collected.

And be it further enacted, That the Keeper of every such Toll Gate or Bar where any such Weighing Engine shall be erected, or any shall weigh all other Person appointed or to be appointed by the said Trustees, or any Five or more of them, to the Care of such Crane, Machine, or Engine, shall and is hereby required to weigh all such Waggons and Carts liable to be weighed by virtue of this Act, which shall pass laden through such Gates or Bars respectively, or shall come upon any Part of the said Turnpike Roads within the Distance of Fifty Yards from any such Crane, Machine, or Engine, without passing through any such Turnpikes or Toll Gates, or Toll Bars respectively, and which he shall have Reason to believe carry greater Weights than are allowed to pass without paying such additional Toll; and if any Gate Keeper or Person so appointed shall permit any such Waggon or Cart to pass through any such Toll Gate with greater Weight than is allowed as aforesaid, without weighing the same and receiving such additional Tolls as aforesaid, and every Owner or Driver

Driver of any such Waggon or Cart which shall pass loaded through any fuch Gates or Bars respectively, or shall come upon any Part of the said Turnpike Roads, within the Distance of Fifty Yards from any such Crane, Machine, or Engine, who shall refuse to suffer his Carriage to be weighed, or shall refuse to drive his Carriage upon the Engine upon being required so to do by the Collector or Receiver of such additional Tolls, although such Waggon or Cart shall have passed beyond the Distance of One hundred Yards from any fuch Gates or Bars respectively, or beyond any such Crane or Engine as aforesaid, or shall not drive his Cart upon the said Weighing Engine for the Purpose of being weighed, being required so to do, every such Gate Keeper or Person so appointed as aforefaid, shall for every such Offence forfeit any Sum not exceeding Five Pounds nor less than Forty Shillings; and the Driver being the Owner Or for his of every such Waggon or Cart shall for every such Offence forfeit any Neglect shall Sum not exceeding Ten Pounds, nor less than Five Pounds; and the forfeit not exceeding 51, Driver of every such Waggon or Cart, not being the Owner, shall for nor less than every such Offence forfeit any Sum not exceeding Five Pounds nor less Forty Shilthan Forty Shillings.

XXV. Penalty on Persons unloading etc. to avoid the paying the additional or any other Toll.

XXVI. And be it further enacted, That if any Person or Persons shall unload or cause to be unloaded any Goods, Wares, or Merchandize, from any Waggon, Cart, or other Carriage, at or before the same shall come to any Turnpike Gate or Weighing Engine, erected or to be erected by virtue or in pursuance of this Act, or shall load or lay upon any such Carriage, after the same shall have passed any such Turnpike or Weighing Machine, any Goods, Wares, or Merchandize, taken or unladen from any Horse, Cart, or other Carriage belonging to, or hired or borrowed by the same Waggoner or Carrier, in order to avoid the Payment of the said respective Duties of Three-pence, Sixpence, Two Shillings and Sixpence, Five Shillings, and Twenty Shillings per Hundred in the Cases aforesaid; or if any Person shall so unload, and thereby pay less Toll at such Turnpike Gate than would have been paid if such Goods, Wares, or Merchandize had not been so unloaded, each and every Person so offending in any of the Cases aforesaid, and being thereof lawfully convicted before One or more Justice or Justices of the Peace for the Limit where the Offence shall be committed, upon the Oath of One or more credible Witness or Witnesses, shall forfeit and pay any Sum not exceeding Five Pounds nor less than Twenty Shillings, to be levied upon the Goods and Chattels of the Owner of such Cart, Waggon, or other Carriage, and each and every Driver, not being the Owner of such Waggon or Carriage, so offending, and being thereof convicted as aforesaid, shall be committed to the House of Correction for any Time not exceeding the Space of Three Calendar Months.

And be it further enacted, That the Gate Keeper or Toll Ga- Gate Keepers therer of every such Toll Gate or Bar, and the Keeper of every such Toll Gate or Bar where any fuch Crane, Machine, or Weighing Engine shall upon Oath or may hereafter be erected or set up in or across the said Turnpike when re-Roads, and every Surveyor of the said Roads, shall, when required by Trustees. XXX. And whereas Part of the said Roads leads over Commonable Trustees may and Waste Grounds, and the Tolls by this Act granted may, by reason of the great Width and Extent of such Commons and Waste Grounds, be to prevent easily avoided; be it therefore further enacted, That the said Trustees or any Five or more of them, may and they are hereby authorized and empowered if they see Occasion, to make, or cause to be made such Ditches, Cops, Walls, and Fences, by the Sides of the faid Roads, or upon, over, or across the said Commons or Waste Grounds, in such Manner and Direction as they shall find necessary, so that the Payment of the said Tolls may not be avoided; and if any Person or Persons shall pull down, or otherwise damage, displace, or carry away any such Fence, or any Part thereof, or shall fill up or spoil any such Ditch, every such Person shall, for every such Offence, forseit and pay any Sum not exceeding Five Pounds nor less than Forty Shillings.

XXXI. And be it further enacted, That if any Person or Persons shall, with any Horse, Beast, Cattle, or Carriage, pass through any Lands, Grounds, or Hereditaments, lying near any Turnpike or Toll Gate at any Time erected on the said Roads (the same not being a publick Highway), or if any Owner or Occupier of any fuch Lands, Grounds, or Hereditaments, shall knowingly permit or suffer any Person or Persons with any Horse, Cattle, Beast, or Carriage whatsoever to pass through the same, or if any Person or Persons shall give to, or receive from any Person or Persons, or forge or counterfeit any Note or Ticket, Notes or Tickets, by this Act directed to be given whereby the Payment of any of the said Tolls, or any Part thereof shall be avoided; or if any Person or Persons' shall forcibly pass through any such Turnpike or Toll Gate, with any Horse, or other Cattle or Beast, without Payment of Toll, shall take off or cause to be taken off any Horse or other Cattle or Beast from any Carriage, or shall leave or cause to be left upon or near any Part of the said Roads, any Carriage, Horse, Cattle, or Beast, with Intent to avoid the Payment of any of the said Tolls, or any Part thereof, or shall with such Intent unload any Goods from any Horse, Cattle, Beast, or Carriage, or in any Manner whatsoever evade or attempt to evade the Payment of any of the Tolls hereby authorized to be taken, every Person so offending shall for every such Ossence, forfeit any Sum not exceeding Five Pounds nor less than Forty Shillings, One Moiety whereof shall be paid to the Informer or Informers, and the other Moiety shall be applied in such Manner as the Penalties are hereby directed to be applied.

through any of the said Turnpikes or Toll Gates, so that no such Composition shall be made for any Cattle or Carriages travelling for Hire; and all such Composition Money, shall be paid One Year in Advance, otherwise such Composition shall be void.

XXXIV. And be it further enacted, That it shall be lawful for the said Trustees may Trustees, or any Seven or more of them, from Time to Time, by Writ- lease Tolls. ing under their Hands and Seals, or under the Hand and Seal of their Clerk or Treasurer for the Time being, by their Order to be made for that Purpose, to let or lease the Tolls arising by virtue of this Act, or any Part or Parts of such Tolls, unto any Person or Persons, for any Term not exceeding Three Years at any One Time, for the best Rent that can or may be got for the same, payable at such Times and under fuch Covenants and unto such Person or Persons as the said Trustees or any Seven or more of them shall direct or appoint; of which Letting, Fourteen Days Notice at the least shall be given in Writing, to be affixed on all the Gates or Turnpikes which shall be then erected by virtue of this Act upon the said Roads, and by inserting the same in some publick Newspaper circulating in the Neighbourhood through which the faid Roads pass; and the Monies arising thereby shall be applied in such Manner as the Tolls so let or leased are directed to be applied.

Persons liable to the Repair of the Roads, &c. to continue so.

LVIII. And be it further enacted, That all Owners, Occupiers, Grantees, Trustees, Feossees, and Committees of any Land, Tenements. and Hereditaments, and all other Person or Persons liable to the amending or maintaining any Part or Parts of the said Roads, or any Bridge, Causeway, Drain, Arch, or Sewer therein, shall still remain liable and chargeable to the Repair thereof, in such Manner as they were before the passing of this Act, (subject nevertheless to the Regulations herein-after expressed concerning the same); and that all and every Person and Persons who by Law are obliged to do Statute Work, or are chargeable or liable to or towards the repairing or amending of any Highways in the several Parishes, Townships, Hamlets, Districts, or Places through which the said Roads shall pass, shall be liable to the Repair of the said Roads, and to perform their respective Works thereon in such and the like Manner in every Respect as they are liable to the Repair of any other Common Highway within such Parish, Township, Hamlet, District, or Place respectively.

How the Statute Work shall be apportioned. LIX. And, for ascertaining and determining what Part of the Statute Work ought to be performed on the said Roads by the Inhabitants of the several Parishes, Townships, Hamlets, Districts, or Places through which the said Roads pass; be it surther enacted, That it shall be lawful for the said Trustees, or any Two of them, being acting Justices of the Peace for the said County of Derby, from Time to Time to adjudge and order what Part of the Statute Work shall be done in or upon the said Roads hereby directed to be amended, improved, and kept in Repair, and for what Space of Time, and in what Manner the same shall be done upon the said Roads by the Inhabitants of each or any of the Parishes, Townships, Hamlets, Districts, or Places, in or through which the said Roads shall pass.

For regulating the Performance thereof:

LX. And be it further enacted, That the respective Surveyors of the Highways, or the Churchwardens or Overseers of the Poor in all the Parishes, Townships, Hamlets, Districts, or Places through which the said

said Roads pass, shall yearly and every Year, within Ten Days after Demand made to them respectively in Writing, by the Surveyor, Clerk, or Treasurer of the said Roads, in pursuance of an Order under the Hands of Two or more of the said Trustees, being acting Justices of the Peace for the said County, give and deliver to the Person making such Demand, a true and exact List or Account in Writing under their respective Hands, of the Christian and Surname of every Person in their respective Parishes, Townships, Hamlets, Districts, or Places, who are by Law chargeable towards repairing the said Roads in such Parishes, Townships, Hamlets, Districts, and Places, and shall set forth and specify in such List what each Person is respectively chargeable with, for and towards the same, and such respective Parish or Township Surveyor or Surveyors, shall (within Four Days after Notice to them given by the said Turnpike Surveyor, of the Time or Times when and where, and how many of the Persons so chargeable as aforesaid are to perform their respective Statute or Days Works) summon or give Notice thereof in the Mode prescribed by Law, to the Persons so chargeable as aforesaid; and if any such Parish or Township Surveyor or Surveyors, shall neglect or refuse to do as he and they is and are required and directed to do, or shall wilfully return incorrect or imperfect Lists, he and they shall respectively forfeit and pay the Sum of Five Pounds for every such Resulal or Neglect; and if any Person or Persons keeping a Team or Teams, Draught or Draughts, Cart or Carts, Wain or Wains, and chargeable towards repairing the said Roads, shall after such Summons or Notice as aforesaid neglect or refuse to send their respective Teams. Draughts, Carts, or Wains, furnished with Labourers, Oxen, or Horses, according to the Custom of the Country, and proper Tools to do and perform such their respective Days Works upon the said Roads, he, she, or they so neglecting or refusing shall forfeit and pay the Sum of Ten Shillings for every Day that each Team, Draught, Cart, or Wain shall be wanting, or shall not be duly employed in that Service; and if any Person or Persons who shall be sent with any Team, Draught, Cart, or Wain, to work on the said Roads, shall be found idle or negligent, it shall be deemed as if such Team, Wain, Draught, or Cart had not been sent to work on the said Roads, and the same Sum shall be accordingly forfeited and paid; and if any Statute Work shall not be performed within the Year in which the same is due, the same shall be performed in the Course of the succeeding Year.

LXI. Provided always, and be it further enacted, That it shall be law- How Trustees ful for the said Trustees, or any Five or more of them, at any of their Meetings, by Writing under their Hands, to summon all, every, or any Highways to of the Surveyor or Surveyors of the Highways of all, every, or any of the Parishes, Townships, Hamlets, Districts, or Places (the Inhabitants Money. whereof are liable to perform Statute Work on the said Roads), to appear before the said Trustees at any of their subsequent Meetings, and then to deliver in to them a full, true, and just Account in Writing of all Sums of Money by them respectively received for, in lieu of, or by way of Composition for Statute Work in their several and respective Parishes, Townships, Hamlets, Districts, or Places (which Account shall be verified upon Oath, if the said Trustees shall require the same); and in case the Person or Persons so summoned, shall neglect to appear at the Time and Place therein appointed, or shall refuse or neglect to deliver in such Account as aforefaid,

Provided always, and be it further enacted, That it shall be compound for lawful for the said Trustees, or any Five or more of them, to compound and agree by the Year or otherwise with the Possessors, Occupiers, Grantees, Trustees, Feossees, and Committees of Lands, Tenements, or Hereditaments, which are or shall be liable to or chargeable with the Repair of any Part of the said Roads within their respective Districts, or of any Bridge, Arch, or Sewer, or with any Person or Persons for the Performance of his, her, or their Statute Work thereon; and also that it shall be lawful for the Surveyor or Surveyors of the Highways of any of the said Parishes, Townships, or Places, or such Churchwardens or Overseers of the Poor respectively as aforesaid, by and with the Consent of the Majority of the Inhabitants of such Parishes, Townships, or Places, first had at any Vestry or other publick Meeting of such Inhabitants, to compound and agree by the Year or otherwise with the said Trustees, for and in lieu of the Statute Work to be performed by fuch Inhabitants upon any Part or Parts of the said Roads.

For recovering Composi-tion Monies.

LXIII. And be it further enacted, That in case the Composition Money agreed to be paid for passing through any Turnpike or Toll Gate, or in lieu of any such Repairs or Statute Work as aforesaid, or any Part or Parts of such Composition Money respectively, shall not be paid within Fifteen Days after the same shall become payable, it shall be lawful for the said Trustees, or any Justice or Justices of the Peace for the said County of Derby, by Writing under their respective Hands and Seals, to empower the Person or Persons authorized to receive such Composition Money, (Oath having been first made before such Trustees or such Justice or Justices that the same hath been demanded and remains due, which Oath the said Trustees or such Justice or Justices are hereby respectively empowered to administer), to levy such Composition Money by Distress and Sale of the Goods and Chattels of the Surveyor or Surveyors of the Highways, or of the Churchwardens, or Overseers of the Poor, or other Person or Persons having so compounded or agreed to pay such Composition Money as aforesaid, returning the Overplus (if any) upon Demand, after deducting such Composition Money and the reasonable Charges of such Distress and Sale, to the Owner or Owners. thereof.

How Surveyors of Highways are to be reimbursed, and Composition Money paid by them.

LXIV. And be it further enacted, That the respective Surveyors of the Highways, or the Churchwardens or Overseers of the Poor, who shall pay any such Composition Money, or of whom the same shall be recovered as aforesaid, shall be repaid or reimbursed the Composition Money paid by or recovered of them respectively, with the Costs and Charges attending such Recovery, by the several Ways, Means, and in fuch

such Manner as by the Laws in being Surveyors of the Highways are to be repaid or reimbursed the Monies by them expended in buying Materials for repairing the Highways.

LXV. And be it further enacted, That the said Trustees, or any Five Trusteës mäy contract for or more of them, or such Person or Persons as they shall for that Purpose Repairs. authorize, delegate, or appoint, are hereby empowered to contract with any Person or Persons for making, altering, widening, or repairing the faid Roads, or any Part thereof, and for erecting Mile or Direction Stones or Posts thereon, or for doing any other Work to be performed in the Execution of this Act, in such Manner and for such Sum or Sums of Money as the said Trustees or any Five or more of them shall think proper; and that all Contracts or Agreements in Writing entered into pursuant to any Order of the said Trustees, or any Five or more of them, by their Clerk or Treasurer, Surveyor, or other Officer, with any Workmen or other Person or Persons, relating to any Matter or Thing to be done by virtue of this Act, shall be binding upon all such Parties and Persons as shall sign the same, his, her, or their Executors and Administrators, and that Actions and Suits shall and may be maintained thereon by the said Trustees or any Five or more of them, or by their Clerk or Clerks, Treasurer or Treasurers, and in his or their Name or Names respectively, and Damages and Costs recovered against the Party or Parties, or Person or Persons failing in the Persormance of fuch Contracts or Agreements respectively; and such Sum or Sums of Money as shall or may be requisite for making or repairing the said Roads, or any other Matter or Thing to be done by virtue of this Act, and which by such Contracts or Agreements respectively the Parties ought to have done, shall be the Measure of the Damages to be recovered in any Action or Suit against such Party or Person or Persons so as aforefaid making Default in fulfilling his, her, or their Contract or Agreement, any Law or Usage to the contrary in anywise notwithstanding.

LXVI. And be it further enacted, That in case any Action or Pro- Prosecutors secution shall be commenced or prosecuted in pursuance of this Act, and prosecuted indemnissed. under the Authority or by the Direction of the said Trustees or any Five or more of them, they the said Trustees, or any Five or more of them. thall, out of the Monies arising by virtue of this Act, allow and pay to the Prosecutor or such Person or Persons in whose Name or Names such Action or Prosecution shall be commenced and prosecuted, all such reasonable Costs and Charges as such Person or Persons shall be really and bond fide out of Pocket, for or by reason of such Action or Prosecution, or any Judgement or Determination therein, and likewise indemnify all such Persons as shall be prosecuted, or have any Action or Actions brought against them, for or by reason of any Thing done in pursuance of this Act, under the Authority and by the Direction of the said Trustees, or any Five or more of them.

LXVII. And be it further enacted, That the several and respective Persons To oblige who have subscribed Money for and towards the making and repairing the Subscribers to Said Road and new Branches of Roads hereby authorized to be made, icriptions. shall and they are hereby required to pay the Sum or Sums of Money so subscribed within such Time and Times, and in such Parts and Proportions as the said Trustees or any Five or more of them shall order [Loc. & Per.] and

and direct, and the same shall be paid to such Person or Persons as the said Trustees or any Five or more of them shall by any Writing under their Hands authorize to receive the same; and if any Person or Persons shall neglect or refuse to pay the same or any Part thereof as aforesaid, it shall be lawful for the said Trustees, or any Five or more of them, to fue for and recover the same in the Name of the said Trustees or any Five or more of them, or in the Name of their Clerk or Treasurer, in any of His Majesty's Courts of Record, by Action of Debt, or on the Case, Bill, Plaint, Suit, or Information, wherein no Essoign, Protection, or Wager at Law, or more than One Imparlance shall be allowed.

For paying the Expences of this Act, stc.

LXVIII. And be it further enacted, That out of the Monies to be received by virtue or to be borrowed on the Credit of this Act, the said Trustees or any Five or more of them shall in the first Place pay and discharge the Expences of procuring and passing this Act; and the Remainder of such Monies shall from Time to Time be applied in erecting Toll Gates or Turnpikes, Weighing Engines, and Toll Houses, and in making, repairing, widening, altering, improving, and keeping in Repair the said Roads, and in defraying the necessary Expences attending the Execution of this Act, and in paying the Interest and Principal of any Money to be borrowed by virtue hereof, and to no other Use or Purpose whatsoever.

Trustees may compound for Penalties.

LXIX. And be it further enacted, That in all Cases where any Action or Actions, Suit or Suits, shall be brought, commenced, or prosecuted against any Person or Persons for any Penalty or Penalties contained in this Act, or for Breach or Non-performance of any Contract or Contracts entered into, it shall be lawful for the said Trustees or any Five or more of them, from Time to Time to compound or agree for such Sum or Sums of Money as they shall think proper, instead of receiving the Whole of such Penalty or Penalties; and such Trustees or any Five or more of them may also mitigate, compound, or lessen any other the Forfeitures incurred under this Act, but the Sum so compounded or agreed for shall not be less than the Injury or Damage sustained by the Breach or Non-performance of any such Contract; and all the Costs, Charges, and Expences which shall be occasioned thereby, and the Mitigation of the said other Penalties or Forfeitures shall not extend to remit above One Moiety of such Penalties and Forfeitures respectively.

Distress not deemed unlawful for want of Form.

LXX. And be it further enacted, That where any Distress shall be made for any Penalty, or Sum or Sums of Money to be levied by virtue of this Act, the Distress itself shall not be deemed unlawful, nor the Party or Parties making the same be deemed a Trespasser or Trespassers ab initio on Account of any Irregularity which shall hereafter be done by the Party or Parties so distraining; but the Person or Persons so aggrieved by such Irregularity shall and may recover full Satisfaction for the special Damage in an Action on the Case; Provided always, that no Plaintiff shall recover in any Action for such Irregularity, Trespass, or other Proceedings, if Tender of sufficient Amends shall be made by or on Behalf of the Party or Parties who shall have committed, or caused to be committed any such Irregularity, Trespass, or wrongful Proceeding before such Action brought; and the Defendant or Defendants in any such Action,

Action, by Leave of the Court where such Action shall depend, may at any Time before Issue joined pay into Court such Sum of Money as he or they shall think sit, whereupon such Proceedings or Orders and Judgements shall be had, made, and given in and by such Court, as in other Actions where the Defendant is allowed to pay Money into Court.

LXXI. And be it further enacted, That if any Person or Persons shall General Apthink himself, herself, or themselves aggrieved by any Thing done in pure pealsuance of this Act, for which no particular Method of Relief hath been herein-before appointed, such Person and Persons shall and may appeal to the Justices of the Peace at any General Quarter Sessions to be holden in and for the said County of Derby, within Three Calendar Months next after any Order or Determination of the said Trustees or any Five or more of them; such Appellants first giving or causing to be given Six Days Notice at the least in Writing, of their or his, or her Intention to bring such Appeal, and of the Matter thereof, to the Clerk to the said Trustees, and within Four Days next after such Notice given entering into Recognizance, before some Justice of the Peace for the said County of Derby, with Two sufficient Sureties conditioned to try such Appeal, and to abide the Order of the said Justices at fuch Quarter Sessions, and to pay such Costs as shall be awarded by the Justices at such Quarter Sessions; and the said Justices at such Sessions, or at some Adjournment thereof, upon due Proof of the Notice having been given, and of the entering into Recognizance in Manner herein-before mentioned, shall hear and finally determine the Causes and Matters of every such Appeal in a summary Way, and shall award fuch Costs to the Parties appealing or appealed against, as they the said Justices shall think proper; and the Determination of the said Justices at fuch Sessions or Adjournment, shall be final, binding, and conclusive.

LXXII. And be it further enacted, That the said Trustees or any mile stones to Five or more of them, shall cause the said Roads to be measured, and be set up, etc. Stones or Posts to be set up in or near the Sides of the said Roads, at the Distance of One Mile from each other, denoting the Distance of every Stone or Post from any Town or Place; and also such and so many Direction Posts às to the said Trustees or any Five or more of them shall seem meet; and if any Person shall wilfully pull up or damage any such Posts or Stones, or shall obliterate or deface any of the Letters, Figures, or Marks which shall be inscribed thereon, or if any Person shall ride upon any Footway adjoining to the said Roads, or shall drive any Horse or other Cattle, or any Swine, or any Cart or other Carriage, or any Wheelbarrow thereon, or shall cause any Damage to be done to such Footway; or if any Person shall hale or draw, or cause to be haled or drawn upon any Part of the said Roads, any Tree or Piece of Timber, or any Stone, otherwise than upon wheeled Carriages, or shall suffer any Part of any Tree, or Piece of Timber or Stone which shall be carried upon wheeled Carriages to drag upon any Part of the said Roads, to the Prejudice thereof respectively, or shall lay any Hay, Straw, or other Matter or Thing upon any Part of the said Roads to be made into Manure, or shall scrape off the same any Mud, Soil, or other Matter or Thing which shall be or lie upon any Part of the said Roads, with an Iron Rake or other Instrument with sharp Points, or shall pull or force up

any Stones or other Part of the Pavement of the said Roads, whereby the said Roads or any of them shall be damaged, or shall lay down any Timber, Hay, Straw, Dung, or any other Matter or Thing whatfoever upon the said Roads or any Part thereof, or shall otherwise obstruct or impede the Passage upon the said Roads, or shall turn out any Horses, Mares, Cows, or other Cattle, or Swine, upon the Roads hereby to be repaired, or any Part thereof, or in the Ditches adjoining the same, every Person so offending shall forfeit any Sum not exceeding Forty Shillings nor less than Ten Shillings, to be levied and recovered by such Ways and Means as are herein directed with respect to other Penalties and Forseitures hereby inflicted.

For compel-

LXXIII. And be it further enacted, That if any Person or Persons ling Witnesses shall be summoned as a Witness or Witnesses to give Evidence before any Justice of the Peace touching any Matter of Fact contained in any Information or Complaint for any Offence against this Act, either on the Part of the Prosecutor, or the Person or Persons accused; or if any Person or Persons shall be summoned as a Witness or Witnesses to give Evidence at any General Quarter Sessions of the Peace for the said County of Derby, or any Adjournment thereof, upon any Appeal by virtue of this Act, either upon the Part of the Appellant or Respondent, and any such Person or Persons respectively shall refuse or neglect to appear at the Time and Place to be for that Purpose appointed, without a reasonable Excuse for his, her, or their Resulal or Neglect, or appearing shall resule to be examined upon Oath, and to give Evidence before such Justice of the Peace, or at such Sessions or Adjournment thereof, then and in either of the said Cases, every such Person shall forfeit for every such Offence any Sum not exceeding Five Pounds.

Penalties how to be levied and applied.

LXXIV. And be it further enacted, That all Penalties, Forfeitures, and Fines hereby inflicted or authorized to be imposed, if the Manner of lexying and Recovery thereof is not herein otherwise directed, upon Proof of the Offences respectively before any One Justice of the Peace of the County or Place wherein the Offence shall be committed, or any Justice of the Peace of the County or Place wherein the Offender shall reside, either by Confession of the Party or Parties offending, or by the Oath of One or more credible Witness or Witnesses (which Oath such Justice is hereby empowered and required to administer, without Fee or Reward), shall be levied by Distress and Sale of the Goods and Chattels of the Party or Parties offending, by Warrant or Warrants under the Hand and Seal of such Justice, which Warrant or Warrants such Justice is hereby empowered to grant for those Purposes; and the Overplus, after such Penalties, Forfeitures, and Fines, and the Charges of such Distress and Sale, are recovered and deducted, shall be returned upon Demand unto the Owner or Owners of fuch Goods and Chattels, and the Penalties, Forfeitures, and Fines, when paid or recovered, shall be, if not otherwise directed to be applied by this Act from Time to Time paid, Half to the Informer, and Half to any Five or more of the faid Trustees, or to their Treasurer or Clerk, and applied in the Repair of the said Roads; and in case sufficient Distress shall not be found, or such Penalties or Forfeitures shall not be forthwith paid, it shall be lawful for any One Justice of the Peace as aforesaid, and he is hereby authorized

and required, by Warrant or Warrants under his Hand and Seal, to cause such Offender or Offenders to be committed to the Common Gaol or House of Correction of the County or Place wherein the Offender shall reside, there to remain, without Bail or Mainprize, for any Time not exceeding Three Calendar Months, unless such Penalties, Forfeitures, and Fines, and all reasonable Charges shall be sooner paid and fatisfied.

LXXV. And be it further enacted, That no Proceeding of the said Trustees, or of any Justice or Justices of the Peace, or any of them re-Schedule of spectively, touching or concerning, or in Execution of any Power or 13 Geo. 3. tobe Authority vested in such Trustees, or Justice or Justices respectively, by this Act, shall be quashed or vacated for want of Form, or be removed by Certiorari, or any other Writ or Process whatsoever, into any of His Majesty's Courts of Record at Westminster, or any other Court of Record in the Kingdom of Great Britain, any Law or Statute to the contrary notwithstanding.

LXXVI. And be it further enacted, That no Action or Suit shall be Limitation of commenced against any Person or Persons, for any Thing done in pursuance Actions. of this Act, until Fourteen Days Notice thereof, in Writing be given to the Clerk or Clerks, Treasurer or Treasurers to the said Trustees, or after a sufficient Satisfaction or Tender thereof hath been made to the Party or Parties aggrieved, or after Three Calendar Months next after the Fact committed; and every such Action shall be laid in the County of Derby, and not elsewhere; and the Defendant or Defendants in every such Action or Suit, shall and may plead at his Election, specially or the General Issue, and give this Act or the special Matter in Evidence at any Trial to be had thereupon, and that the same was done in pursuance and by the Authority of this Act; and if the same shall appear to have been so done, or that fuch Action or Suit shall be brought before Fourteen Days Notice shall be thereof given as aforesaid, or after a sufficient Satisfaction made or tendered as aforesaid, or after the Time limited for bringing the same as aforesaid, or shall be brought elsewhere than in the said County of Derby then the Jury shall find for the Defendant or Defendants, and upon such Verdict, or if the Plaintiff or Plaintiffs shall be nonsuited, or discontinue his, her, or their Action or Actions after the Defendant or Defendants shall have appeared, or if upon Demurrer, Judgement shall be given against the Plaintiff or Plaintiffs, then the Defendant or Defendants shall and may recover Treble Costs, and have such Remedy for the same, as any Defendant or Defendants hath or have in other Cases by Law.

LXXVII. And be it further enacted, That all Orders and Proceedings Orders and of the faid Trustees shall be made and entered in a Book or Books to be of Trustees to kept for that Purpose, and signed by a competent Number of Trustees, beentered. and such Orders and Proceedings, so entered and signed by the said Trustees at any Meeting of Five or more of them the said Trustees, shall be deemed and taken to be original Orders; which said Book or Books, and also the said Book to be directed to be kept for registering the Mortgages and Assignments herein-before mentioned, shall and may be read in Evidence in all Cases of Appeal, and in all Suits or Actions touching any Thing done in pursuance of this Act.

Commencement and Duration of the Act. LXXVIII. And be it further enacted, That this Act shall commence and have Continuance from the Thirteenth Day of April One thousand eight hundred and three, for and during the Term of Twenty-one Years, and from thence to the End of the then next Session of Parliament.

Publick Act.

LXXIX. And be it further enacted, That this Act shall be adjudged, deemed, and taken to be a publick Act; and be judicially taken Notice of by all Judges, Justices, and other Persons whatsoever, without specially pleading the same.
