## Cap. II3.

An Act for altering and enlarging the Powers of an Act, made in the Forty-third Year of His present Majesty, for the further Improvement of the Port of London, by making Docks and other Works at Blackwall, for the Accommodation of the East India Shipping in the said Port.

[12th July 1806.]

THEREAS by an Act, made in the Forty-third Year of the Reign of His present Majesty, intituled, An Act for the further 43 G.3. Improvement of the Port of London, by making Docks and other c.126. Works at Blackwall, for the Accommodation of the East India Shipping in the said Port, certain Persons therein named, and their several and respective Successors, Executors, Administrators, and Assigns, were united into a Company or Association of Proprietors, by the Style and Firm of The East India Dock Company, for the Purpose of making the said Docks, Basons, and other Works, and for otherwise carrying the several Powers and Authorities of the said Act into Execution: And whereas the said Company of Proprietors have proceeded in the Execution of the said recited Act, but for the more effectual Execution of the Intention of the said recited Act, and for rendering greater Accommodation to the East India Company and to their Shipping, it is expedient that certain of the Powers and Provisions of the said recited Act should be altered and enlarged, and that the [Lac. & Per] 25 M

said East India Dock Company should have Power to increase their Capital or Joint Stock: And whereas it would be attended with great Benefit to the Interest of the Owners of the East India Shipping, and of the East India Company, and be the Means of preventing the Plunder or Pillage not only of their actores and Corpoes somethiely, but allo de private Property. A se East Suche Dock Company were permitted not only to receive the laid Dacks, Basons, and other Works, the Confoes of the homeward-bound Ships, but also to land med Cargoes en the Wharfs and Quays to be built along the Sides or Banks of luch Docks, Basons, and other Works, and were permitted to load from their Wharfs and Quays within the said Docks, Basons, and other Works, the several Goods. and Stores on board the outward-bound Ships, and to do all such Matters and Things as may be necessary for the Convenience and Accommodation of the East India Shipping; and if the said Quays and Wharfs, so to be made and built by the said Company of Proprietors, were declared to be Legal Quays and Wharfs for the landing, relanding and discharging, lading and shipping of Goods, Wares, and Merchandize, and if the faid East India Dock Company were enabled to employ the Means necessary for landing, loading, moving, and removing all such Goods, Wares, and Merchandize, and also the Stores, and other Articles and Things belonging to the said Shipping: But as such several Purposes cannot be effected without the Aid and Authority of Parliament: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same. That the said recited Act, and all and every the Clauses, Powers, Exemptions, Rules, Remedies, Regulations, Penalties, Forfestures, Articles, Matters, and Things whatsoever therein contained (lave and except luch Parts of the same as are hereby varied, altered, or repealed), shall be and the same is and are hereby declared to be in full Force and Effect, and shall be as good, valid, and effectual, for carrying the several Purposes of this Act into Execution. in as full, ample, and beneficial a Manner, to all Intents and Purposes whatsoever, as if the same were repeated and re-enacted in the Body of this present Act. 

Powers of 43 G. 3. C. 126. extended to this Act.

Part of prefent Act for holding Geneholding General Meetings repealed, and other Days appointed.

II. And be it further enacted. That so much of the said recited Act as requires that Two General Meetings of the said Company of Proprietors should be holden in each and every Year, whereof One Meeting should be holden on the Second Monday in the Month of July, in each and every Year, shall be and the same is hereby repealed; and, from and after the passing of this Act, such Two General Meetings of the said Company of Proprietors shall be holden. One thereof on some Day in the Month of January, and the other on some Day in the Month of July, in each and every Year; and of such respective General Meetings Seven Days Notice shall be given by Publication in the London Gazette, and in Two or more Morning News, papers usually circulated in the City of London, and by Writing affixed in the Royal Exchange in London; and all Matters and Things directed to be done and executed by the said recited Act, at such respective General Meetings to be holden on the Second Mondays in the said respective Months of January and July, shall and may be holden, and shall and may

be done and executed on any Day within the Months respectively in which fuch Meetings are by the said recited Act required to be holden, and such Matters and Things directed to be done and executed.

III. Provided always, and be it enacted, That it shall and may be lawful to and for any Five or more of the said Directors of the East India Dock Meeting, Company, when and as often as they shall judge it expedient or necessary that a General Meeting of the said Company should be holden for carrying any of the Purposes of the said recited Act or of this Act into Execution, to call such General Meeting, by giving Notice thereof in Writing to be affixed on the Royal Exchange in London, and by inserting such Notice in the London Gazette, and in Two or more Morning Newspapers circulated in London, and such General Meeting shall be holden at such Time and Place, within the City of London, as they the said Directors, giving such Notice, shall judge expedient, such Time not being more than Ten Days, nor less than Five, after such Notices so given; and every such Notice shall specify the Purpose or Purposes for which such Meeting is to be holden; and such Meeting shall be, and be deemed to be, a General Meeting of the said East India Dock Company; and all Proceedings thereat, relative to the Purpole or Purpoles specified in such Notices, shall be and be deemed to be good, valid, and effectual, to all Intents and Purposes whatfoever.

And be it further enacted, That, for the better and more effectual carrying into Execution the several Purposes of the said recited Act and this Act, it shall and may be lawful to and for the said Company of Pro- Joint Stockprietors, at any extraordinary General Meeting or Meetings to be especially called for that Purpose, in Manner by the said recited Act or this Act directed, to increase and augment the Capital or Joint Stock, which by the said recited Act they are enabled to raise, with any further Sum of Money not exceeding One hundred thousand Pounds, as to the Majority of the Proprietors present at such Meeting or Meetings shall be deemed necessary and expedient; and it shall and may be lawful to and for the faid Company of Proprietors to raise such further Sum of One hundred thousand Pounds, or any Part thereof, by Contribution amongst themselves, or by the Admission of any new Subscriber or Subscribers, or by such other Ways and Means as to the Majority of the Proprietors present at fuch Meeting or Meetings shall seem right and proper.

VII. And be it further enacted, That no Assignment or Transfer of any of the said Capital Stock shall be permitted to be made or entered into the Transfer Books of the said East India Dock Company, of or concerning any smaller Sum of the Capital Stock of the said Company heretofore subscribed, or hereaster to be subscribed as aforesaid, than Fifty Pounds thereof; and every Assignment or Transfer of such Capital Stock. which shall or may at any Time or Times hereafter be made for any less Sum of the said Capital Stock than Fifty Pounds, shall be and is hereby declared to be null and void to all Intents and Purpoles what soever; any Thing in the said recited Act, made in the Forty-third Year of the Reign of His present Majesty to the contrary thereof in anywise notwithstanding.

And whereas the Directors of the said East India Dock Company, were by the said recited Act empowered to make such Bridges and Roads. as they should from Time to Time deem necessary for the more convenient Use of the said Docks, and of the other Works appertaining thereto: And whereas by an Act, made in the Forty-fourth Year of the Reign of His present Majesty, intituled. An Act for alwring and enlarging the Term and Powers of an Act, made in the Forty-second Year of His present Majesty, for making, maintaining, weathbridg, lighting, and watering several Koads to communicate with the West India Docks, in the Me of Dogs, in the County of Middletex, and elso of several Acts for repairing the Cannon Street Road, in the said County; and also for making, maintaining, watching, lighting, and watering, a new Branch to communicate with the East India Docks, the Trustees acting in Execution of the said recited Acts, and the several Subscribers under the said recited Act, made in the Forty-second Wear of the Reign of His present Majesty, were enabled to raise and contribute amongst themselves, in such Shares and Proportions as to them bould seem meet, or to raise by the Admission of new Subscribers the Sum of Twenty thousand Pounds for the Purpose of making, repairing, altering, widening, lighting, watching, paying, and, watering a Branch of Road leading from and out of the Commercial Road. at or near the North-East Corner of Limehouse Church Yard, to communicate with the East India Docks, and also leading from and out of Robinbood. And be it further enacted, That it shall and may be lawful to and for all Bodies Politick, Corporate, or Collegiate, Corporations Aggregate or Sole, and all Feoffees in Trust, Executors, Administrators, Husbands, Guardians, Committees for Lunaticks or Idiots, or other Trustees whomsoever, not only for or on Behalf of themselves, their Heirs and Successors, but also for and on Behalf of their Cestuique Trucks; whether Infants or Issue unborn, Lunaticks, Idiots, or Femes Covert, who are or shall be seised in their own Right, and to and for all and every Person and Persons whomsoever, who are or shall be seised, possessed of, or interested in such Lands, Tenements, or Hereditaments, or any Part or Parts thereof which shall be thought necessary by the said Company of Proprietors, or their Directors, to be purchased for any of the Purposes of the said recited Act, made in the Forty-third Year of the Reign of His present Majesty, or of this Act, to treat, contract, and agree with the said Directors for the Sale thereof, or of any Part or Parts thereof, and to sell and convey all or any Part or Parts thereof, and all Estate, Right, Title, and Interest whatsoever, of, in, and to the same, to the said Company of Proprietors, for any of the Purposes of the said recited Act or of this Act; and all Contracts, Agreements, Bargains, Sales, and Conveyances, which shall be so made by virtue and in pursuance of the faid recited Act and this Act, shall, without any Fine or Fines, Recovery or Recoveries, be good, valid, and effectual to all Intents and Purposes whatsoever, not only to convey the Estate and Interest of the Persons or Person conveying, but also to convey all Right, Estate, Interest, Use, Property, Claim, and Demand whatsoever of their several and re-

And be it further enacted, That in Consideration of the Costs, Charges, and Expences of making and maintaining such Wharfs and Quays, and of employing Labourers and Workmen, and for carrying and conveying such Goods, Wares, Merchandize, Stores, Articles, Matters. and Things, to or from the said Docks, Basons, and other Works, it shall and may be lawful to and for the said East India Dock Company to demand and take, or cause to be demanded and taken, to and for their own Use and Benefit, such Rate or Rates, or Sum or Sums of Money, for the Wharfage, and for carrying or conveying such Goods, Wares, Merchandize, Stores, or other Matters or Things, or any of them, to or from the said Docks and Busons, or for any other Service as shall be required by the East India Company, or the Owners of the East India Shipping, for the Accommodation or Convenience of the said Shipping, as shall be mutually agreed upon between the said Company of Proprietors, or their Directors, and the Proprietor or Proprietors of such Goods, Wares, Merchandize, Stores, or other Articles, Matters, or Things, or the said East India Company, or the Owners of the East India Shipping.

XXXVIII. Provided

XXXVIII. Provided also, and be it enacted, That nothing herein contained shall extend or be construed to extend so as to require or compel any Body or Bodies Politic or Corporate, or any Person or Persons whatsoever, to employ the faid Company of Proprietors in carrying or conveying Goods, Wares, Merchandize, Stores, or other Articles, Matters, or Things, or any of them, to or from the said Docks, Basons, and other Works, but it shall and may be lawful to and for every such Body Politic or Corporate, and every Person whomsoever, to carry and convey his, her, and their Goods, Wares, Merchandize, Stores, Articles, Matters and Things, to and out of and from the said Docks, and Basons, in such and the like Manner, as he, she, or they would be enabled or empowered to carry or convey the same, or any of them, out of such Docks and Basons, in case this Act had not been made: Provided always, that nothing herein contained shall authorize any Person or Persons to use the Wharfs or Quays of the said East India Dock Company, without paying the accustomed Rate for Wharfage.

Persons not to be compelled to emoloy the East India Dock Company in conveying Goods, &c.

XXXIX. And be it further enacted, That all Rates and Sums of Rates how to Money hereby granted or allowed to be taken, by or for the Use of the and applied. East India Dock Company, shall be payable, received, and recovered, in the Manner specified in the said recited Act of the Forty-third Year of the Reign of His present Majesty, and that all such Rates and Sums of Money as shall be collected or received by the said East India Dock Company, by virtue of this Act, shall be applied and disposed of in Manner directed by the said recited Act, made in the Forty-third Year of the Reign of His present Majesty, and this Act, for carrying the several Purposes of the said recited Act and this Act into Execution.

XL. And whereas, by reason or in consequence of certain Parts of the compensa-Works, Improvements, and Regulations, intended by the said recited Act, made in the Forty-third Year of the Reign of His present Majesty, and this Act, some of the Lighters and Craft employed in the Business of the faid East India Company, which belong to Individuals, may become less valuable, by Means of the landing and shipping of the Cargoes of East India Ships being in part diverted, than the same respectively are at present, and divers Owners of such Lighters and Craft employed as aforesaid, and other Persons interested or employed in the Business of landing and shipping such Cargoes of homeward and outward-bound East India Shipping, may thereby sustain Loss or Damage, and the Yearly aud other Receipts of the Governors of Christ's Hospital, in the City of London, for or on Account of Car-roons or Figures for using Free Carts within the said City and the Liberties thereof, may also thereby happen to be lessened; be it therefore further enacted, That in case such Lighters and Craft employed as aforefaid, or any of them, shall by reason of the said intended Account of Works or any of them, be rendered less valuable by reason or means of Car-room. the Business of landing or shipping of the Cargoes of East India Ships being diverted therefrom, than they respectively were before the passing of this Act, or any Lightermen, Tackle House Porters, Ticket Porters, or Free Carmen of the City of London, or other Person or Persons interested in or employed upon the Business of landing or shipping of East India Cargoes, shall, by reason of any of the same Works, suffer Loss or Damage, or the yearly or other Receipts or Income of the Governors of Christ's Hospital aforesaid, or of their Successors for or on Account of Car-roons, shall, by reason of any of the same Works, happen to be lessened or diminished, [Loc. 5 Per.] the

the Commissioners appointed or to be appointed as herein after mentioned for managing the Business of the Compensations authorized and r quired to be made by them, do and shall make or cause to be made fuch just and liberal Compensation or Satisfaction, by Purchase or by Employment, or otherwise, to the Owners of Lighters and Craft, and the Tackle House Porters, Ticket Porters, Free Carmen, and other Persons interested in or employed upon the Business of landing or shipping of East India Cargoes, and to the Governors of Christ's Hospital aforesaid, or their Successors, for the Injury, Loss, or Damage, which such Owners of Lighters and Craft, Porters, Carmen, and other Persons, and Governors respectively, shall have thereby suffered or sustained, as shall be agreed on between the said Commissioners and such respective Owners of Lighters and Craft, and other Persons interested or employed as aforesaid, or between the faid Commissioners and Governors, so far as relates to the said Car-rooms.

XLI. And whereas by an Act passed in the Thirty-ninth Year of the Reign of His present Majesty, intituled, An Act for rendering more commodious, and for better regulating the Port of London, certain Persons were appointed Commissioners for managing the Business of the Compensations directed to be made by the said Act; be it therefore enacted, That the Commissioners of Compensations appointed in, or to be appointed by virtue of the said Act, shall be the Commissioners to settle and determine the Compensations to be made under this Act, and shall have the same Powers and Authorities for putting in Execution this Act, with respect to the Compensations hereby directed to be made, as they have by the said former Act with respect to the Compensations thereby directed to be made; and the respective Parts of the said Act, and all and every the Clauses. XLII. And be it further enacted, That no Claim shall be received or admitted by the said Commissioners for any Compensation, until after the Expiration of Three Years next after any Rate granted or made payable by virtue of this Act, for or in respect of any Ship or Vessel entering into or using any of the Docks or Basons to be made by virtue of this Act, shall have been taken; and the seid Directors shall, and they are hereby ready soi vie. required to cause Notice to be given in the London Gazette, and Two or

more publick Newspapers usually circulated in London of the Day on which such Rate shall have been taken, within the Space of Fourteen Days after the Day on which such Rate shall have been taken; and all and every Bodies and Body Politick, Corporate, and Collegiate, Corporations Aggregate and Sole, and other Persons and Person whosoever, who shall deem himself, herself, or themselves, entitled to any such Compensation, shall, within One Year after the Expiration of the said Three Years, enter a Memorial or Memorials of such their respective Claims in a Book to be for that Purpose prepared and kept by the Clerk of the said Commissioners, which Book the said Clerk is hereby required to prepare and keep accordingly, and for which Entry fuch Clerk shall be entitled to fuch Fee and no other, as the Register of the County of Middlesex is by the Law entitled to for the Registry of a Memorial containing the same Number of Words; and that in case any Body Politic, Corporate, or Collegiate, Corporation Aggregate or Sole, or other Person or Persons whosoever, shall refuse or neglect to enter or cause to be entered such Memorial or Memorials of fuch his, her, or their Claim or Claims in Manner aforesaid, within One Year next ensuing the Expiration of the faid Term of Three Years, then and in every fuch Case all and every such Bodies and Body Politic, Corporate and Collegiate, Corporations Aggregate or Sole, and other Person and Persons whomsoever, so refusing or neglecting to enter fuch Memorial or Memorials in Manner and within the Time aforesaid, shall be, and is and are hereby declared to be barred and excluded from all Right and Title to any fuch Compensation or Compenfations whatsoever, under or by virtue of this Act, any Thing herein contained to the contrary thereof in anywife notwithstanding: Provided nevertheless, that if any Person or Persons entitled to, or who might claim any fuch Compensation, shall be absent from the United Kingdom of Great Britain and Ireland during the Whole of the said One Year, and there shall not be any Person in the said United Kingdom duly empowered to act for him, her, or them in that Behalf, then and in every such Case it shall and may be lawful to and for the Person or Persons so being or having been absent to enter a Memorial or Memorials of his, her, or their Claim or Claims in Manner aforesaid, at any Time within Iwo Years next ensuing after the Expiration of the said Term of Three Years, or in Default thereof such Person and Persons shall be, and is and are hereby declared to be in like Manner barred and excluded from all Right and Title to any fuch Compensation under or by virtue of this Act.

XLIII. Provided always, and be it enacted, That nothing herein con- Claimants' tained shall extend or be construed to extend so as to hinder or prevent Compensa ion any Person or Persons whomsoever, so as aforesaid barred of any Right, iviency from Title, Claim or Demand, of or to any fuch Compensation, from com- have wrongmencing or bringing an Action cr Actions of Debt, or for Money had fully received and received for his, her, or their Use, against any Person or Persons, the same. or the legal Representatives of the Person or Persons who shall have received all or any Part of the Compensation Money to which the Person or Persons so barred might have been entitled, if he, she, or they had claimed and proceeded as aforesaid in due Time; and that in every such Case the respective Plaintiffs, on due Proof of his, her, or their Right and Title to any such Money, shall recover the same, with legal Interest in respect thereof, from the Person or Persons so receiving such Compensation Money, or from his, her, or their legal Representatives.

XLIV. Provided always, and be it further enacted, That none of the Directors not faid Directors of the East India Dock Company already appointed and ally answers. hereafter ble for acts

legally done by them in the Capacity of Directors. hereafter to be appointed by virtue of the said recited Act, made in the Forty-third Year of the Reign of His present Majesty, or of this Act, or either of them, shall, by reason or means or on account of their or his being Parties or Party to, or making, signing, or executing in their or his Capacity of Directors or Director for managing the Affairs and Bufiness of the said East India Dock Company pursuant to the said recited Acts made in the Forty-third Year of the Reign of His present Majesty, and this Act or either of them, any Contract, Covenant, Agreement, Affignment, or Security, for and on the Behalf of the said East India Dock Company, or otherwise lawfully executing any of the Powers and Authorities given to them or any of them, by the said recited Act, made in the Forty-third Year of the Reign of His present Majesty, and this Act, or either of them, be subject or liable to be sued, prosecuted, or impleaded, either collectively or individually, by any Person or Persons whomsoever, in any Court or Courts of Law or Equity, or elsewhere; and that the Bodies or Body, Goods, Chattels, Lands, or Tenements of the said Directors, or any of them, shall not, by reason, on account, or in consequence of any such Contract, Covenant, Agreement, Assignment, or Security so entered into, or made, signed, or executed by them, or any of them, as aforesaid, or any other lawful Act or Acts done or to be done by them, or any of them, in the Execution of any of the same last-mentioned Powers and Authorities, be liable to be arrested, seized, detained, or taken in Execution, but that in every fuch Case, any Person or Persons making Claim or Demand upon the faid Company, or upon any Director or Directors thereof, under or by virtue of any such Contract, Covenant, Agreement, Assignment, or Security, or other lawful Act or Acts, shall and may fue and implead the said East India Dock Company in the Name of their Secretary, as provided by the said recited Act, made in the Forty-third Year of the Reign of His present Majesty, in like Manner as if such Contract, Covenant, Agreement, Assignment, or Security had been entered into and executed by fuch Secretary, for and on Behalf of the said East India Dock Company, or such other Act or Acts had been done by him; and the Party or Parties so suing or impleading shall be entitled to the same Remedies as are provided in and by the said recited Act, made in the Forty-third Year of the Reign of His present Majesty, in Cases where Authority is thereby given to sue and implead the said Company in the Name of the Secretary, but not to any further or other Remedy whatfoever.

Costs of the Act.

XLV. And be it further enected, That the said Directors shall pay and discharge all the Costs and Charges of obtaining and passing this Act, out of any of the Monies already subscribed, borrowed, or received, or to be subscribed, borrowed, or received, by virtue or in pursuance of the said recited Act, made in the Forty-third Year of the Reign of His present Marjesty, and of this Act, or either of them.

Publick Act.

XLVI. And be it further enacted, That this Act shall be deemed and taken to be a Publick Act, and shall be judicially taken Notice of as such by all Judges, Justices, and others, without being specially pleaded.
