An Act to enable the several Persons therein named to dispose of several Houses in Pickett Street Temple Bar in the Parish of Saint Clement Danes in the County of Middlesex, and in Skinner Street Snow Hill, and on Snow Hill and in Fleet Market, in the Parish of Saint Sepulchre in the City of London, by Lottery.

[3d July 1806.]

HEREAS by virtue of several Acts, one made in the Thirtyfifth Year of the Reign of His present Majesty, intituled An
Act for widening and improving the Entrance into the City of
London near Temple Bar, for making a more commodious Street or Passage
at Snow Hill, and for raising on the Credit of the Orphans Fund a Sum of
Money for those Purposes; and another made in the Thirty-eighth Year of
the Reign of His present Majesty, intituled An Act to explain, amend, 38G.3.c.61.
and enlarge the Powers of an Act, passed in the Thirty-fifth Year of the Reign
of His present Majesty, intituled An Act for widening and improving the
Entrance into the City of London near Temple Bar, for making a more
commodious Street or Passage at Snow Hill, and for raising on the Credit
of the Orphans Fund a Sum of Money for those Purposes; and another
made in the Thirty-ninth and Fortieth Years of the Reign of His present

An Act for raising an additional Sum of Money for carrying into Execution several Acts for widening the Entrance into the City of London near Temple Ban, for making a more commodious Street at Snow Hill, and for raising on the Gredit of the Orphans Fund certain Sums of Money for those Purposes, and also for enlarging the Powers of the said Acts; the Mayor, Aldermen, and Commons of the City of London, in Common Council assembled. have purchased certain Messuages, Lands, Tenements, and Hereditaments therein mentioned or referred to, for the several Purposes of the said Acts: And whereas the said Mayor, Aldermen, and Commons, in Common Council assembled, have granted and agreed to grant certain Lands and Scites of Houses purchased by them in pursuance of the said recited Acts, on Leases for Terms of Years, for the Purpose of erecting Buildings thereon, the Particulars whereof are mentioned and set forth in the First Schedule to this Act annexed: And whereas the several Persons to whom such Lands and Scites of Houses have been demised and agreed to be demised by the said Mayor, Aldermen, and Commons, in Common Council assembled, or the Persons claiming under them, have effected many great and expensive Buildings thereon: And whereas the said several Persons trave employed great Numbers of Workmen and Artists in erecting the said Buildings, and have expended great Sums of Money, and several of them have contracted large Debts in bringing the said Buildings to the Degree of Perfection in which they now are, and have borrowed considerable Sums of Money on the Security of the said Buildings; all which Securities are particularly mentioned in the Second Schedule to this Act annexed; and it will yet require considerable Sums of Money to finish and complete the same: And whereas, by reason of the Magnitude of the said Buildings, and the heavy Ground Rents payable for the same, such Buildings cannot be let to advantage, nor can they be disposed of by the common Mode of Sale; and unless the several Leaseholders, whose Names are contained in the Third Schedule to this Act annexed, are, under the Sanction of Parliament, enabled to dispose of the Property comprized in the Fourth, Fifth, and Sixth Schedules to this Act annexed, to the best Athantage, the Improvements intended to be made near Temple Bar and at Snow Hill, which are of considerable Importance to the Metropolis, cannot be completed, and the Monies borrowed upon the Credit of the said Buildings, and other the Debts contracted by the said Leaseholders, cannot be discharged: And whereas the

the said Mayor, Aldermen, and Commons, in Common Council assembled, are, by the aforesaid Acts, or some or one of them, authorized to sell or dispose of the Fee Simple and Inheritance of the said Buildings and Ground, subject to the aforesaid Leases, to such Person or Persons as shall be willing to purchase the same; and it being found that the said Buildings could not, for the Reasons herein-before mentioned, be let or sold to Advantage by the several Persons to whom they were respectively demised, or in whom the same respectively are now vested, the said Mayor, Aldermen, and Commons, in Common Council assembled, agreed to concur in the Sale of the Fee Simple and Inheritance of the same, and of such Part of the said Ground as is still uncovered, discharged of the Leases and Agreements for Leases to which the Persons whose Names are contained in the Third Schedule to this Act annexed are now entitled: And in order to facilitate the Application to Parliament for this present Act, the Mayor and Commonalty and Citizens of the City of London have duly conveyed or limited the Fee Simple and Inheritance of and in the said Buildings and uncovered Ground, with their Rights, Members, and Appurtenances, discharged of Land Tax, but subject to the Leases and Agreements for Leases therein mentioned (being the same Leases and Agreements for Leases as are specified in the First Schedule to this Act annexed), unto or to the Use of the Right Honourable James Shaw, Lord Mayor of the City of London, Sir John William Anderson Baronet, and Harvey Christian Combe Esquire, Aldermen of the said City of London, John Silvester Esquire, Recorder of the said City, and Newman Knowlys Esquire, Common Serjeant of the said City, their Heirs and Assigns, upon the Trust nevertheless and for the Intents and Purposes therein declared of the same, and herein-after mentioned, (that is to say), In the meantime and until this present Act should have been passed into a Law, or in case the same should not pass into a Law during the present Session of Parliament, then and in either of these Cases in Trust for the said Mayor and Commonalty and Citizens, their Successors and Assigns; and in case this Act should be passed into a Law during the present Session of Parliament, then from and after the passing of the same, upon Trust for the Purposes thereof; and in case the said Act should be passed into a Law during the present Session of Parliament, but all the said Messuages and other Hereditaments should not be sold by way of Lottery or Chance as aforesaid, then as to all such and so many of the same as should not be sold, in Trust for the said Mayor and Commonalty and Citizens, their Successors and Assigns, and that the same should be re-conveyed unto them accordingly: And it was by the said Indenture now in recital declared, that it should and might be lawful to and for the said James Shaw, Sir John William Anderson, Harvey Christian Combe, John Silvester, and Newman Knowlys, and the Survivors and Survivor of them. and other the Trustees or Trustee to be appointed in the Place or Stead of them or any of them, under or by virtue of any Power or Authority to be for that Purpose contained in this present Act, to join and concur in all Acts necessary and expedient to be made, done, and executed, in order to obtain this present Act, and to carry the Powers and Authorities hereby to be granted into Execution, in the same Manner, to all Intents and Purposes, as the said Mayor, Aldermen, and Commons, in Common Council assembled, might or could do if the said Indenture now in recital had not been executed: Now in order that the aforesaid Buildings and Improvements may be completed according to the original Plan, and that the Powers to

the said Buildings may be disposed of to the best Advantage, so that the said Persons whose Names are contained in the Third Schedule annexed to this Act may not be materially injured by their Endeavours to execute the Improvements sanctioned by the Legislature, and that the Monies charged by them on the said Buildings, and other the Debts incurred by them, may be speedily paid: May it please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That it shall and may be lawful to and for the said James Shaw, Sir John William Anderson, Harvey Christian Combe, John Silvester, and Newman Knowlys, and the Survivors and Survivor of them, and the several Persons whose Names are contained in the Second and Third Schedules to this Act annexed, their respective Executors, Administrators, and Assigns, and they are hereby authorized and empowered, to sell and dispose of the Buildings, Hereditaments, and Premises specified in the Fourth, Fifth, and Sixth Schedules to this Act annexed, by way of Lottery or Chance, in Three several and distinct Lotteries, without being liable or subject to any Penalty or Forfeiture imposed by any Act or Acts of Parliament against any Sale or Sales by way of Lottery, or Tickets, Numbers, or Figures, or upon any Person or Persons for opening, setting up, exercising, or keeping an Office without Licence for buying, selling, or disposing of, or otherwise dealing in Tickets by way of Lottery, or by any other Act or Acts of Parliament whatsoever; and that such Sale or Sales so to be made by the said James Shaw, Sir John William Anderson, Harvey Christian Combe, John Silvester, and Newman Knowlys, or the Survivors or Survivor of them, and the said several Persons whose Names are contained in the Second and Third Schedules to this Act annexed, their respective Executors, Administrators, or Assigns, of the said Buildings, Hereditaments, and Premises (subject only to the Conditions, Provisoes, and Restrictions herein-after contained) shall be good and valid, any Law or Statute to the contrary notwithstanding.

Notices to be given in the Gazette, &c. of the Intention to sell, and a List of the Prizes to be published.

VI. And be it further enacted, That the said James Shaw, Sir John William Anderson, Harvey Christian Combe, John Silvester, and Newman Knowlys, or the Survivors or Survivor of them, shall, Forty Days at the least previously to every or any One of the said Lotteries being drawn, and before any Ticket, Number, or Figure shall be sold or disposed of, for or in respect of such Lotteries respectively, under or in pursuance of this Act, and they or he are and is hereby required to give Notice in the London Gazette of the Intention to sell and dispose of the Buildings and Hereditaments to be comprised in each and every of the said Lotteries respectively, under and in pursuance of the Conditions, Provisoes, and Restrictions herein contained, and shall also from Time to Time publish, in Two or more of the London Daily Newspapers, a List of the specific Buildings to be allotted as Prizes to the Holders of each and every of the fortunate Tickets in every such Lottery respectively, and shall particularly specify in every such List the Underleases and Charges (if any) to which the same respectively shall then be subject or liable.

And be it further enacted, That immediately upon and after every or any such Notice being given in the London Gazette as aforesaid, under and in pursuance of this Act, the Right and Property of the several Persons whose Names are contained in the Second and Third Schedules to this Act annexed, their respective Executors, Administrators, and Assigns, of and in such of the said Buildings and Hereditaments as are to be comprised in the Lottery, of which such previous Notice shall have been given as aforesaid, shall from Time to Time, by force of this present Act, be vested in and settled upon the Trustees or Trustee for the Time being of this Act, their or his Heirs and Assigns, so and in such Manner that they or he shall and may stand and be seised of the Fee Simple and Inheritance of and in the same, freed and absolutely acquitted and discharged of and from the several Leases and Incumbrances specified in the Fourth, Fifth, and Sixth Schedules to this Act annexed, in Trust nevertheless for the said Mayor and Commonalty and Citizens of the City of London, their Successors and Assigns, and the several Persons whose Names are contained in the Second and Third Schedules to this Act annexed, their respective Executors, Administrators, and Assigns, according to their respective Estates, Rights, and Interests therein, till the Determination of the Chances by the drawing of every or any such Lottery respectively; and immediately after the drawing of the same respectively, in Trust for the respective Holders of the fortunate Tickets, as to the Prizes allotted to every such Ticket respectively; and the said Buildings and Hereditaments shall thenceforth be freed and absolutely acquitted and discharged by the said Mayor and Commonalty and Citizens, their Successors and Assigns, and the said several Persons whose Names are contained in the Second and Third Schedules to this Act annexed, their respective Executors or Administrators, (the said Parties respectively being answerable for their and his own Incumbrances only,) against all Conveyances, Sales, Judgments, Executions, Titles, Charges, Debts, and Incumbrances whatsoever, by them or any of them respectively made, done, or committed (save only the Underleases which are specified in the Fourth, Fifth, and Sixth Schedules to this Act annexed); and the same Buildings and Hereditaments shall become the Property of, and be conveyed free of Charge to the Bearers of the said Tickets respectively, who shall be entitled to the Rents payable for their respective Prizes from the last Quarterly Day of Payment thereof preceding the drawing of such Prizes respectively;

Provided always, and be it further enacted, That the said Buildmay be deter- ings and Hereditaments shall be divided and allotted into Sixty-nine mined by the Prizes in the Manner specified in the Fourth, Fifth, and Sixth Schedules to this Act annexed; and the Prizes comprised in each and every of the Three Lotteries so authorized to be drawn as aforesaid shall respectively be determined by the drawing of any State Lotteries that shall be drawn within this Kingdom between the First Day of October One thousand eight hundred and six, and the Thirty-first Day of December One thousand eight hundred and eight, in pursuance of any Act or Acts of Parliament that may hereafter be passed for that Purpose; and Notice shall be given by the said James Shaw, Sir John William Anderson, Harvey Christian Combe, John Silvester, and Newman Knowlys, or the Survivors or Survivor of them, and such other Person or Persons as shall or may be appointed under and in pursuance of this Act, or the Survivors or Survivor of them, in the London Gazette, Forty Days before the drawing of any such State Lottery, of the Intention to determine any of the said Three Lotteries by the drawing of any such State Lottery; and that the First Tickets which shall be drawn in such State Lottery (be they either Blank or Prize), the Numbers whereof shall respectively correspond with any Number of the Tickets of such Lotteries authorized by this Act respectively, shall be, and they are hereby declared to be, the Prizes in the Lotteries respectively authorized by this Act, in the Order in which the said Buildings and Hereditaments are divided and allotted in the Fourth, Fifth, and Sixth Schedules to this Act annexed.

First Lottery may be determined by a separate Lottery in Guildhall.

XII. Provided always, and be it further enacted, That in case the said Mayor, Aldermen, and Commons, in Common Council assembled, shall be desirous to have a separate Lottery for the Determination of the First of the said Three Lotteries authorized to be drawn by this Act, instead of having the same Lottery determined by the drawing of any such State Lottery as aforesaid, and the Lords Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, shall approve thereof, and give their Consent thereto in Writing, then and in every such Case it shall be lawful for the said James Shaw, Sir John William Anderson, Harvey Christian Combe, John Silvester, and Newman Knowlys, and the Survivors or Survivor of them, and such other Person or Persons as shall or may be appointed under or in pursuance of this Act, and they and he are and is hereby authorized and empowered and required, from Time to Time, before the Twenty-fifth Day of March next, to put all the Tickets to be comprised in such First Lottery as last aforesaid into a Wheel, in like Manner as if the same were a State Lottery, and to cause as many Numbers as there are Prizes in such First Lottery as last aforesaid to be drawn thereout for the Prizes therein, at or in the Guildhall of the City of London, on such Day or Days, and at such Time or Times, and under and subject to such Regulations as the said Lords Commissioners of

His

His Majesty's Treasury, or any Three or more of them, shall approve and direct, and so and in such Manner that the same may be drawn and conducted in such or the like Manner as the State Lotteries of this Kingdom are usually drawn and conducted, or as near thereto as existing Circumstances will permit: Provided nevertheless, that in case the said First Lottery shall be drawn separately as aforesaid, then and in such Case Notice thereof shall be given in the London Gazette by the Space of Forty Days at the least previously to the drawing of such First Lottery.
