An Act for more effectually repairing the Roads from Wendover to the End of Oak Lane, and from the River Colne, for Half a Mile, towards Beaconsfield, in the County of Bucks. [20th March 1812.]

THEREAS an Act was passed in the Seventh Year of the Reign of His late Majesty King George the First incimal. of His late Majesty King George the First, intituled An Ast for 7 G. r. c. 24. repairing the Road from Wendover to the Town of Buckingham, in the County of Bucks: And whereas another Act was passed in the Fif- 15 G. 2. c. 5. teenth Year of the Reign of His late Majesty King George the Second, intituled An AET for continuing and making more effectual an AEt made in the Seventh Year of the Reign of His late Majesty King George the First, intituled ' An Act for repairing the Road from Wendover to the Town of Buck-· ingham, in the County of Bucks; and for building a Bridge at Padbury, · and making it a County Bridge:' And whereas another Act was passed in 24G.2.c.32. the Twenty-fourth Year of the Reign of His said late Majesty King George the Second, intituled An Act for enlarging the Term and Powers granted by Two Acts of Parliament, for repairing the Road from Wendover to the Town of Buckingham, in the County of Bucks; and also for repairing and widening the Road leading from the West End of the said Town of Wendover to the End of a Lane called Oak Lane, next the great Road called The Oxford Road, lying between the Town of Beaconsfield in the said County of Bucks, and Uxbridge in the County of Middlesex, and that Part of the said great Road which leads from the West End of the said Town of Beaconsfield to the River Coine, near Uxbridge aforesaid: And whereas another Act was 17G.3.c.82. Loc. & Per.

That Trustees have proceeded in the Execution of Acts, as to these Roads; and borrowed Money, &c.

New Term and Tolls to be liable to Debt, &c.

passed in the Seventeenth Year of the Reign of His present Majesty, intituled An Act for enlarging the Term and Powers of Three several Acts of Parliament for repairing the Roads therein mentioned, in the County of Bucks, so far as the said Acts relate to the Road from the West End of the Town of Wendover to the End of a Lane called Oak Lane, next the great Road called The Oxford Road, and also Half a Mile of Road next from the River Colne towards Beaconsfield, in the said County: And whereas the Trustees for carrying into Execution the laid several Acts, so far as they relate to the said Road from the West End of the said Town of Wendover to the End of Oak Lane aforesaid, and the said Half Mile of Road next from the said. River Colne towards Beaconsfield aforelaid, have, in pursuance of the Powers and Trusts vested in them, borrowed considerable Sums of Money on the Credit of the Tolls authorized to be taken on the said last-mentioned Roads, the greater Part of which Money still remains due, and cannot be repaid, neither can the same Roads be essectually improved, and kept in good Repair, unless additional Tolls, Powers, and Authorities be granted for a further Term: And it would be convenient that all the Tolls, Powers, and Provisions necessary to be granted and continued in force with respect to the same Roads, should be consolidated and comprised in One Act of Parliament: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, Former Acts That on the Day of the Commencement of this Act the said Acts of the repealed as to Seventh Year of the Reign of His said late Majesty King George the First, the Fifteenth and Twenty-fourth Years of the Reign of His said late Majesty King George the Second, and the Seventeenth Year of the Reign of His present Majesty, so far only as they severally relate to or concern the said Road from the West End of Wendover to the End of Oak Lane aforefaid, and also the said Half Male of Road next from the River Colne towards Beaconsfield aforesaid, shall be and the same are hereby declared to be re-Except, &c. pealed, (except so far and during such Time as the existing Tolls and Ex. emptions are herein-after directed to continue in force); and that this ACL, and the Tolls hereby granted, shall be and are hereby made subject and liable to the Payment of all Monies which are now due and owing on the Credit of the Tolis authorized to be taken by the said recited Acts or any of them, on the said last-mentioned Roads; and to the Payment of all Monies which shall or may hereafter be borrowed, and become due and owing by virtue of this Act, and of all Interest due and to grow due for the lame respectively.

III. And be it further enacted, That when any of the Trustees named Power to apin, or to be elected by virtue of this Act, shall die or refuse to act, it shall point new be lawful for the surviving or remaining Trustees, or any Seven or more Trustees. of them, at any Meeting to be held by virtue of this Act, (whereof at least Twenty-one Days Notice in Writing shall have been given upon all the Toll Gates erected or to be erected on the said Roads hereby intended to be repaired), by Writing under their Hands, to elect one other Person to be a Trustee in the room of every or any Trustee so dying or refusing to act; and every Person so elected, (being qualified as by this Act is required), shall from thenceforth have the like Powers and Authorities to act as a Trustee in the Execution of this Act, as if he had been named and appointed a Trustee in and by this Act.

And be it further enacted, That all Acts and Proceedings relative All Acts may to the Execution of this Act may be done and executed by any Five or bedone by more of the Trustees hereby appointed, and to be elected and appointed Trustees, unas aforesaid; except only in the Cases herein-after mentioned as requiring directed. a greater or less Number of them.

V. And be it further enacted, That no Person shall be capable of acting Qualification as a Trustee in the Execution of this Act unless he shall at the Time of of Trustees. acting be seised in his own Right, or in the Right of his Wife, and be in the actual l'ossession or Receipt of the Rents and Profits of Freehold or Copyhold Messuages, Lands, Tenements, Tythes or Hereditaments, of the clear yearly Value of One hundred Pounds above Reprises; or shall be Heir apparent of a Person seised of Messuages, Lands, Tenements, Tythes or Hereditaments for some Estate of Freehold or Inheritance in Possession, of the clear yearly Value of Three hundred Pounds above Reprifes.

Provided always, and be it further enacted, That no Person shall Persons holdbe capable of acting as a Trustee in the Execution of this Act, in any ing Places of Matter wherein he shall be personally interested, nor during the Time he shall hold any Place of Profit under this Act; nor shall any Victualler, or tees, &c. Retailer of Ale, Beer or Spirituous Liquors, or any menial Servant of any Trustee, be capable of holding any Place of Profit under this Act.

VII. And be it further enacted, That if any Person hereby declared Penalty for incapable of acting as a Trustee in the Execution of this Act, shall pre-acting as a sume to act therein, every such Person shall, for every such Offence, forfeit Trustee not and pay the Sum of Fifty Pounds to any Person or Persons who shall sue fied. for the same in any of His Majesty's Courts of Record, by Action of Debt, or on the Case, wherein no Essoign, Protection or Wager of Law, or more than One Imparlance, shall be allowed; and the Person so prose-

cuted shall prove that he is qualified as aforesaid, or otherwise shall pay the said Penalty, upon Proof being given of his having acted as a Trustee in the Execution of this Act.

VIII. Provided always, and be it further enacted, That all Acts and Proceedings which shall have been done by any such Person, touching the Execution of this Act, previous to his being convicted of the Offence before mentioned, shall, notwithstanding such Conviction, be as valid and effectual, as if such Person had been qualified according to the Directions of this Act.

First Meeting IX. And be it further enacted, That the said Trustees shall meet toof Trustees, gether at the Griffin Inn, or some other House in Amersham, in the said County of Buckingham, on Monday the Twenty-fifth Day of May One thousand eight hundred and twelve, or as soon after as conveniently may be, between the Hours of Ten of the Clock in the Forenoon and Two of the Clock in the Afternoon, and shall then and there proceed to the Execution of this Act; and shall adjourn themselves from Time to Time, and afterwards meet there, or at any other Place on or near the said Roads hereby intended to be repaired, at luch Time or Times as the said Trustees shall order, direct and appoint, as often as it shall be necessary for putting this Act in Execution; but nevertheless, Two Trustees shall be sufficient for the Purpose of Adjournment only; and that in case a competent Number of Trustees shall not appear at any Time and Place appointed for a Meetsing of the Trustees for putting this Act in Execution, either to act or to adjourn to any other Time, or in case the Trustees at any Time assembled Thall not adjourn themselves, then and in either of the said Cases, it shall be lawful for the Clerk or Treasurer to the said Trustees for the Time being, to appoint a Meeting of the said Trustees, to be holden at the same Place where the last Meeting was held or was appointed to have been held, on some future Day, not exceeding Three Calendar Months next after the Day on which such last Meeting was held or was appointed to have been held as aforesaid; and the said Clerk or Treasurer shall give Notice thereof in Writing, by affixing the same on all the Toll Gates then erected on the said Roads, or by inserting the same in some Newspaper circulated in the Neighbourhood of the said Roads, at least Seven Days before such future Meeting; and in case neither the Clerk nor Treasurer shall give such Notice as aforesaid, it shall be lawful for any Three of the said Trustees, although not assembled at a Meeting, by Notice in Writing under their Hands, to be affixed or inserted in Manner aforesaid, to appoint the Trustees to meet at some House on or near the said Roads, upon some Day not exceeding Four Weeks from the Time of affixing or inserting such lastmentioned Notice; and that the said Trustees shall, at all their Meetings, defray their own Expences.

Méetings on Emergencies.

X. And be it further enacted, That if after any such Adjournment of the said Trustees, it shall be thought necessary that they should meet at an earlier Day than the Day appointed by such Adjournment, in that Case the Clerk to the said Tsussees, upon an Order in Writing, signed by Three or more of them, although not assembled at a Meeting, mentioning the Time, Place and Purpose of such Meeting, shall forthwith give Notice, in the Manner herein-before directed, of the Time, Place and Purpose of such Meeting as mentioned in such Order, (such Time not being less than Five

Five Days after such Notice), and such earlier Meeting shall and may be held accordingly; and the Proceedings of the Trustees at all such Meetings as aforesaid, shall be as good, valid and effectual, as they would have been in case such Meetings had been held in pursuance of Adjournments.

XI. And he it further enacted, That all Orders and Determinations of Orders of the said Trustees, shall be made at Meetings to be held in pursuance of this Act, and not otherwise, and shall be entered in a Book or Books to be kept for that Purpose (except herein otherwise particularly directed,) and that no Order or Determination shall be made, unless the major Part of the Trustees present at any Meeting shall concur therein; and such Oidees and Proceedings to entered, and figned by a competent Number of the said Trustees, (as the Case may require), or by their Clerk by their Order, shall be deemed to be original Orders and Proceedings; and the Books to be said Book or Books, and also the Book or Books herein-after directed to be kept for registering Mostgages and Assignments of Tolls, and true examined Copies thereof, signed by the Clerk to the said Trustees, shall and may respectively be read in Evidence in Cases of Appeal, and in all Suits or Actions touching any Thing done or to be done in pursuance of this Act.

XII. Provided always, and be it further enacted, That no Order made Orders not to by the said Trustees, shall be revoked or altered at any subsequent Meeting, unless by a Majority of Trustees at a Meeting where Seven at least tain Number shall be present, and Five of them shall concer therein.

XIII. And be it further enacted, That all such Trustees as are Justices Trustees beof the Peace, may act as Justices in the Execution of this Act, notwith. ing Justices standing their being Trustees, except only in such Cases where they shall such, &c. be personally interested; and that no Person possessed of or entitled to any Mortgage or other Security upon the Tolls granted by this Act, shall on such Account only be disqualified from acting as a Trustee.

XIV. And be it further enacted, That it shall be lawful for the said Trustees may Trustees at their First or any subsequent Meeting, as Occasion shall require, appoint Officers, and to elect, and by Writing under their Hands to appoint a Clerk or Clerks, remove their, and a Treasurer or Treasurers, Receiver or Receivers, Collector or Col-&c. lectors of the Tolls and Monies which shall be due and payable by virtue of this Act; and also One or more fit Person or Persons to be Surveyor or Surveyors of the said Roads, and such other Officer or Officers as the said Trustees shall think proper, and from Time to Time to remove such Clerks, Treasurers, Collectors, Receivers, Surveyors and other Officers, or any of them, as they shall see Occasion, and to elect and appoint others in the room of such of them as shall be removed, or shall die; and out of the Monies to be raised or received by virtue of this Act, to pay and allow to the several Clerks, Treasurers, Collectors, Receivers, Surveyors and other Officers so elected and appointed, and to such other Persons as shall assist them, or any of them, in and about the Execution of this Act, such Salaries, Rewards and Allowances, for their Attendance, Care, Labour and Service, as to the said Trustees shall seem reasonable and proper; and every such Officer and Person as hath been appointed by virtue of the said recited Acts, or shall be appointed by virtue of this Act, shall from Time to Time when thereunto required by the said Trustees, by Writing under their Hands, make out and deliver to such Trustees, or to such Person or [Loc. & Per.] Perlons

Persons as they shall for that Purpose appoint, a true and perfect Account in Writing under his or her Hand, of all Monies which shall have been by him or her had, collected or received, and how and to whom and for what Purpole the same and every Part thereof hath been disposed of, together with the Vouchers and Receipts for such Payments; and shall verify fuch Account upon Oath, if thereunto required by the faid Trustres, (which Oath any One of the laid Trustees is hereby empowered to administer); and every such Officer and Person shall and is hereby required to pay all Such Monies as upon the Balance of such Account, shall appear to be owing from him or her to such Person or Persons as the said Trustees shall appoint to receive the same; and if any such Officer or Person shall refuse or neglect to render and give such Account as aforesaid, or to produce and deliver up the Vouchers and Receipts relating to the same, or to verify the Articles thereof upon Oath, or to pay the Balance remaining in his or her Hands, when thereunto required in Manner aforesaid; or if any such Officer or Person shall refuse or neglect to deliver up to the said Trustees, or to such Person or Persons as they shall direct or appoint, within Ten Days after being thereunto required by the said Trustees, or by such other Person or Persons, all Books, Papers and Writings in his or her Custody or Power, relating to the Execution of the said recited Acts or of this Act; then and in every such Case, Complaint being made by the said Trustees of any such Neglect or Refusal, to any Justice of the Peace for the County or Place where the Officer or Person so neglecting or refusing shall live or reside, such Justice may and is hereby authorized and required, by Warrant under his Hand and Seal, to cause such Officer or Person to be brought before him, and upon his or her appearing, or not being to be found, to hear and determine the Matter of such Complaint in a summary Way, and to settle the said Account or Accounts, if produced, in such Manner as the faid Trustees might have done; and if upon the Confession of the Ossicer or Person against whom such Complaint shall be made, or by the Oath or Oaths of any Witness or Witnesses, it shall appear to the said Justice that any of the Monies which shall have been collected or received, shall be in the Hands of such Officer or Person, such Justice may and is hereby authorized and empowered, upon Non-payment thereof, by a Warrant or Warrants under his Hand and Seal, to cause such Monies to be levied by Distress and Sale of the Goods and Chattels of such Officer or Person respectively; and if no Goods or Chattels can be found sufficient to answer and fatisfy the faid Monies, and the Charges of taking and making fuch Distress, and of selling the same; or if such Officer or Person shall not appear before the said Justice at the Time and Place appointed for that Purpose, or if appearing shall refuse or neglect to make out and deliver to the said Justice such Account in Writing as aforesaid, or to verify the same on Oath as aforesaid, if so required by the said Justice, or to produce and deliver up to the said Justice the several Vouchers and Receipts relating to luch Account, or to deliver up all such Books, Papers and Writings as aforesaid, then and in either of the Cases aforesaid, the said Justice may and is hereby authorized and required, by a Warrant or Warrants under his Hand and Seal, to commit fuch Officer or Person to the Common Gaol or House of Correction of the County, Town, or Place where he or she shall live or reside, there to remain without Bail or Mainprize until he or she shall have delivered in and settled his or her Account, and have verified the same on Oath, and shall have delivered up the Vouchers and Receipts relating thereto, and shall have paid all the Monies which shall appear to DC.

XVI. And be it further enacted, That each and every Clerk, Trea-Old Officers surer, Receiver, Collector, Surveyor and other Officer appointed under and by virtue of the said recited Acts, or any of them, for or in respect of till new ones the said Roads hereby intended to be repaired, shall hold and enjoy their several and respective Offices and Employments under this Act, until removed therefrom by the said Trustees; and each and every such Clerk, Treasurer, Receiver, Collector, Surveyor and other Officer shall have the like Power and Authority for carrying this Act into Execution, and shall be subject and liable to the like Pains and Penalties, and to the like Power of Removal, and to the like Rules and Regulations in all Respects whatsoever as if he had been elected by virtue of this Act.

XVII. And be it further enacted, That the said Trustees shall and they Treasurer, are hereby authorized, directed and required to take such Security from &c. to give the Treasurer or Treasurers, Receiver or Receivers, and Collector or Collectors appointed by virtue of the said recited Acts, or to be elected and appointed by virtue of this Act, for the due Execution of their Offices respectively, as the said Trustees shall think proper.

XVIII. And be it further enacted, That when and as often as any Re- Collectors ceiver or Collector of the Tolls by this Act granted, shall neglect to per- making Deform, or be incapable of performing his or her Duty, or shall abscond or absent himself or herself, any Two or more of the said Trustees (although not assembled at a Meeting of the said Trustees appointed by virtue of this Order of Act), may discharge such Receiver or Collector so neglecting or being incapable of performing his or her Duty, or absconding or absenting himself or herself; and in such Case, and also in case any Receiver or Collector pointed till of the Tolls shall die, the said Trustees, or any Two or more of them, though not assembled at a Meeting, shall and may nominate and appoint a Receiver or Collector of the said Tolls, to continue until the then next Meeting of the said Trustees, instead of such Receiver or Collector as shall die or be so discharged; and such Person so nominated and appointed shall have the like Power and Authority, and be answerable and accountable in the same Manner in all Respects as the Person who shall die or be so discharged would have had and been subject to; and if any Receiver or Collector of the said Tolls who shall be discharged from his or her Office by

virtue of this Act, or his Wife, Child or Children, or Fimily, or the Widow, or any of the Children, Family or other Representative or Representatives of any Receiver or Collector who shall die, or any other Person shall refuse to deliver up the Possession of any Toil Gate or Toll House, or any of the Appurtenances thereof, for the Space of Seven Days next after Demand thereof made, and Notice in Writing for that Purpose given or left at such Toll Gate or Toll House, under the Hands of any Two or more of the said Trustees, (although not assembled at a Meeting), or under the Hand of their Clerk or Treasurer for the Time being; then and in any of the said Cases it shall be lawful for any Justice or Justices of the Peace for the said County, by Warrant under his or their Hand and Seal, or Hands and Seals, to order any Constable or other Peace Officer, with such Assistance as shall be necessary, to enter such House and Appurtenances in the Day-time, and to remove the Person or Persons who shall be found therein, or in Possession of the said Gate, together with his, her or their Goods, out of and from the same, and to put the said. Trustees, or any One of them, or such new-appointed Receiver or Collector into the Possession of fuch Toll House, Toll Gate and Appurtenances.

Trustees may fue and be fued in the Name of their Trea-furer or Clerk.

XIX. And be it further enacted, That the said Trustees may sue and prosecute, and be sued for and concerning any Thing which shall be done by virtue or in pursuance of this Act, in the Name of their Treasurer or Clerk for the Time being; and that no Action or Suit to be brought or commenced by the Direction of or against the said Trustees, by virtue of this Act, in the Name of their Treasurer or Clerk, shall abate or be discontinued by the Death or Removal of any Treasurer or Clerk, nor by the Act of such Treasurer or Clerk, without the Consent of the said Trustees at a Meeting held in pursuance of this Act; but that the Treasurer or Clerk for the Time being to the said Trustees shall be deemed to be the Plaintiff or Defendant, as the Case may be, in every such Action: Provided always, that every such Treasurer or Clerk, in whose Name any Action or Suit shall be commenced, prosecuted or desended, in pursuance of this Act, shall be fully indemnissed, reimbursed and paid, out of the Monies to arise by virtue of this Act, all such Costs, Damages and Expences, as by the Event or in consequence of any such Action or Proceedings, he shall pay, bear, expend, or be put unto or become chargeable with, for or by reason of his being so made Plaintiff or Desendant as aforesaid.

Trustees may continue or remove Toll Gates, and erect new ones, &c.

XX. And be it further enacted, That the said Trustees shall and may, as they may think proper, continue or remove all or any of the Toll Houses, Toll Gates and Weighing Machines erected on the said Roads, hereby intended to be repaired, by virtue of the said recited Acts, or any of them, and erect and set up, or cause to be erected and set up, any other Toll Gate or Gates, Weighing Machine, or Weighing Machines, in or upon or across the said Roads hereby intended to be repaired, or either of them, or any Part thereof; and also any Toll House or Toll Houses, with suitable Outbuildings and Conveniences at or near each Toll Gate and Weighing Machine, or either of them, and may from Time to Time afterwards remove, alter or discontinue the same, or any of them, as the said Trustees shall think expedient.

XXI. And be it further enacted, That it shall be lawful for the said Side Gates or Trustees, or any Five or more of them, to erect, or cause to be erected, Bars may be One or more Gate or Gates, Turnpike or Turnpikes, Bar or Bars, Chain or Chains, on the Side or Sides of the said Roads, and across any public Lane or Way leading out of the same, and there to receive and take any fuch Tolls as are by this Act granted and made payable, so that the same do not extend to a Double Charge, in case of passing through any other of the Toll Gates or Turnpikes upon the said Roads.

XXII. And be it further enacted. That the Right and Property in all the Toll Gates, Toll Houses, and Weighing Machines, and the several Conveniences and Appurtenances thereto belonging, which are already Trustees, who erected, set up, or made upon the said Roads, or which shall be erected, may sue, &c. or other Beast in or upon any Part of the said Roads, every Person so offending in any of the Cases atoresaid. shall for every such Offence forseit and pay any Sum not exceeding Five Pounds.

Surveyors to remove An-noyances.

XLV. And be it further enacted, That it shall be lawful for the said Surveyor and Surveyors, and such Person or Persons as he or they shall appoint, from Time to Time, to remove and prevent all Nuisances and Annoyances on any Part or Parts of the said Roads, by Timber, Wood, Stone, Carriages, Saw-pits or other Pits, Trees, Ashes, Dung, Filth, Rubbish, Straw or otherwise; and to turn any Watercourses, Gutters, Conduits or Drains running into, along or out of the said Roads, to the Prejudice thereof; and to open, scour or cleanse, widen, deepen and enlarge any Gutter, Ditch, Conduit or Watercourse adjoining or near to the said Roads, or any Part or Parts thereof respectively; and also to prune or lop, at proper Seasons of the Year, any Trees, Branches, Shrubs, or Bushes growing in the Hedges or Fences adjoining the said Roads, so as the same be not planted for Ornament or Shelter, and, to take and carry away the Prunings or Loppings thereof, or in case the respective Owners or Occupiers of the Lands where such Annoyances shall happen to be, shall neglect so to do for Five Days after Notice in Writing given for that Purpose under the Hand or Hands of such Surveyor or Surveyors, the Charges whereof to be settled by the said Trustees by Writing under their Hands, shall from Time to Time be reimbursed to the said Surveyor or Surveyors by fuch respective Owners or Occupiers neglecting to turn, open, scour or cleanse, or to deepen, widen and enlarge any such Gutter, Ditch, Conduit, Drain or Watercourse, or to prune or lop such Trees, Branches, Shrubs or Bushes, or by the Person or Persons occasioning or neglecting or refusing to remove such Annoyances as aforesaid; which Charges shall be levied and recovered in the same Manner as the Penalties, Forteitures and Fines by this Act inflicted or authoriz deto be imposed are herein-after directed to-be levied and recovered; and if after the Removal of any such Annoyances, any Person or Persons shall offend again in like Manner, every such Person shall for every such Second or subsequent Offence sorfeit and pay any Sum not exceeding Five Pounds.

And be it further enacted, That no Action or Suit shall be commenced or brought against any Person or Persons for any Thing done or alledged to be done in pursuance of this Act, until Fourteen Days Notice shall be given to the Clerk or Treasurer to the said Trustees, nor after a sufficient Satisfaction, or Tender thereof, hath been made to the morafter Party or Parties aggrieved, nor after Three Calendar Months next after the Fact committed; and every such Action shall be brought, laid and Months, &c. tried in the said County of Buckingham, and not elsewhere; and the Defendant or Defendants in every such Action or Suit shall and may plead the General Issue, and give this Act and the Special Matter in Evidence at any Trial to be had thereupon, and that the same was done in pursuance and by the Authority of this Act; and if it shall appear that the same was To done, or that such Action or Suit was brought before Fourteen Days Notice thereof had been given as aforefaid, or after sufficient Satisfaction made or tendered as aforelaid, or after the Time hereby limited for bringing the lame, or in any other County, then the Jury shall find for the Defendant or Defendants; and upon such Verdict, or if the Plaintiff or Plaintiffs shall be nonsuited, or discontinue his, her, or their Action or Suit, after the Defendant or Defendants shall have appeared, or if upon Demurrer Judgment shall be given against the Plaintiff or Plaintiffs, then the Defendant or Defendants shall and may recover Treble Costs, and have such Remedy for recovering the same as any Defendant or Defendants hath or have for his, her, or their Costs in any other Case of Law.

LXXIV. And

LXXIV. And be it further enacted, That all Penalties, Forfeitures and Penalties and Fines hereby inflicted or authorized to be imposed, (the Manner of levying and recovering whereof is not herein otherwise directed), shall upon Proof how to be recovered and of the Offences respectively before any One Justice of the Peace for the applied. County or Place wherein the Offence shall be committed, or wherein the Offender shall be and reside, either by Confession of the Party or Parties offending, or by the Oath of One or more credible Witness or Witnesses, be levied by Distress and Sale of the Goods and Chattels of the Party or Parties offending, by Warrant under the Hand and Seal of such Justice. which Warrant such Justice is hereby empowered and required to grant for those Purposes; and the Overplus, after such Penalties, Forfeitures, and Fines, and the Charges of such Distress and Sale are levied, shall be returned upon Demand unto the Owner or Owners of Juch Goods and Chattels; and the Penalties, Forfeitures, and Fines, when so levied, (if not otherwise directed to be applied by this Act), shall be from Time to Time paid to the Treasurer of the said Trustees, and applied to the Purpuses of this Act; and in case sufficient Distress shall not be found, and such Penalties, Forseitures, or Fines shall not be forthwith paid, it shall be lawful for any One Justice of the Peace as aforesaid, and he is hereby authorized and required by Warrant or Warrants under his Hand and Seal, to cause such Offender or Offenders to be committed to the Common Gaol or House of Correction of such County or Place, there to remain without Bail or Mainprize for any Time not exceeding Three Calendar Months, unless such Penalties, Forfeitures, or Fines, and all reasonable Charges shall be sooner paid and satisfied.

Forfeitures

LXXV. Provided always, and be it further enacted, That if any Person Persons agshall think himself or herself aggrieved, and to have Cause of Complaint grieved may by any Thing done in pursuance of this Act, and for which no particular Method of Relief hath been herein-before appointed, such Person may sous.

Appeal to the Justices at the General Quarter Sessions of the Peace to be holden for the County or Place wherein the Cause of Complaint shall arise, within Four Calendar Months next after the Cause of Complaint shall have arisen, such Appellant first giving or causing to be given Fourteen Days Notice at least in Writing, of his, her, or their Intention to bring such Appeal, and of the Matter thereof, to the Clerk or Treasurer of the said Trustees, and within Four Days after such Notice entering into a Recognizance before some Justice of the Peace for such County or Place, with Two sufficient Sureties, conditioned to try such Appeal, and abide by the Order of, and pay such Costs as shall be awarded by the said Justices at such Quarter Sessions; and the said Justices at such Sessions, upon due Proof of such Notice being given as aforesaid, and of the entering into fuch Recognizance, shall hear and finally determine the Cause and Matter of such Appeal in a summary Way, and may award such Costs to the Parties appealing or appealed against, as they the said Justices shall think proper; and the Determination of such Quarter Sessions shall be final, binding, and conclusive to all Intents and Purposes.

LXXVI. And be it further enacted, That this Act shall be deemed and Public Act. taken to be a Public Act, and shall be judicially taken Notice of as such, by all Judges, Justices, and others, without being specially pleaded.

Gommencement and Duration of Act. LXXVII. And be it further enacted, That this Act shall commence and take Effect upon the Twenty-fourth Day of May, in the present Year of our Lord One thousand eight hundred and twelve, and shall be in Force and have Continuance until the Twenty-fourth Day of May which will be in the Year of our Lord One thousand eight hundred and Thirty-three, and from thence to the End of the then next Session of Parliament.
