An Act to amend an Act of the last Session of Parliament, for the better repairing the several Roads leading into and from the City of *Worcester*.

[23d May 1817.]

WHEREAS an Act was made in the last Session of Parliament, ^{56 Geo. 3. c. 46.} intituled *An Act for the better repairing the several Roads leading into and from the City of Worcester*: And whereas it was by the said Act enacted, that on every *Sunday* during the Continuance of the said recited Act there should, under the Provisions and Restrictions in the said Act contained, be demanded and taken at the Toll Gates respectively (except at the *London* and *Upton* Gates) as thereafter mentioned, by such Person or Persons to be nominated and appointed in the Manner directed by the said Act, One Half of the respective Tolls thereby granted, except upon every Horse not drawing, which should pay Twopence: And whereas it was intended by the said Act, that an additional Toll of One Half of the Tolls thereby granted should be demanded and taken on a *Sunday*, except as therein excepted: And whereas it will tend greatly to the improvement of the said Roads, if the said Act was amended; may it therefore please Your Majesty, that it may be enacted, and be it enacted by the King's most excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That from and after the passing of this Act, there shall on every *Sunday* during the Continuance of the said recited Act be demanded and taken at the Toll-Gates continued or erected, or hereafter to be erected, by virtue of the said recited Act, (except at the said *London* and *Upton* Gates, as is thereafter mentioned,) by such Person or Persons nominated and appointed by virtue of the said recited Act, or hereafter to

II. Provided always, and be it further enacted, That it shall not be lawful for the said Trustees to appoint the Person who may be appointed to act as their Clerk in the Execution of the said Act and this Act, or the Partner of any such Clerk, the Treasurer for the Purposes of the said Act and this Act; or to appoint the Person who may be appointed Treasurer, or the Partner of any such Treasurer, the Clerk to the said Trustees for executing the said Act and this Act; and if any Person shall act in both the Capacities of Clerk and Treasurer for the Purposes of the said Act and this Act, or if any Person, being the Partner of any such Clerk, shall act as Treasurer, or being the Partner of any such Treasurer shall act as Clerk in the Execution of the said Act and this Act, every Person shall, for every such Offence, forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same; to be recovered in any of His Majesty's Courts of Record at *Westminster*, by Action of Debt or on the Case, or by Bill, Suit, or Information, wherein no Effoign, Protection, or Wager of Law, nor more than One Imparlance shall be allowed.

III. And be it further enacted, That the Charges and Expences of procuring and passing this Act shall be paid out of the Tolls granted by this and the said Act.

IV. And be it further enacted, That this Act shall be deemed and taken to be a Public Act, and shall be judicially taken Notice of as such by all Judges, Justices, and others, without being specially pleaded.

Provided always, and be it further enacted, That it shall not be lawful for the said Trustees to appoint the Person who may be appointed to act as their Clerk in the Execution of the said Act and this Act, or the Partner of any such Clerk, the Treasurer for the Purposes of the said Act and this Act; or to appoint the Person who may be appointed Treasurer, or the Partner of any such Treasurer, the Clerk to the said Trustees for executing the said Act and this Act; and if any Person shall act in both the Capacities of Clerk and Treasurer for the Purposes of the said Act and this Act, or if any Person, being the Partner of any such Clerk, shall act as Treasurer, or being the Partner of any such Treasurer shall act as Clerk in the Execution of the said Act and this Act, every Person shall, for every such Offence, forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same; to be recovered in any of His Majesty's Courts of Record at *Westminster*, by Action of Debt or on the Case, or by Bill, Suit, or Information, wherein no Essoign, Protection, or Wager of Law, nor more than One Imparlance shall be allowed.
