# Cap. v.

\* An Act for repairing the Road from the Cross Hands, on the Worcester and Oxford Turnpike Road, to Halford Bridge, and other Roads therein mentioned, in the Counties of Gloucester, Warwick, I7th March 1817. and Worcester.

HEREAS the public Carriage Road leading from the Cross Hands, upon Broad Campden Hill, on the Worcester and Oxford Turnpike Road, through the Town and Parishes of Chipping Campden and Ebrington, in the County of Gloucester, the Parishes of Ilmington in the County of Warwick, and Tredington in the County of Worcester, into the Turnpike Road from Warwick to Stow, near to a Bridge over the River Stour known by the Name of Halford Bridge; and also the public Carriage Road leading from the lower or North end of the Village of Ilmington aforesaid, through the Parishes of Whitchurch in the County of Warwick, and Alderminster in the County of Worcester, . into the Turnpike Road from Stratford on Avon to Oxford, near to the Fourth Mile Stone from Stratford on Avon aforesaid, are in some Parts in a ruinous Condition, and cannot be amended, widened, improved, and kept in good Repair, by the ordinary Course of Law: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That William Bateson, Trustees. John Coventry, the Honourable Thomas Henry Coventry, the Honourable William James Coventry, Michael Corbett, Thomas Corbett, George Cotterell, Robert Cotterell, William Cotterelle, Dugdale Stratford Dugdale, Thomas Eden, William Edens, Thomas Frequell, the Reverend Morgan Graves, John Grant, Sir Benkeley William Guise Baronet, the Reverend John Robert Holly Samuel Hilfory, John Hickman, Thomas Halford, Thomas Stanley Ling William Izod, John Jordan, James Kettle, Sir John Dashwood King Burniet; the Honourable Henry Beauchamp Lygon, the Honourable William Henry Lyttleton, Richard Miles, George Matthews, Sir Charles Mordaunt Baronet, Charles Marshall, Sir Gerard Noel Noel Baronet, the Honourable Charles Noel, the Honourable William Noel, Thomas Phillipps, Thomas Phillipps the younger, Joseph Roberts, the Honourable and Reverend George Rusbout, William Coleman Russell, the Honourable Robert Edward Henry Somerset commonly called Lord Robert Edward Henry Somerset, the Reverend William Spooner, the Reverend John Smith, George Talbot, Gore Townsend, the Reverend Henry Townsend, the Reverend Edward Townsend, John Hathaway Turbitt, the Reverend Samuel Wilson Warnford, James Roberts West, the Reverend Charles White, George Wilkes, Thomas Wynniatt, the Reverend Reginald Wynniatt, and the Reverend Philip Wren, and their Successors, to be elected in manner herein-after mentioned, shall be and they are hereby appointed Trustees for amending, widening, shortening, improving, and keeping in Repair the said Roads herein-before described, and for otherwise putting this Act in Execution.

Power to ap point additional Truftees.

Trustees, or any Five or more of them, at a Meeting to be held for that Purpose (of which Meeting and of the Eurpose thereof Thirty Days Notice shall be given, as is herein-after directed respecting the Appointment of Trustees on Vacancies), to elect, nominate, and appoint any Number of sit and proper Persons, not exceeding Ten, to be Trustees for the Purposes, of this Act, in addition to the Trustees hereby hominated and appointed.

Power to elect other Trustees.

III. And be it further enacted, That when and as often as any of the Trustees hereby appointed or to be elected and appointed in Manne meetin mentioned, shall die, or by Writing under their Hands refuse to act in the Execution of this Act, it shall be lawful for the remaining or surviving. Trustees from Time to Time to elect and appoint One or more fit and proper Person or Persons to be a Trustee or Trustees in the Room of every Trustee or Trustees dying or refusing to act as aforesaid, provided that public Notice of the Time and Place of Meeting of the said Trustees for every such Election be given by the Clerk, to be appointed by the said Trustees as herein-after is mentioned, by affixing the same in Writing upon all the Toll Gates then erected and being upon the said Roads, and by inserting such Notice in One or more of the Newspapers published within the Counties of Gloucester, Warwick, and Worcester, Thirty Days at least before every such Meeting; and every Person who shall be elected and appointed a Trustee or Trustees pursuant to the Directions of this Act, shall and may act with the surviving and remaining Trustees in the Execution of this Act, to all Intents and Purpoles, as if he or they had been named and appointed a Trustee or Trustees in and by this Act.

IV. And be it further enacted, That no Person shall be capable of Qualification. acting as a Trustee in the Execution of this Act, unless he shall be in his of Trustees. own Right, or in the Right of his Wife, in the actual Possession or Enjoyment or Receipt of the Rents and Profits of Messuages, Lands, Tenements, or Hereditaments of the clear yearly Value of One hundred Pounds above Reprizes; or shall be Heir Apparent of a Person so seized of Messuages, Lands, Tenements, or Hereditaments of the clear yearly Value of Two hundred Pounds above Reprizes; or shall be possessed of a clear Personal Estate of the Amount or Value of Three thousand Pounds: and if any Person not being so qualified shall act as a Trustee in the Execution of this Act, every fuch Person shall for every such Offence forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same, to be recovered in any of His Majesty's Courts of Record at Westminster, by Action of Debt or on the Case, or by Bill, Suit, or Information, wherein no Effoign, Protection, or Wager of Law, nor more than one Imparlance, shall be allowed; and every Person so prosecuted shall prove that he is qualified as aforefaid, or otherwise shall pay the said Penalty, upon Proof being given of his having acted as a Trustee in the Execution of this Act; provided nevertheless, that all Acts and Proceedings by any such Person as a Trustee in the Execution of this Act, previous to his being convicted of the said Offence, shall be as valid and effectual as if such Person had been qualified according to the Directions of this Act.

V. Provided also, and be it further enacted, That every Trustee ap- Trustees to pointed or to be elected and appointed by virtue of this Act, before he take an Oath. shall act as such (except in administering the Oath next herein-after mentioned, at the First or Second Meeting of the said Trustees), shall take an Oath before One or more of the said Trustées (who is or are hereby empowered to administer the same) in the Form or to the Effect following; (that is to fay),

B. do swear, That I am in my own Right [or, in the Right of my Wife] truly and bona fide seized or possessed of, and in the actual 'Possession or Receipt of the Rents and Profits of Messuages, Lands, Tenements, or Hereditaments of the clear yearly Value of One hundred 'Pounds above Reprizes; [and in case of an Heir Apparent,] I A. B. do 's fwear, That I am Heir Apparent of C.D. who to the best of my Know-'ledge and Belief is truly and bona fide seized or possessed of, and in the 'actual Possession or Receipt of the Rents and Profits of Messuages. Lands, Tenements, or Hereditaments of the clear yearly Value of Two 'hundred Pounds above Reprizes; [and in the Case of Personal Estate] I A. B. do swear, That I am truly and bona fide possessed of a clear Per-'sonal Estate of the Amount or Value of Three thousand Pounds; and 'that I will truly and faithfully execute the Powers and Trusts reposed in ' me by an Act of Parliament, passed in the Fifty-seventh Year of the Reign of His Majesty King George the Third, intituled [here set forth. . the Title of this Act. So help me GOD.

VI. Provided also, and be it enacted, That no Person shall be capable Trusteees of acting as a Trustee in the Execution of this Act during the Time he places of shall hold any Place of Profit, or shall be interested or concerned in any Profit not Contract, or shall be a Lessee or Farmer of the Tolls under this Act; and to act.

Justices may act in both Characters.

that all such Trustees as are Justices of the Peace may act as Justices of the Peace within their respective Jurisdictions in the Execution of this Act, notwithstanding their being Trustees (except only in Cases where they shall be personally interested); nor shall any Mortgagee, or Assignee of any Mortgage or other Security, nor any Lender of Money upon the Credit of the Tolls granted by this Act, or receiving Interest thereout for the same, be on that Account deemed unqualified to act as a Trustee in the Execution of this Act.

Victuallers not to be Officers, or act as Truftees.

VII. Provided always, and be it enacted, That no Person or Persons who shall keep any Victualling House or other House of public Entertainment, or who shall sell any Wine, Cider, Beer, Ale, Spirituous or other strong Liquors by Retail, shall be capable of acting as a Trustee, or of taking, holding, or enjoying any Place or Places of Trust or Prosit under the said Trustees, or of collecting the Tolls hereby granted and made payable, during fuch Time as he, she, or they, shall keep such Victualling House, Alehouse, or other Place of public Entertainment, or shall sell any Wine, Cider, Beer, Ale, Spirituous or other strong Liquors, by Retail; but no such Person shall be precluded from farming such Tolls, provided he, The, or they employ a Person or Persons to collect such Tolls who shall not be under any fuch Incapacity.

General Meetings of Trustees.

VIII. And be it further enacted, That the said Trustees shall meet at the Noel Arms, in the Town of Chipping Campden, or at some other convenient House or Place in Chipping Campden aforesaid, on the Third Wednest after the passing of this Act, or as soon after as conveniently may be and shall then proceed to carry this Act into Execution; and the said Trustees shall then and from Time to Time afterwards adjourn themselves, and meet at the same Place, or at such other Place upon any of the said Roads, and at fuch Times, as the said Trustees shall from Time to Time order and direct; provided that no Adjournment shall be made for a longer Time than Three Calendar Months; and if, at any Meeting appointed to be held by virtue of this Act, there shall not appear a sufficient Number of Trustees to act, or in case the Trustees at any Meeting assembled shall not adjourn themselves, the Clerk to the said Trustees shall from Time to Time, as often as such Case shall happen, by Notice in Writing to be affixed on all the Toll Gates then erected in, upon, across, or on the sides of the said Roads, and to be inserted in One or more of the Newspapers published and circulated within the Counties of Gloucester, Warwick, and Worcester, at least Fourteen Days before the next intended Meeting, appoint the Trustees to meet at the Place where the last Meeting was appointed to have been held, on that Day Month next after the Day on which such last Meeting was appointed: Provided always, that no Business shall be done or proceeded upon by the said Trustees, at any Meeting to be holden under this Act, before the Hour of Twelve in the Forenoon, nor shall any Adjournment be made, or any Meeting appointed to be held at any later Hour than Four in the Afternoon, of the Day on which such Meeting is appointed to be held.

IX. And be it further enacted, That if after any Adjournment of the Emergencies. said Trustees it shall at any Time be thought necessary that an earlier Day of Meeting should be appointed than the Day appointed by such Adjournment, in that Case the Clerk to the said Trustees, upon an Order in Writ-

ing, figned by Five or more of the said Trustees, mentioning the Time, Place, and Purpose of such Meeting, shall forthwith give Notice thereof in the Manner before directed, and of the Time and Place which shall be mentioned in the Order of the said Trustees (such Meeting not being less than Fourteen Days after such Notice), and such earlier Meeting shall and may be held accordingly; and all the Orders and Determinations of the said Trustees at all such Meetings shall be as valid and effectual as they would have been in case such Meetings had been held in pursuance of Adjournments; and the said Trustees or the Majority of them at all Meetings held in pursuance of this Act are hereby empowered to make all necessary Orders, Determinations, and Agreements in the Execution of this Act; and no such Order, Agreement, or Determination shall be made, unless the Majority of the said Trustees present at such Meeting shall concur therein, such Majority not being less than the Number of Trustees by this Act authorized to make any fuch Order, Agreement, or Determination; and no such Order, Agreement, or Determination shall be revoked or altered at any subsequent Meeting, unless special Notice shall be given at least Fourteen Days before, in some public Newspaper usually circulated in the said Counties, of the Intention to apply to revoke or alter the same, nor unless a greater Number of Trustees shall concur in the Revocation or Alteration thereof, than concurred in the making of any fuch Order, Agreement, or Determination; and the said Trustees, at all their Meetings, shall Trustees to defray their own Expences; and at every Meeting of the said Trustees, a pay their Chairman shall and may be appointed; and when and as often as it shall own Exhappen that there shall be an Equality of Votes at any such Meeting upon pences at any Question, including the Vote of the Chairman, then and in every such Case it shall and may be lawful to and for the Chairman to give the decisive Chairman to or casting Vote. X. And be it further enacted, That all Acts, Proceedings, Matters, and All Acts may Things relative to the Execution of this Act, may be done and executed be done by by any Five or more of the Trustees hereby nominated and appointed; or FiveTrustees, who shall hereafter be elected and appointed as aforesaid, except only in wise directed, Cases herein particularly directed to be done and executed by any greater or less Number of them.

XI. And be it further enacted, That all Orders and Proceedings of Orders, &c. the Trustees shall be entered in a Book or Books to be kept for that Pur- to be entered. pose; and such Orders and Proceedings so entered shall be signed by the Trustees making the same, or by their Clerk; which Book or Books, and also the Book or Books herein-after directed to be kept for registering Mortgages and Assignments, or Transfers thereof, shall be admitted as Evidence in all Courts whatfoever.

XII. Provided always, and be it further enacted, That the said Trus-Accounts tees shall and they are hereby required from Time to Time to cause to be of the Trusentered in a Book regular Accounts of the Receipts and Disbursements, open to the and of the several Articles for which such Sums have been disbursed; which Inspection of Book shall be kept by the Treasurer or Clerk, in order that any of the Creditors. Trustees, or any Creditor or Creditors on the said Tolls, may at all seasonable Times have Access thereto, and take Copies or Extracts therefrom; without paying any thing for the same; and in case the said Treasurer or Clerk shall refuse to permit such Person or Persons as aforesaid to inspect or [Local.]

take Extracts from such Book of Accounts, he shall forfeit and pay for every such Offence any Sum not exceeding the Sum of Five Pounds.

Appointing Officers Salaries, &c.

XIII. And be it further enacted, That the said Trustees may and they are hereby empowered by Writing under their respective Hands to appoint One or more Collector or Collectors of the said Tolls, and a Clerk, or Clerks, Treasurer or Treasurers, Surveyor or Surveyors of the said Roads, and such other Officers as the said Trustees shall think necessary; and such Collectors, Clerks, Treasurers, Surveyors and other Officers, or any of them, from Time to Time to remove, and on Removal, Death, or Resignation of any such Collectors, Clerks, Treasurers, Surveyors or other, Officers, to appoint others in their stead; and may and are hereby authorized and empowered, out of any of the Monies arising by virtue of this Act, to allow and pay to the several Collectors, Clerks, Treasurers, Surveyors, and other Officers, and to such other Person or Persons as shall be assisting them or any of them in or about the Execution of this Act, such Salaries, Rewards, and Allowances for their Attendance, Care, Labour, and Services, as the faid Trustees shall deem reasonable; and all such Ot-How Officers ficers and Persons shall from Time to Time, when thereunto required by shall account. the said Trustees, deliver to such Trustees, or to such Person or Persons as they shall for that Purpose appoint, true, exact and perfect Accounts in Writing under their respective Hands of all Monies which they and every of them respectively shall have received to that Time by virtue of this Act, and how much thereof hath been paid and disbursed, and for what Rurposes, together with the proper Vouchers for such Payments, and shall pay all fuch Monies as shall remain in their or any of their Hands to the laid Trustees, or to such Person or Persons as they shall appoint to receive the same, and not otherwise; and if any such Officer or Person shall resule or neglect to produce or deliver up such Vouchers relating to the same, or shall refuse or neglect to pay the Money due on such Account in Manner aforesaid; or if any such Officer or Person shall resuse or neglect to deliver up to the said Trustees, or to such Person or Persons as they shall appoint, within Ten Days after being thereunto required by the said Trustees, all the Books, Papers, or Writings in his Custody or Power relating to the Execution of this Act, then and in every or any of the said Cases, upon Complaint being made by any Three or more of the said Trustees, it shall be lawful for any Two or more Justices of the Peace for either of the Counties of Gloucester, Warwick, or Worcester, within their respective Jurildictions, and they are hereby authorized and required, by Warrant or Warrants under their Hands and Seals, to cause such Officer or Officers, Person or Persons, to be brought before them, and upon his, her, or their, appearing, or not being to be found, to hear and determine the Matter of such Complaint in a summary Way, and to settle the said Account or Accounts, if produced; and if upon Confession of the Officer or Officers, Person or Persons, against whom any such Complaint shall be made, or by, the Oath or Oaths of any Witness or Witnesses (which Oath such Justices are hereby empowered and required to administer), or upon Inspection of the said Accounts, if produced, it shall appear to such Justices that any of the Monies which shall have been collected or received shall be in the Hands of such Officer or Officers, Person or Persons, such Justices may and they are hereby authorized and required, on Non-payment thereof, by a Warrant or Warrants under their Hands and Seals, to cause such Money to be levied by Distress and Sale of the Goods and Chattels of such Officers, Person Region

Person or Persons, respectively; and if no Goods or Chattels can be found fufficient to answer and satisfy the said Money, and the Charges of distraining and selling the same; or if such Officer or Officers, or other Person or Persons, shall not appear before the said Justices, unless for some sufficient Excuse, at the Time and Place by them appointed for that Purpose; or if appearing shall refuse or neglect to give and deliver to such Justices an Account or Accounts of all Receipts and Payments as aforefaid, or to produce and deliver up to the said Justices the several Vouchers and Receipts relating to such Accounts respectively, or the Books, Accounts, Papers, and Writings in his, her, or their Custody or Power, relating to the Execution of this Act, or to the said Roads, then and in either of the Cases aforefaid fuch Justices may and they are hereby authorized and required, by a Warrant or Warrants under their Hands and Seals, to commit such Officer or Officers, Person or Persons, to the Common Gaol or House of Correction of the County wherein such Offender shall be convicted, there to remain without Bail or Mainprize until he shall have given and made a true and perfect Account or Payment as aforesaid, or until he shall have compounded and agreed with the faid Trustees, and shall have paid such Composition, in such Manner as the said Trustees shall appoint (which Composition the said Trustees are hereby empowered to make,) or until he shall have delivered up such Books, Papers, and Writings as aforesaid, or made Satisfaction in respect thereof to the said Trustees: Provided always, that no Person who shall be so committed for want of sufficient Distress shall be detained in Prison by virtue of this Act for a longer Space of Time than Six Calendar Months.

XIV. Provided always, and be it further enacted, That it shall not be Clerk not lawful for the said Trustees to appoint the Person who may be appointed to be Treato act as their Clerk in the Execution of this Act, or the Partner of any vice versa. such Clerk, the Treasurer for the Purposes of this Act; or to appoint the Person who may be appointed Treasurer, or the Partner of any such Treasurer, the Clerk to the said Trustees for executing this Act; and if any Person shall act in both the Capacities of Clerk and Treasurer for the Purposes of this Act, or if any Person being the Partner of any such Clerk shall act as Treasurer, or being the Partner of any such Treasurer shall act as Clerk in the Execution of this Act, every Person so offending shall for every such Offence forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same, to be recovered in any of His Majesty's Courts of Record at Westminster by Action of Debt or on the Case, or by Bill, Suit, or Information, wherein no Essoin, Protection, or Wager of Law, nor more than One Imparlance, thall be allowed.

XV. And be it further enacted, That the said Trustees shall and they are hereby required to take sufficient Security from the Treasurer or Treasurers, Receiver or Receivers, Collector or Collectors, or other Officers to be appointed for the Purposes of this Act, for the faithful Exeeution of their respective Offices; and no such Treasurer, Receiver, Collector, or other Officer shall be permitted to enter upon such their Offices respectively, until they shall have given such Security.

Treasurer, &c. to give Security.

XVI. And be it further enacted, That upon the Death, Incapacity, absonding, or Absence of any Collector or Receiver of Tolls, any Three

Collectors in certain Cases.

or more of the faid Trustees, though not assembled at any General Meeting of the Trustees appointed by virtue of this Act, by Writing under their respective Hands shall and may nominate and appoint a proper Person to be a Collector or Receiver of the said Tolls, to continue until the then next Meeting of the said Trustees, in the Stead of such Collector or Receiver as shall so die, become incapable, abscond, or absent himself: and every Person so nominated and appointed shall have the like Power and Authority, and be answerable and accountable in the same Manner in all respects, as the Person who shall so die, become incapable, abscond, or absent himself, would have had or been subject to; and if any Collector or Receiver of the said Tolls, who shall be discharged from his said Office by the said Trustees, or the Wife or Widow, or any of the Children, Family, or Representatives of any Collector or Receiver who shall die, abscond, absent himself, or be discharged, or any other Person having the Possession of any Toll House or Buildings to be erected or set up by virtue of this Act, shall neglect or refuse to deliver up such Possesfion for the Space of Seven Days after Demand thereof made, and Notice in Writing given for that Purpose, by any Three or more of the said Trustees, or by their Clerk or Treasurer, then and in any of the said Cases it shall and may be lawful for any Justice or Justices of the Peace for the said Counties of Gloucester, Warwick and Worcester, within their respective Jurisdictions, by Warrant under his or their Hand and Seal or Hands and Seals, to order any Constable or other Peace Officer, with fuch Affistance as shall be necessary, to enter such House or Buildings in the Day-time, and to remove the Person or Persons who shall be found therein, together with his, her, or their Goods, out of the same, and to put the said Trustees or any Three or more of them, or any of their Officers, in the Possession thereof.

No Trustee shall vote for Officers, unless he has acted in the preceding Year.

XVII. Provided always, and be it enacted, That after the first Nomination and Appointment of any Officers in pursuance of this Act, no Trustee shall be capable of voting or acting in any future Nomination or Appointment of any such Officers respectively, upon Death, or any other Vacancy or Vacancies, unless such Trustee shall have acted as a Trustee in the Execution of this Act at least Once within the Space of One Year next preceding the Time of such last-mentioned Nomination or Appointment.

Trustees may fue and be sued in the Name of their Clerk or Treasurer.

XVIII. And be it further enacted, That the said Trustees may sue and be fued for or concerning any Thing to be done by virtue or in purluance of this Act, in the Name of their Clerk or Treasurer for the Time being; and that no Action or Suit brought or commenced by the Direction of or against the said Trustees by virtue of this Act, in the Name of their Clerk or Treasurer, shall abate or be discontinued by the Death or Removal of any such Clerk or Treasurer, or by the Act of any such Clerk or Treasurer, without the Consent of the said Trustees; but that the Clerk or Treasurer for the Time being to the said Trustees shall be deemed to be Plaintiff or Defendant as aforesaid, as the Case may be, in every such Action: Provided always, that every such Clerk and Treasurer in whose Name any Action or Suit shall be commenced, sued, prosecuted, or defended in pursuance of this Act, shall be fully reimbursed and paid, out of the Monies to arise by virtue of this Act, all such Costs, Charges, Damages and Expences, as by the Event or in consequence of any such Action

Action of Proceeding, he shall pay, bear, expend, or be put unto, or become chargeable with, by reason of his being so made Plaintiff or Defendant as aforesaid.

XIX. And for the Purpose of collecting and receiving the Tolls herein Power to granted and made payable, be it enacted, That the said Trustees, or such other Person or Persons as they shall direct and appoint, shall and may Houses, &c. èrect or cause to be erected such and so many Toll Gates or Toll Bars in, upon, or across such Parts and in such Places of the said Roads, and also fuch and so many Toll Gates or Toll Bars on the Sides of the said Roads, and in, upon, or across any Road, Street, Lane, or Byway that does of shall lead into or out of the same, as they the said Trustees shall think proper and expedient (subject nevertheless to such Restrictions and Directions as are herein after mentioned concerning the same); and also shall or may erect or provide a Toll House, with suitable Buildings, a Garden and other Conveniences, not exceeding One Rood of Land, at or near each of the said Toll Gates or Toll Bars.

And be it further enacted, That the Right and Property of and Toll Houses in all the Toll Gates and Toll Houses, Weighing Machines, Buildings, Lamps, &c. vested in Bars, Toll Boards, Direction Boards, Posts, Rails, and Fences which shall be Trustees. erected and provided in pursuance of this Act, with the several Conveniences and Appurtenances thereunto respectively belonging, and the Materials of which the same shall consist, and all Materials which shall be provided for repairing the faid Roads, shall be vested in the said Trustees for the Time being; and they are hereby authorized and empowered to apply and dispose of the same as they shall think fit, and to bring or cause to be brought any Action or Actions, and to prefer and profecute, or order and direct the preferring and prosecuting of any Informations or Indictments against any Person or Persons who shall dig up, break, or pull down, steal, take, or carry away, spoil, destroy, injure, or damage any of the Tøll Gates or Toll Houses, Weighing Machines, Buildings, Lamps, Bars, Toll Boards, Direction Boards, Posts, Rails, and Fences, or any of the Conveniences and Appurtenances thereunto belonging, or any of the Materials aforesaid.

XXI. Provided always, and be it further enacted, That it shall be law. Power to ful for the said Trustees or any Five or more of them, and they are here- remove Toll by empowered, from Time to Time, when and as often as they shall think Gates. proper, to cause any of the Toll Gates or Toll Bars which shall be erected in, upon, or across, or on the Side or Sides of the said Roads, by virtue of this Act, to be removed to, and erected in, or discontinued upon or across or on the Side or Sides of such other Part or Parts of the said Roads, as the said Trustees or any Five or more of them shall from Time to Time order and direct; provided that none of the said Toll Gates or Toll Bars shall be removed or discontinued as aforesaid, unless Fourteen Days previous Notice of the Intention to remove or discontinue the same shall have been given in One or more of the Newspapers published or circulated within the Counties of Gloucester, Warwick, and Worcester, aforesaid, and also affixed in Writing upon all the Toll Gates then standing upon the faid Roads.

Power to take Tolls.

XXII. And be it further enacted, That it shall be lawful for the said Trustees, or any Person or Persons to be appointed by virtue of this Act Collector or Collectors as aforesaid, to demand and take the several Tolls and Duties following at each and every of the respective Toll Gates or Toll Bars, or Toll Gate or Toll Bar, which shall be erected in, upon, or across, or on the Side or Sides of the said Roads, by this Act directed to be amended, widened, shortened, improved, and kept in Repair, or in, upon, or on the Side of any Street, Lane, or Way leading into or out of any Part of the said Roads, and on every Day (such Day to be computed from Twelve of the Clock at Night to Twelve of the Clock in the next succeeding Night); that is to say,

For every Horse, Mule, or other Beast, drawing any Coach, Chariot, Sociable, Landau, Berlin, Vis a-vis, Barouche, Phaeton, Curricle, Calash, Chaise, Chair, Gig, Whiskey, Taxed Cart, Caravan, Hearse, Litter, or other such Carriage, the Sum of Sixpence:

For every Horse, Mule, or other Beast, drawing any Waggon, Wain, Cart, or other such Carriage, having upright cylindrical Wheels of equal Diameter in the whole Breadth of the Fellies or Sole of the Breadth of

Nine Inches, the Sum of Three pence:

For every Horse, Mule, or other Beast, drawing any Waggon, Wain, Cart, or other such Carriage, having Wheels of the Breadth of Six Inches and less than Nine Inches, or which shall not be upright and cylindrical Wheels of equal Diameter in the whole Breadth of the Fellies or Sole, the Sum of Four-pence Halfpenny:

For every Horse, Mule, or other Beast, drawing any Waggon, Wain, Cart, or other such Carriage, having Wheels of less Breadth than Six

Inches, the Sum of Five-pence:

For every Horse, Ass, or Mule, not drawing, the Sum of One Penny Halfpenny:

For every Score of Oxen, Cows, or Neat Cattle, and so in proportion,

the Sum of One Shilling and Eight-pence:

For every Drove of Calves, Hogs, Sheep, or Lambs, the Sum of Tenpence per Score; and so in proportion for any greater or less Number.

Tolls vested in Trustees.

And the said respective Tolls shall be demanded and taken, before any Horse or Horses, or other Beast or Cattle, or any Carriage whatsoever, be permitted to pass through any such Toll Gate or Toll Bar; and all and every Sum and Sums of Money which shall arise and be produced therefrom shall be vested in the said Trustees for the Time being, and the same and every Part thereof shall be paid, applied, disposed of, and assigned, in such Manner as is herein-after mentioned; and if any Person or Persons subject to the Payment of any of the said Tolls shall, after Demand thereof made by the Person or Persons so authorized to receive the same, neglect or refuse the Payment thereof, or any Part or Parts thereof, it shall be lawful for the Person or Persons so authorized to seize and distrain any Horse, Cattle, or Beast, together with their Bridles, Saddles, Harness, or Accoutrements, or any Carriage with its Lading, upon which any Toll is by this Act imposed, (but no such Bridle, Saddle, Harness, or Accoutrements shall be so seized, without detaining and seizing the Horse or other Beast bearing the same), or any of the Goods and Chattels of the Person or Persons neglecting or refusing to pay the same; and if such Tolls, and the reasonable Charges of such Distress, and keeping the same, shall not be paid within the Space of Five Days after the Day of making

making such Distress, the Person or Persons so distraining shall and may at any Time or Times thereafter sell the Horse, Cattle, Beast, Carriage, Goods, and Chattels so distrained, or a sufficient Part of such Goods and Chattels, and out of the Money which shall arise by such Sale, pay such Tolls, and all reasonable Charges incurred by such Distress and Sale, returning the Overplus of the Money which shall arise by such Sale, and what shall remain unsold (if any), on Demand, to the Owner or Owners thereof.

XXIII. And be it further enacted, That upon Payment of any of the Tickets to Tolls granted or made payable by virtue of this Act, the Collector or be printed. Receiver shall and he is hereby required to deliver gratis to the Person paying such Toll a Note or Ticket denoting such Payment, and which Note or Ticket thall be provided by the said Trustees; and there shall be printed and specified thereon the Names of the several or respective Gates which such Ticket shall free, or which ought under the Provisions of this Act to be passed free for One Payment of Toll.

XXIV. Provided always, and it is hereby enacted and declared, That Number of no more than One Toll shall be demanded or taken from any Person or Tolls limited. Persons passing and repassing the same Day with or driving the same Horses, Cattle, Sheep, Beasts, or Carriage, through all or any of the Toll Gates or Toll Bars which shall be erected by virtue of this Act upon that Part of the said Roads which lies between the Cross Hands aforesaid and the Town of Chipping Campden aforesaid; and that no more than One Tolk shall be demanded from any Person or Persons passing or repassing the same Day in Manner aforesaid through all or any of the Toll Gates or Toll Bars which shall be erected by virtue of this Act upon that Part of the said Roads which lies between the Town of Chipping Campden, and the Upper or South-west End of the Village of Ilmington aforesaid; and that no more than One Toll shall be demanded or taken from any Person or Persons passing or repassing the same Day in Manner aforesaid through all or any of the Toll Gates or Toll Bars which shall be erected by virtue of this Act upon that Part of the said Roads which lies between the Upper or South-west End of the Village of Ilmington and the Warwick and Stow Turnpike Road; and that no more than One Toll shall be demanded or taken from any Person or Persons passing or repassing the same Day in Manner aforesaid through all or any of the Toll Gates or Toll Bars which shall be erected by virtue of this Act on that Part of the said Roads which lies between the Lower or North End of the Village of Ilmington aforesaid, and the Fourth Mile Stone from Stratford, on the Turnpike Road leading from Stratford on Avon to Oxford; and that all and every Person or Persons having paid the full Toll imposed by this Act at any One of such Toll Gates to be erected on that Part of the said Roads which lies between the Cross Hands aforesaid and the Town of Chipping Campden, and producing a Note or Ticket denoting the Payment thereof (which Ticket the Collectors of the Tolls are hereby required to give gratis on the Receipt of fuch Tolls), shall pass and repass during the same Day any Number of Times with the same Horses, Cattle, and Carriages, Toll-free, through all other the Toll Gates so to be erected on that Part of the said Roads; and that all and every Person or Persons having paid the full Toll as aforesaid at any One of such Toll Gates to be erected on that Part of the said Roads which lies between the Town of Chipping Campden and the Upper or South-west

South-west End of the Village of Intington, and producing a Ticket as aforelaid, shall pass and repass dufing the same Day any Number of Times as aforesaid, Toll-free, through all other the Toll Gates to be erected on that Part of the laid Roads; and that all and every Person or Persons having paid the full Toll as aforefaid at any One of such Toll Gates to be erected on that Part of the faid Roads which lies between the Upper or South-west End of the Village of Ilmington and the Warwick and Stow Turnpike Road, and producing a Ticket as aforesaid, shall pass and repass during the same Day any Number of Times as aforesaid, Toll-free, through all other the Toll Gates so to be erected on that Part of the said Roads; and that all and every Person or Persons having paid the full Toll as aforefaid at any One of such Toll Gates to be erected on that Part of the said Roads which leads from the Lower or North End of the Village of Unington to the Turnpike Road leading from Stratford on Avon to Oxford, and producing a Ticket as aforelaid, shall pass and repass during the same Day any Number of Times as aforesaid, Toll-free, through all other the Toll Gates so to be érected on that Part of the said Roads.

Persons paying Two Tolls may Road.

XXV. Provided always, and be it enacted, That nothing in this Act contained shall authorize the said Trustees, or any Collector to be by them appass free the pointed, to ask, demand, or receive any further Toll from any Person of whole Line of Persons who shall produce Tickets of having paid the full Toll on the same Day at any Two of the Toll Gates or Toll Bars to be erected by virtue of this Act on any Part of the said Roads; but such Person or Persons shall be permitted to pass through all the other Toll Gates or Toll Bars to be erected by virtue of this Act, on the same Day on which he shall have so paid Two Tolls as aforesaid, without any further Payment whatever; any Thing in this Act contained to the contrary notwithstanding.

XXVI. And be it further enacted, That if any Dispute shall happen con-Disputes con- cerning any Tolls due, or the Charges occasioned by any such Distress as cerning Tolls. aforesaid, it shall be lawful for the Collector of other Person so distraining to retain such Distress, or the Money arising from the Sale thereof, till the Amount of the Tolks and the Charges of such Distress shall be ascertained by some Justice of the Peace for the County in which such Distress shall be taken, who, on Application made to him for that Purpose, shall examine the Matter on Oath of the Parties, or of a Witness or Witnesses, and shall determine the Amount of the Tolls due, and shall award such Costs and Charges to either Party as to the said Justice shall appear right and proper; all which Costs and Charges shall and may be levied and recovered, in case of Non-payment thereof forthwith, by Warrant under the Hand and Seal of such Justice, residering the Overplus (if any) on Demand, after Payment of such Costs and Charges, and the Costs and Charges of making such Distress and Sale to the Person or Persons whose Goods and Chattels shall have been so distrained and sold.

Collectors declared competent Witnesses.

XXVII. And be it further enacted, That in case any Dispute, Suit, or Litigation shall arise, touching or in anywise relating to the said Tolks, the Perion or Persons appointed to collect the same, or any other Person or Persons acting under the Authority of the said Trustees, shall not be incompetent, on account of his being appointed to collect such Tolls, to give Evidence in any such Dispute, Suit, or Litigation.

Evasion of

Tolls.

XXVIII. And be it further enacted, That if any Person or Persons shall To prevent with any Horse, Cattle, Beast, or Carriage whatsoever, in order to avoid Payment of the said Tolls, or any of them, pass through any Land or Ground adjoining to or lying near any Toll Gate or Toll Bar to be erected by virtue of this Act (except the Owner or Owners, Occupier or Occupiers of such Land or Ground, or his or their Servant or Servants, or any Person or Persons in his or their Family), the same not being a common Road; or if any Owner or Occupier of any such Land or Ground shall knowingly permit or suffer any Person or Persons, with any Horse, Cattle, Beast, or Carriage, to pass through the same, except as aforesaid, with Intent to avoid the Payment of any of the said Tolls, or any Part or Parts thereof; or if any Person or Persons shall give to or receive from any Person, other than the Collectors of such Tolls, or forge or counterfeit any Ticker by this Act directed to be given by the Collectors of the said Tolls; or shall forcibly pass through any Toll Gate or Toll Bar with any Horse, Cattle, Beast or Carriage; or shall at any Time or Times take off or cause to be taken off any Horse, Ox, or any other Cattle or Beast, from any Carriage, whereby the Payment of any of the said Tolls, or any Part or Parts of the said Tolls, shall be evaded; or shall leave or cause to be left upon or near to any Part of the said Roads any Carriage, Horse, Cattle, or Beast, with an Intent to evade the Payment of any of the said Tolls, or any Part or Parts thereof, or with such Intent shall unload any Goods from any Carriage, every Person so offending in any of the Case's aforesaid shall for every such Offence forfeit and pay any Sum not exceeding Forty Shillings, at the Discretion of the Justice or Justices before whom such Offender shall be convicted.

XXIX. And be it further enacted, That it shall be lawful for the said Trustees to Trustees or any Five or more of them to cause Fences and Ditches to be erect Fences erected and made upon and over any Parts of any Open Fields, Commons, upon Comors Waste Grounds, over which are Done of Dante of or Waste Grounds, over which any Part or Parts of the said Roads may lead, as they shall think necessary, in order to prevent the Payment of Tolls being evaded; and if any Person or Persons shall pull down or otherwise displace or carry away any such Fence or any Part thereof, or shall fill up or spoil any such Ditch, every such Person shall for every such Offence forfeit and pay the Sum of Five Pounds, over and besides the Amount of the Damages occasioned thereby.

XXX. And be it further enacted, That no Toll shall be demanded or Exemptions taken for any Horse or Cattle drawing any Carriage passing through any from Toll. of the Toll Gates or Toll Bars to be erected upon or on the Sides of the laid Roads, going for or carrying or conveying Stones, Bricks, Lime, Timber, Wood, Gravel, or other Materials to be used on or about the faid Roads, or for repairing any of the Highways in the Parishes or Places which are liable to perform Statute Duty upon any Part of the said Roads, or on returning empty, having been so employed; or carrying or conveying Hay, Straw, or Corn in the Straw, not fold or to be fold or disposed of, but going to be laid up in the Houses, Outhouses, Barns, or Yards of the Owners thereof, or returning empty, having been fo employed; or any Plough, Harrow, or other Implement of Husbandry to be used in the Cultivation of Lands; or any Mould, Dung, Ashes, Soil, or Compost for the manuring of Lands (Lime and Soap Ashes excepted), or when going for or returning empty, having been to employed; or from any Clergyman going to or returning from visiting any Local.

of his fick Parishioners, or going to or returning from Church or Divine Service, or on any other his Parochial or Ministerial Duty; or from any other Person or Persons who shall pass through any of the said Toll Gates or Toll Bars to or from Church, Chapel, or other Place of Religious Worship, on a Sunday, or any other Day on which Divine Service is ordered by Authority to be celebrated; or who shall attend the Funeral of any Person or Persons who shall die and be buried in any of the said Parishes or Places; or for any Horse, Mare, Gelding, Mule, Ass, or Cattle kept within such Parishes or Places, going to or returning from Work, in cultivating Lands therein; or for any Horse or Cattle going to or returning from Water or Pasture, or going to or returning from being shoed or farried, or for any Sheep going to or returning from any Wash, Dike, River, or other Place used for the washing of Sheep in any such Parishes, or for any Sheep going to or returning from any Place used for shearing of Sheep in any such Parishes; or for any Horse or Carriage of whatsoever Description employed or to be employed in conveying the Mails of Letters and Expresses under the Authority of His Majesty's Postmaster General, either when employed in conveying, fetching, or guarding the same, or in returning back from conveying the same; or for the Horses of Officers and Soldiers on their March or on Duty; or for Carriages, or Horses, or other Beasts employed in carrying the Arms or Baggage of such Officers or Soldiers, or in carrying any sick, wounded, or disabled Officers or Soldiers; or for any Horse, Mare, or Gelding furnished by or for any Persons belonging to any Corps of Yeomanry or Volunteer Cavalry, or to any Field Officer, Adjutant, or other mounted Officer of Volunteer Infantry, and rode by him in going to or returning from the Place appointed for and on the Days of Exercise, provided that all such Persons are in the Uniform of their respective Corps, and have their Arms, Furniture, and Accoutrements according to the Regulations provided for such Corps respectively, at the Time of claiming such Exemption, and not otherwise; or for any Waggon, Wain, Cart, or other Carriage whatsoever, or the Horse or Horses, or other Cattle drawing the same, which shall be employed in conveying any Ordnance or Barrack, or other Public or Commissariat Stores of or belonging to His Majesty, or for the Use of His Majesty's Forces; or for any Carriage, Horse, or other Beast employed in the Conveyance of Vagrants travelling with legal Passes, or returning after having been so employed; or for any Horse or Carriage going to or returning from any Election of a Knight or Knights of the Shire to serve in Parliament for the Counties of Gloucester, Warwick, and Worcester, or any or either of them, on the Day or Days of such Election, or on the Day before or Day after such Election shall begin or be concluded; and if any Person shall claim and take the Benefit of any of the Exemptions aforesaid (not being entitled thereto), every such Person shall for every such Offence forfeit and pay any Sum not exceeding Forty Shillings: Provided always, that no Toll shall be demanded and taken for any Horse, Cattle or Carriage, which shall not go or pass more than Two hundred Yards upon the faid Roads.

And be it further enacted, That no Person owning or driving or causing to be driven any Waggon, Wain, Cart, or other Carriage provided for the Service of His Majesty's Forces, or conveying any Ordnance, Barrack, or Commissariat, or other Public Stores of or belonging to His Majesty, or for the Use of His Majesty's Forces, shall be subject to any Penalty

Penalty or Forfeiture for Overweight; nor shall any Waggon, Wain, tions for Cart, or other Carriage, while so employed, be stopped or detained by overweight. reason of any Weight in any such Waggon, Wain, Cart, or other Carriage, or of being drawn by any Number of Horses or Oxen; but it shall be lawful for any Owner or Driver of any such Waggon, Wain, Cart, or other Carriage, to put any Number of Horles or Oxen to such Waggon, Wain, Cart, or other Carriage; any Thing in any Act of Parliament relating to Highways or Turnpike Roads, or in this Act contained to the contrary notwithstanding.

And be it further enacted, That during such Time as the said Tolls or any Part or Parts thereof shall be leased, demised, or in Farm to any Person or Persons whomsoever, it shall be lawful for the Lessee or Lessees, Farmer or Farmers thereof, or such other Person or Persons as he, she, or they shall by Writing or Writings under his, her, or their Hand or Hands authorize or appoint, to demand and take the said Tolls so leased, demised, or farmed, and to use all such Means and Methods for the Recovery thereof, in case of Non-payment or Evasion, as any Collector of the said Tolls appointed under or by virtue of this Act is by this Act authorized and empowered to use; and such Lessee or Lessees, Farmer or Farmers, or other Person or Persons as aforesaid, so demanding and taking the said Tolls, shall be subject to the like Pains, Penalties, and Forseitures, and shall be liable to the like Actions and Prosecutions, as any Collector of the said Tolls appointed by the said Trustees is subject or liable to.

And be it further enacted, That no Lessee or Lessees, or Farmer or Farmers of the Tolls, at any Toll Gate or Toll Bar to be erected upon the said Roads, or his or their Deputy or Deputies, Agent or Agents, shall make any Composition by the Year or otherwise with the Inhabitants of any Town or Place, or with any Person or Persons whomsoever, for or in lieu of the Tolls of any Waggon, Wain, Cart, or other Carriage, liable to be weighed at any Engine or Engines to be erected upon the said Roads, for or in respect of the Overweight thereof; and in case any Lessee or Farmer, or Deputy or Agent, shall offend herein, every such Lessee or Farmer, or Deputy or Agent shall, on Conviction thereof, by Confession, or upon the Oath of one Witness before any Two of His Majesty's Justices of the Peace for the County wherein the Offence shall be committed, forfeit and pay, besides the Costs and Charges attending the Conviction, any Sum not exceeding Forty Shillings, and shall also forfeit his or their Contract or Lease for renting the Tolls, if the Trustees or any Five or more of them shall think proper to order that the same shall be thereupon vacated and made void; and every such Composition shall be and the same is hereby declared to be null and void; and that One Moiety of every such Penalty as aforesaid shall be paid to the Informer, and the other Moiety to the Clerk or Treasurer of the said Roads, to be applied towards the Repairs thereof; the same to be levied by Distress and Sale of the Goods and Chattels of the Person or Persons so convicted, by Warrant under the Hand and Seal or Hands and Seals of fuch Justice or Justices as aforesaid.

And be it further enacted, That it shall and may be lawful to and for the said Trustees or any Five or more of them at any Meeting to borrow and take up at Interest upon the Credit and Security of the Tolls to arise by virtue of this Act, in such Manner as they shall think proper, such Sum or Sums of Money as they or any Five or more of them shall think sit; and for securing the Repayment of all such Sum and Sums, with Interest, they the said Trustees or any Five or more of them are hereby empowered from Time to Time, by any Writing or Writings under

Penalties for defacing, and committing any Nuisances.

LX. And be it further enacted, That the said Trustees shall and they are hereby required from Time to Time to cause the said Roads to be measured, and Stones or Posts to be placed in or near the Sides of the said Roads, with Inscriptions thereon denoting the Number of Miles and Distance of Places from any Town or Place, and also cause to be erected Guide Posts upon such Parts of the said Roads where the same may be crossed or joined by other Roads, as they shall think proper; and if any Person or Persons shall wilfully pull up or damage any Direction or Mile Post or Stone erected or fixed, or to be erected or fixed, in or near the Side or Sides of the said Roads, or shall obliterate or deface any of the Letters, Figures, or Marks inscribed thereon; or if any Person shall ride upon any Causeway

Causeway or Footpath upon or on the Side of or adjoining to the said Roads or shall drive any Horse, Beast, or Swine, or any Carriage upon, or cause, any Damage to be done to any Causeway or Footpath; or if any Person shall cause to be hauled or drawn upon any Part of the said Roads any Timber, Stone, or other Thing (otherwise than upon wheeled Carriages), or shall suffer any Timber, Stone, or other Thing which shall be carried upon wheeled Carriages to drag upon the said Roads to the Prejudice thereof; or if any Person driving any Pigs or Swine upon the said Roads shall suffer the same to root up and damage the said Roads, or the Fences on either Side thereof; or if any Person driving any Carriage upon the said Roads shall ride upon the Shafts or other Part of the said Carriage without holding the Reins of the Horse or Horses, or meeting another Carriage shall not keep his or her Carriage on his or her Left or near Side of the said Roads, and also keep on the same Side himself; or if any Person shall in any other Manner wilfully prevent any other Person or Persons from passing him or; her, or any Carriage under his or her Care, upon the said Roads; or if any Person shall make or assist in making any Fire or Fires, or shall set fire to or let off or throw any Squib, Rocket, Serpent, or Firework whatfoever, or play at Football, or any other Game or Games whatfoever, on any Part of the said Roads; or if any Person shall leave any Carriage (except in Cases of Accident) upon or on the Side of the said Roads, longer than may be necessary to load or unload the same, either with or without any Horse or Beast of Draught harnessed or yoked thereto, and then such Carriage shall be placed as near to the Side of the said Roads as conveniently may be, or shall lay any Timber, Stone, Chalk, Marl, Lime, Hay, Straw, Dung, Manure, Soil, Rubbish, or other Matter or Thing whatsoever upon the said Roads, or on the Side or Sides thereof between the said Roads and the Fences to be erected on the Sides thereof, or shall plough up, dig up, or break up any of the Soil between the said Roads and such Fences as aforesaid, for the Purpose of making Compost or Manure, or otherwise shall scrape off any Soil or other Thing from the said Roads or the Sides thereof, or shall take up and carry away any Scrapings thereof, or any Dung, Mould, Soil, Compost, or Manure from the Sides thereof, except such as may be lying in his own Ground, and be carried away without being brought over any Part of the said Roads, or that the same be done at such Times and under such Regulations as the Trustees or their Surveyor shall direct and order, every Person so offending shall for every such Offence forfeit and pay any Sum not exceeding Forty Shillings, to be recovered and applied as herein-after directed.

LXI. And be it further enacted, That it shall be lawful for the said Trustees may Trustees or any Five or more of them from Time to Time to contract contract for and agree with any Person or Persons for the amendian and agree with any Person or Persons for the amending, widening, any other shortening, or improving of the said Roads or any Part thereof, or for Works. doing any other Work in pursuance or Execution of this Act, in such Manner and for fuch Sum or Sums of Money annually, or for a Term of Years or otherwise, as the said Trustees or any Five or more of them' shall think proper.

LXII. And be it further enacted, That all Owners, Occupiers, Grantees, Persons liable Trustees, Feoffees, and Committees of any Lands, Tenements, Rents, and Annuities, or any Sum or Sums of Money which have been given or are liable to the maintaining or amending of any Part or Parts of the said Roads by this Act directed to be widened, improved, or repaired, or any Bridge or Bridges, or other necessary Things thereon, or any Part or Parts

to repair the Roads to

Parts thereof, shall still remain hable and chargeable to the Repair thereof, in such Manner and to the same Extent, but not in any other Manner, nor to any greater Extent, than as they were liable and chargeable before the passing of this Act.

LXIII. Teams, Draught or Draughts, Horse or Horses, Beast or Beasts, to be provided by him, her, or them, be subject and liable to such Pains; Penalties, and Forseitures as such Person or Persons may be subject or liable to by any Law or Statute in Force and Effect for the Repair of the public Highways; and if any Person who shall come to work as a Labourer, or who shall be fent with any Team or Draught to work on the said Roads, shall be found idle or negligent by any Surveyor to the said Trustees, such Surveyor is hereby empowered to remove and dismiss the Person who shall be found idle or negligent as aforesaid; and in that Case every such Person shall be subject and liable to the respective Forseitures and Payments aforefaid, as if he had neglected or refused to come, or such Team or Draught had not been sent to work on any Part of the said Roads; all which Forfeitures shall be paid to the Treasurer to the said Trustees, and applied towards amending the said Roads; and in case the said Surveyor or Surveyors of the Highways for any of the said Parishes or Places respectively shall refuse or wilfully neglect to give in such Lists as aforefaid, or shall knowingly or wilfully give in false or impersect Lists, every such Surveyor so offending shall for every such Offence forfeit and pay any Sum not exceeding Forty Shillings.

And be it further enacted, That it shall and may be lawful to and Trustees may for the said Trustees to compound and agree with any Person or Persons, compound Bodies Politic or Corporate, for the Statute Work to be by them done on Work. the faid Roads or any Part thereof, and also with the Inhabitants and Occupiers of Lands, Tenements, or Hereditaments of and in all or any the Parishes or Places in which the said Roads are or shall be situated; for a certain Sum of Money by the Year or otherwise, as the said Trustees shall think reasonable, in lieu of the whole or of any Part of the Statute or other Work to be by all or any of the said Inhabitants and Occupiers done on the said Roads; which Composition Money shall always be paid by the Surveyor or Surveyors of the Highways, or other Officer of the Parish, or by the Person or Persons so compounding, to the Treasurer to the said Trustees, in advance, on or before the First Day of January in each and every Year, or otherwise the Inhabitants and Occupiers of such Parish or Place shall not be permitted to compound for that Year.

LXV. And be it further enacted, That all Gates in any Field or Ground Gates to be adjoining any of the said Roads, shall be made and hung to open respectively inwards towards such Field or Ground, and not outwards towards joining the said Roads; and it shall be lawful for the said Trustees to order all such Lands, and Gates as open outwards towards the said Roads to be altered and made not into the to open inwards, as they the said Trustees shall think proper; and if any Roads. Occupier or Occupiers of the Lands in or upon which any Gate or Gates are or shall be constructed so as to open outwards towards the said Roads, shall (after Ten Days Notice from the Surveyor of the said Roads, requiring him or them to alter such Gate or Gates, and make the same to open inwards) refuse or neglect to make such Alteration, it shall and may be lawful for the faid Trustees to exercise and apply the same Powers for this Purpose with which they are by Law invested for the Removal of any Nuilances, Obstructions, or Annoyances made or committed upon the faid Roads.

LXVII And be it further enacted, That if any Person or Persons shall Penalty is assault, interrupt, or hinder, or cause to be assaulted, interrupted, or hindered,

LXVII. And whereas Offences may be committed against this Act by Persons unknown to the Trustees, Collectors, Surveyors, or other Officers appointed to put the same in Execution; be it therefore further enacted, That it shall be lawful for the said Trustees, Collectors, Surveyors, or other Officers respectively, and such other Person or Persons as he or they shall call to his or their Assistance, without any Warrant or other Authority than this Act, to apprehend and detain any such unknown Person or Persons, who shall commit any such Offence or Offences, and to take him, her, or them before any Justice of the Peace for the County or Place where the Offence or Offences shall be committed, to be dealt with according to Law.

LXVIII. And be it further enacted, That all and every the Toll Collectors, being Lessee of the said Tolls, or appointed either by the said Trustees or by any such Lessee or Lessees to collect the Tolls payable at any Toll Gate or Toll Bar to be erected by virtue of this Act, shall and he is hereby required to place his Christian and Surname, painted on a Board in legible Characters, on the Front or on some other conspicuous Part of the Toll House or Toll Gate, immediately on his beginning to collect fuch Toll, or coming on Duty; each of the Letters of such Name or Names to be at least Two Inches in Length, and of a Breadth in proportion, and painted either in Black Letters on a White Ground or White Letters on a Black Ground, and shall continue the same so placed during the whole Time he shall collect such Toll, or be upon such Duty; and if any Collector of the same Tolls shall not place such Board as aforesaid, and keep the same there during the Time aforesaid, or shall demand or take a greater or less Toll from any Person than he shall be authorized to do by virtue of the Powers of this Act, or of the Orders and Resolutions of the Trustees made in pursuance thereof; or shall demand and take a Toll from any Person or Persons who shall be exempt from the Payment thereof, and claim such Exemption; or shall resuse to permit or suffer, or shall in anyways hinder any Person or Persons from reading such Christian or Surname, or shall refuse to tell his Christian or Surname to any Person or Persons who shall demand the same on having paid the said Tolls or any of them, or shall in answer to such Demand give a false Name or Names; or shall refuse or neglect to give a Ticket to denote the Payment of the Toll when demanded; or, upon the legal Toll being paid or tendered, shall unnecessarily detain or wilfully obstruct, hinder, or prevent any Passenger or Passengers from passing through any Toll Gate or Toll Bar; or shall make use of any scurrilous or abusive Language to any Traveller or Passenger; then and in every such Case every such Toll Collector shall forfeit and pay any Sum not exceeding Five Pounds for every fuch Offence, as the Justice or Justices before whom the Information shall be laid shall adjudge; and such Penalty shall be recovered and applied as other Penalties are by this Act directed to be recovered and applied.

Toll Collectors not to make use of **fcurrilous** Language to Travellers.

LXIX. And be it further enacted, That all Penalties, Forfeitures, and Penalties and Forfeitures Fines hereby inflicted or authorized to be imposed (if the Manner of

levying and recovering thereof be not herein otherwise directed), shall, how to be upon Proof of the Offences respectively before any Justice of the Peace for the County or Place wherein the Offence shall be committed, or wherein the Offender shall be and reside, either by the Confession of the Party or Parties offending, or by the Oath of One or more credible Witnels or Witnesses, be levied by Distress and Sale of the Goods and Chattels of the Party or Parties offending, by Warrant under the Hand and Seal of such Justice (which Warrant such Justice is hereby empowered and required to grant for those Purposes); and the Overplus, after such Penalties, Forfeitures, and Fines, and the Charges of the Distress and Sale, are recovered and deducted, shall be returned upon Demand to the Owner or Owners of fuch Goods and Chattels; and the Penalties, Forfeitures, and Fines, when paid and recovered (if not otherwise directed to be applied by this Act), shall be from Time to Time paid, One Moiety thereof to the Informer, and the other Moiety thereof to the Treasurer or Clerk to the said Trustees, and applied to the Purposes of this Act; and in case such fufficient Distress shall not be found, and such Penalties, Forfeitures, and Fines shall not be forthwith paid, it shall be lawful for any Justice of the Peace as aforesaid, and he is hereby authorized and required by Warrant, or Warrants under his Hand and Seal, to cause such Offender or Offenders to be committed to the Common Gaol or House of Correction for fuch County or Place, there to remain without Bail or Mainprize for any Time not exceeding Three Calendar Months, unless such Penalties, Forfeitures, or Fines, and all reasonable Charges, shall be sooner paid and fatisfied.

LXX. And for the more easy Conviction of Offenders against this Act, Offences. be it further enacted, That all and every the Justices and Justice of the Peace, before whom any Person or Persons shall be convicted of any Offence against this Act, shall and may cause the Conviction to be drawn up in the following Form of Words (as the Case shall happen), or in any other Form of Words to the same Effect; (that is to say),

BE it remembered, That on the Day of Form of in the Year of our Lord Conviction.

LXXI. And be it further enacted, That if the several Persons who have become Subscribers towards the Expence of obtaining and passing this Act, and carrying the same into Execution, or any one or more of them, or any Subscriptions. Person or Persons who shall hereafter become or agree to become a Subscriber or Subscribers for the Purposes aforesaid, shall, after Forty Days. previous Notice in Writing under the Hand of the Treasurer or Clerk to the faid Trustees, for that Purpose to him, her, or them given, or left at his, her, or their Dwelling House or usual Place or Places of Abode, refuse or neglect to make Payment of the respective Sums by him, her, or them so subscribed or agreed to be subscribed, or such Part or Parts thereof as may be required in such Notice, it shall be lawful for the said Trustees to bring or cause to be brought any Action of Debt or on the Case, Bill, Plaint, or Local.

Suit, against the Person or Persons so neglecting or resusing as aforesaid his, her, or their Heirs, Executors, or Administrators, in any of His Majesty's Courts of Record at Wostminster, wherein no Essoign, Protection, or Wager of Law, nor more than One Imparlance, shall be allowed; and after Proof of such Person or Persons having so subscribed or agreed to subscribe, and that such Notice was given as aforesaid, a Verdict shall be given for the Plaintiss in all such Action and Actions, and Executions shall issue thereupon as the Case may require.

Persons aggrieved may appeal to the Quarter Sessions.

LXXII. Provided always, and be it further enacted, That if any Person, shall think himself or herself aggrieved by any. Thing done or omitted to be done in pursuance of this Act, either by the said Trustees, or by any One or more of His Majesty's Justices of the Peace, or by any other Person. or Persons whomsoever, such Person may appeal to the Justices of the Peace at the next General Quarter Sessions of the Peace to be holden for the County in which the Cause of Complaint shall arise, such Appellant (if there be sufficient Time after the Cause of such Complaint shall have arisen) first giving or causing to be given Eight Days Notice at least in Writing of his or her Intention of bringing such Appeal, and of the Matter thereof, to the Clerk or Treasurer to the said Trustees, and within Four, Days next after such Notice entering into a Recognizance before some, Justice of the Peace for the said County, with Two sufficient Sureties; conditioned to try such Appeal, and abide the Order thereon, and to pay such Costs as shall be awarded by the Justices at such Quarter Sessions; and for want of sufficient Time for giving such Notice, previous to the First Quarter Sessions after the Cause of such Complaint shall have happened, then such Appeal, after such Notice and under such Recognizance, may be made at the Second General Quarter Sessions of the Peace to be holden, for the said County; and the Justices at such First or Second Sessions, upon due Proof of fuch Notice having been given as aforesaid, and of the entering into such Recognizance, shall hear and finally determine the Cause and Matter of such Appeal in a summary Way, and award such Costs to the Parties appealing or appealed against as they the said Justices shall think proper; and the Determination of such Justices at such Quarter Sessions shall be final, binding, and conclusive to all Intents and Purposes; and the said Justices at such Sessions may also by their Order or Warrant levy such Costs so awarded by Distress and Sale of the Goods and Chattels of the Person or Persons who shall refuse or neglect to pay the same, and for want of sufficient Distress commit such Person or Persons to the Common Gaol or House of Correction for the County, there to remain for any Time not exceeding Three Calendar Months, or until Payment of such Costs.

Proceedings not to be quashed for want of Form.

LXXIII. And be it further enacted, That no Order made touching or concerning any of the Matters in this Act contained, or any Proceedings to be had touching the Conviction of any Offender or Offenders against this Act, shall be quashed for want of Form, or be removed or removable by Certiorari or any other Writ or Process whatsoever into any of His Majesty's Courts of Record at Westminster; and that where any Distress shall be made for any Sum or Sums of Money to be levied by virtue of this Act, the Distress itself shall not be deemed unlawful, nor the Party or Parties making the same be deemed a Trespasser or Trespassers, on account of any Defect or want of Form in the Summons, Conviction, Warrant of Distress, or other Proceedings relating thereto; nor shall the Party or Parties distraining

training be deemed a Trespasser or Trespassers ab initio on account of any Irregularity which shall be afterwards committed by the Party or Parties distraining; but the Person or Persons aggrieved by such Irregularity shall and may recover full Satisfaction for the special Damage (if any) in an Action on the Case; but no Plaintiff or Plaintiffs shall recover in any Action for such Irregularity as aforesaid, if Tender of sufficient Amends hath been made by or on behalf of the Party distraining before such Action brought.

LXXIV. And be it further enacted, That no Action or Suit shall be Limitation commenced against any Person or Persons, for any Thing done in pursuance of Actions. of this Act, until Twenty-eight Days Notice thereof shall be given to the Clerk or Clerks of the said Trustees, nor after a sufficient Satisfaction or Tender thereof hath been made to the Party or Parties aggrieved, nor after Three Calendar Months next after the Fact committed; and every such Action or Suit shall be laid or brought in the County where the Cause of Action shall have arisen, and not elsewhere; and the Defendant or Defendants in every such Action shall or may at his or their Election plead specially or the General Issue Not Guilty, and give this Act and the special General Matter in Evidence at any Trial to be had thereupon, and that the same was Issue. done in pursuance and by the Authority of this Act; and if the same shall appear to have been so done, or that such Action or Suit shall have been brought before Twenty-eight Days Notice thereof was given as aforesaid, or after a sufficient Satisfaction made or tendered as aforesaid, or shall be brought in any other County, then the Jury shall find for the Defendant or Defendants; and upon such Verdict, or if the Plaintiff or Plaintiffs thall be nonfuited, or discontinue his, her, or their Action or Suit after the Defendant shall have appeared, or if upon Demurrer Judgment shall be given against the Plaintiff or Plaintiffs, then the Defendant or Defendants shall recover Treble Costs, and have such Remedy for the same as any Defend- Treble Costs. ant or Defendants hath or have in any Cases by Law.

LXXV. And be it further enacted, That this Act shall be deemed and Public A&. taken to be a Public Act, and shall be judicially taken Notice of as fuch by all Judges, Justices, and others, without being specially pleaded.

LXXVI. And be it further enacted, That this Act shall commence upon Commenceand have Continuance from the Day of the passing thereof for and during ment and the Term of Twenty-one Years, and from thence to the End of the then Continuance next Session of Parliament.
