# GEORGII IV. REGIS.

An Act for making and maintaining a Road from Brighton to Shoreham Bridge in the County of [15th May 1822.] Sussex.

HEREAS it would be convenient, and tend to the Public Benefit, that a new and improved Road should be made and maintained, leading from the Town of Brighton in the County of Sussex, to the Eastern End of Shoreham Bridge in the same County; and that the said new and improved Road, together with such Parts of the present Road leading as aforesaid as shall be made Part of the said new and improved Road, should be made Turnpike: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That from and after the passing of this Act, this Act shall commence and take effect, and be put in execution, ment and for and during the Term herein-after mentioned, for the Purpose of con-Purpose of structing, making, amending, widening, turning, varying, altering, fencing, the Act. maintaining, and keeping in Repair the Road herein after mentioned.

II. And be it further enacted, That the said Road shall begin, commence, Line of and be made from the Western Extremity of the Parish of Brighton, and Road, shall lead from thence unto and through the several Parishes of Hove; Portslade, Southwick, Kingston-by-Sea, in the said County, and unto and [Local.]

through the High Street and the Market Place of the Town and Borough of New Shoreham in the said County, and from thence unto and through the Parish of Old Shoreham in the said County, and from thence unto the Gate or Toll House now standing and being at the Eastern Extremity of Shoreham Bridge in the said County.

Trustees appointed.

III. And be it further enacted, That all His Majesty's Justices of the Peace acting for the County of Sussex, together with Walter Burrell, Edward Jeremiah Curteis, Robert Parker, Robert Burnett, Charles Compton Cavendish, John Hall, Isaac Bass, Thomas Read Kemp, Charles Elliott, Thomas Clayton, Thomas West, John Edwards, Sir James Graham Baronet, Sir Matthew Tierney Baronet, Philip Walton, Smith Hannington, Edward Tate, George Tate, Lewis Loyd, John Tabor, Andrew A. Mieville, Thomas Harrington, George Henry Hooper, Doctor Carr Dean of Hereford, Reverend Doctor Hugh Pearson, John Wood, William Borrer, John Reay, William Day Beard, Benjamin Tillstone, Joseph Manton, Richard Tamplin, Edward Hill Creasy, B Gregory, Sir Charles Merrick Burrell Baronet, Sir Timothy Shelley Baronet, Thomas Crossweller senior, William Blaber, Reverend Doctor John Styles, Charles Malcolm, Amon Wilds, Reverend Richard W Hutchins, Lord George Cavendish, John Lashmar, William Wigney, S G tinez, Francis Skelton, Thomas Attree, John Richard Hawkins, Sir Henry Rycroft, and Joshua Flecher Hanson, and their Successors, to be elected in Manner herein after directed, shall be and they are hereby appointed Trustees for making, amending, widening, turning, varying, altering, fencing, and keeping in Repair the said Road, and for putting this Act into Execution.

Power to appoint additional Trustees.

IV. And be it further enacted, That it shall be lawful for the said Trustees, or any Three or more of them, and they are hereby authorized and empowered, at any of their Meetings to be holden in pursuance of this Act, to elect any Number of Persons (not exceeding Five in the Whole) to be Trustees for the Purposes of this Act, in addition to the Trustees hereby appointed, and such Trustees so elected and being duly qualified as herein-after mentioned, and having taken the Oath hereby prescribed, shall be invested with the like Powers and Authorities for executing this Act, as if they had been herein named.

Election of

V. And be it further enacted, That when and so often as any Trusnew Trustees. tee or Trustees hereby appointed, or to be appointed by virtue of this Act, shall die, or become disqualified by Bankruptcy, Insolvency, or otherwise, or incapable of acting in the Trusts aforesaid, or by Writing under his Hand delivered to the Clerk or Clerks to the Trustees shall refuse or decline to act, it shall be lawful for the surviving or remaining Trustees, or any Three or more of them, from Time to Time to elect, and by Writing under their Hands to nominate and appoint, some other Person in the Room of every Trustee so dying, or becoming disqualified, or refusing to act; and Notice of the Time and Place of Meeting for every such Election shall be given by any Two or more of the said Trustees, or the Clerk or Clerks to the said Trustees, by affixing Notice in Writing on all the Turnpike Gates which shall then be erected on the said Road, at least Ten Days before such Meeting; and all and every Person and Persons who shall be so elected and appointed shall, immediately upon such Election and Appointment, be a Trustee or Trustees for the Purposes of this Act; and after taking and subscribing the Oath herein-after prescribed, shall

shall be vested with the same Powers and Authorities for carrying this Act into Execution as if he or they had been herein nominated and appointed a Trustee or Trustees.

VI. Provided always, and be it further enacted, That no Person shall be capable of acting as a Trustee in the Execution of this Act, unless he shall, at the Time of his acting, be in his own Right, or in the Right of his Wife, in the actual Possession and Enjoyment of, or in the Receipt of Rents and Profits issuing out of Freehold or Copyhold Lands, Tenements, or Hereditaments of the clear yearly Value of One hundred Pounds above Reprises, or shall be Heir apparent of a Person seised of a Real Estate in Freehold or Copyhold Lands, Tenements, or Hereditaments of the clear yearly Value of Two hundred Pounds, or be possessed of a Personal Estate, or of a Real and Personal Estate together, of the Value of Four thousand Pounds after Payment of all just Debts; nor (except in administering the Oath or Affirmation hereinafter mentioned) until he shall have taken and subscribed, before any Two or more of the said Trustees, an Oath of Affirmation in the following Form of Words; and which Oath or Affirmation any Two or more of the said Trustees, at any of the Meetings to be holden in pursuance of this Act, are hereby authorized to administer:

Qualification of Trustees,

do swear, (or, being one of the People called Quakers, do solemnly affirm), That I truly and bona fide am, in my own Right, (or, 'in the Right of my Wife), in the actual Possession and Enjoyment of ' (or, in the Receipt of Rents and Profits issuing out of) Freehold or 'Copyhold Lands, Tenements, or Hereditaments, of the clear yearly 'Value of One hundred Pounds above Reprises, (or, am Heir appawho, to the best of my Knowledge, rent of 'is seised of a Real Estate, of Freehold or Copyhold Lands, Tenements, or Hereditaments, of the clear yearly Value of Two hundred Pounds), or am possessed of a Personal Estate, or of a Real and Personal Estate 'together, of the Value of Four thousand Pounds after all my Debts So help me GOD.' are paid (as the Case may be).

VII. Provided also, and be it further enacted, That no Person ap-Trustees inpointed or to be appointed a Trustee by virtue of this Act shall be terested or capable of acting as a Trustee in the Execution of this Act in any Case holding where he shall be concerned in Interest (except as herein-after provided), nor whilst he holds any Place or Employment of Profit, or shall be concerned or interested in any Contract or Contracts under this Act; tualling and that no Person shall be capable of being appointed a Trustee, or of acting as such, during the Time he shall keep a Victualling House, or other House of public Entertainment, or who shall sell Wine, Cider, Beer, Ale, Spirituous or other Strong Liquors, by Retail, or who shall be Lessee of Farmer of the Tolls, or of any Part or Parts thereof, under this Act; and if any Person not being qualified as aforesaid, or being disqualified by any of the Causes aforesaid, or not having taken and subscribed the Oath herein-before mentioned, or, being a Quaker, not having made and subscribed the Affirmation herein-before mentioned, shall nevertheless act as a Trustee in the Execution of this Act, every such Person shall, for every such Offence, forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same; to be recovered, with full Costs

Places of Profit, or keeping Vic-Houses, &c. not to act.

Costs of Suit, in any of His Majesty's Courts of Record at Westminster, by Action of Debt or on the Case, or by Bill, Plaint, Suit, or Information, wherein no Essoign, Protection, Wager of Law, or more than one Imparlance, shall be allowed; and the Person so sued or prosecuted shall prove that he is qualified as aforesaid, or otherwise shall pay the said Penalty, without any other Proof or Evidence on the Part of the Prosecutor, than that such Person hath acted as a Trustee in the Execution of this Act: Provided nevertheless, that all Acts and Proceedings touching the Execution of this Act, which shall be done and performed by any such Person previously to his being convicted of the Offence before mentioned, shall be as valid and effectual as if such Person had been qualified according to the Directions of this Act: Provided also, that no Mortgagee or Assignee of any Mortgage or other Security, or any Lender of Money upon the Credit of the Tolls, or receiving Interest thereout for the same, shall on that account be deemed disqualified to act as a Trustee in the Execution of this Act.

Trustees may act as Justices.

VIII. And be it further enacted, That any of the Trustees appointed or to be appointed under this Act, who are or shall be in the Commission of the Peace, may act as Justices of the Peace in the Execution of this Act notwithstanding their being such Trustees as aforesaid, except in Cases where they shall be personally interested, otherwise than as Mortgagees, Assignees, Lenders of Money, or Holders of any Security on the Credit of the Tolls granted by virtue of this Act.

First Meeting of Trustees.

Power to adjourn.

IX. And be it further enacted, That the said Trustees, or any Three or more of them, shall meet at the House known by the Name or Sign of the Old Ship, or some other convenient Place, in the Town of Brighthelmston in the County of Sussex, on the Second Tuesday next after the passing of this Act, or as soon after as conveniently may be, between the Hours of Ten in the Forenoon and Two in the Afternoon, and shall then and there proceed to the Execution of this Act, and shall or may adjourn, and from Time to Time afterwards meet there, or at any other Place on or near the said Road, as the said Trustees, or any Three or more of them, shall think proper and appoint, as often as it shall be necessary for carrying this Act into Execution: Provided always, that I'wo Trustees shall be sufficient for the Purpose of Adjournment only; and that in case a competent Number of Trustees shall not appear at the Time and Place appointed for the Meeting of the Trustees for carrying this Act into Execution, either to act or to adjourn, or in case the Trustees at any Time assembled shall omit or neglect to adjourn, then and in either of the said Cases it shall be lawful for the Clerk or Clerks to the said Trustees for the Time being, by a Notice in Writing to be affixed on all the Turnpikes and Toll Gates which shall then be erected upon the said Road, at least Ten Days before the next Meeting, to appoint a Meeting of the Trustees at the same Place where the last Meeting was held, or was appointed to have been held, on such future Day as shall be specified in such Notice, not exceeding One Month after the Day on which such Meeting was held or was to have been held as aforesaid; and in case such Clerk shall refuse or neglect to give Notice, or shall by any Means be prevented from giving Notice as aforesaid, it shall be lawful for any Three of the said Trustees, although not assembled at a Meeting, at any Time or Times after such Refusal, Neglect, or Prevention respectively as aforesaid, by Notice in Writing under

under their Hands, to be affixed in manner aforesaid, to appoint the Trustees to meet at some convenient House on or near the said Road; upon some convenient Day within One Month next after the Date of such last-mentioned Notice; and the said Trustees at all their Meetings shall defray their own Expences; and at every Meeting of the said Trustees a Chairman shall and may be appointed; and when and as often as it shall happen that there shall be an Equality of Votes at any such Meeting, including the Vote of the Chairman, then and in every such Case the Chairman shall have the decisive or casting Vote.

X. And be it further enacted, That all the Orders and Determinations Majority of of the said Trustees shall be made at Meetings to be held in pursuance of Trustees this Act, and not otherwise, (except as herein-after provided or mentioned) and all Acts, Matters, and Things, in or relative to the Execution of this Orders. Act, may be done and executed by the Majority of the Trustees present at any Meeting, (the whole Number present not being less than Three) except only in Cases herein particularly directed to be done by any greater or less Number of them; and that all Acts, Orders, and Proceedings, had, made, or done, by or before such Three Trustees, shall have the same Force and Effect, and be binding and conclusive on all Persons, and to all Intents and Purposes, as fully and effectually as if the same were had. made, done, or executed by or before all the said Trustees.

XI. And be it further enacted, That no Order made by any of the said How Orders Trustees shall be revoked or altered at any subsequent Meeting, unless the Number of Trustees present, and revoking or altering the same, shall exceed the Number of Trustees by whom such Order shall have been altered. made, and unless Ten Days Notice shall have been given by Two Trustees, to the Clerk or Clerks of the said Trustees, of their Desire to have a Meeting called at a Time and Place to be mentioned in such Notice, for the Purpose of taking into Consideration such Order, with a View to revoke or alter the same, or that it will be proposed to revoke, or alter such Order at the next adjourned Meeting; and in such Case, Notice shall be given by such Trustees, or by the Clerk or Clerks, Ten Days at the least before such Meeting, to such Trustees as were present when the Order was made, of the Intention to revoke or alter any such Order.

XII. And be it further enacted, That if after any Adjournment of the Meetings on said Trustees, it shall, upon any Emergency, be thought necessary that Emergencies. an earlier Day of Meeting should be appointed than the Day to which any Meeting shall have been adjourned, any Two or more of the said Trustees, or the Clerk or Clerks to the said Trustees (being authorized by an Order in Writing, signed by Three or more of the said Trustees), shall and may call a Meeting of the said Trustees, by Notice in Writing to be affixed on all the Turnpike Gates then standing on the said Road, Ten Days previous to the Time of such Meeting, at such Time and Place as such Trustees shall think proper, and order, direct, or appoint; and all Proceedings of the Trustees at such earlier Meeting shall be as valid as they would have been in case the Trustees had met in pursuance of any Adjournment; and such Meeting shall and may be adjourned, or be appointed to be held in such Manner as other Meetings under this Act are hereinbefore directed to be adjourned or appointed to be held, notwithstanding any former Adjournment to the contrary; and every such Adjournment [Local.]

shall be considered as an Adjournment of the original Meeting under this Act.

Proceedings to be entered in a Book and signed. XIII. And be it further enacted, That all Orders and Proceedings of the said Trustees shall be entered in a Book or Books to be kept for that Purpose, and such Orders and Proceedings, so entered, shall be signed by the Chairman at such Meeting, or by the Trustees making the same, or by the major Part of them, and attested by their Clerk or Clerks; which said Book or Books, and also the Book or Books herein-after directed to be kept for registering Mortgages and Assignments of the Tolls or Transcripts thereof, shall and may be read in Evidence in all Cases of Appeal, and in all Suits, Actions, Controversies, or Disputes, touching any thing done or to be done by virtue or in pursuance of this Act, or in anywise relating thereto.

Trustees may appoint Officers;

and remove them.

Officers to account;

or be punished.

XIV. And be it further enacted, That the said Trustees, at their First or any subsequent Meeting, as Occasion shall require, may, by Writing under their Hands, elect and appoint a Clerk or Clerks, and a Treasurer or Treasurers, Receiver or Receivers, and Collector or Collectors of such Money as shall arise and may become due and payable by virtue of this Act, and also a General Surveyor or Surveyors, and all such working and other Surveyors and other Officers, as they the said Trustees shall think necessary and proper to be employed in the Execution of the Powers of this Act; and also may remove, from Time to Time, all such Clerks, Treasurers, Collectors, Receivers, Surveyors, and other Officers, or any of them, as the said Trustees shall see occasion; but no Victualler or Retailer of Ale, Beer, or Spirituous Liquors, or any menial Servant of any Trustee, shall be appointed to or be capable of holding any Place of Profit under this Act; and the said Trustees shall and may, out of the Money to be raised or received by virtue of this Act, make such Allowance unto the Clerks, Treasurers, Receivers, Collectors, Surveyors, and other Officers so appointed, and to such other Persons as shall be assisting in and about the Execution of this Act, as to them the said Trustees shall seem proper; and every Officer and Person who shall be appointed as aforesaid, shall from Time to Time, when thereunto required by the said Trustees, by Writing under their Hands, make out and deliver to such Trustees, or to such Person or Persons as they shall for that Purpose appoint, a true and perfect Account in Writing under his or her Hand, of all Monies which shall have been by him or her had, collected, or received, and how, and to whom, and for what Purpose the same and every Part thereof hath or have been disposed of, together with the Vouchers and Receipts for such Payments; and every such Officer or Person shall and he is hereby required to pay all such Monies as upon the Balance of such Account shall appear to be owing from him or her to such Person or Persons as the said Trustees shall appoint to receive the same; and if any such Officer or Person shall refuse or neglect to render and deliver such Account as aforesaid, or to produce and deliver up the Vouchers and Receipts relating to the same, or to pay the Balance thereof, when thereunto required, in manner aforesaid, or shall refuse or neglect to deliver up to the said Trustees, or to such Person or Persons as they shall appoint, within Six Days after being thereunto required by the said Trustees, or by such other Person or Persons, all Books, Papers, and Writings in his or her Custody or Power relating to the Execution of

this Act, then and in every such Case a Complaint being made thereof by the said Trustees, or by any Person or Persons on their Behalf, of any such Neglect or Refusal, to any Justice of the Peace for the County or Place where the Officer or Person so neglecting or refusing shall live or reside, such Justice may, and he is hereby authorized and required, by Warrant under his Hand and Seal, to cause such Officer or Person to be brought before him, and upon his or her appearing, or not being to be found, to hear and determine the Matter of such Complaint in a summary Way, and to settle the said Account, if produced, in such Manner as the said Trustees might have done; and if upon the Confession of the Officer or Person against whom such Complaint shall be made, or by the Oath or Oaths of any credible Witness or Witnesses, it shall appear to such Justice that any of the Monies which shall have been collected or received shall be in the Hands of or owing from such Officer or Person, such Justice may, and he is hereby authorized and empowered, upon Non-payment thereof, by Warrant under his Hand and Seal, to cause such Money to be levied by Distress and Sale of the Goods and Chattels of such Officer or Person respectively; and if no Goods or Chattels can be found sufficient to answer and satisfy the said Monies, and the Charges of taking and making such Distress, and of selling the same; or if such Officer or Person shall not appear before the said Justice at the Time and Place appointed for that Purpose, without some reasonable Excuse, or if appearing, shall refuse or neglect to make out and deliver to the said Justice such Account in Writing as aforesaid, (if so required by the said Justice), or to produce and deliver up to the said Justice the several Vouchers and Receipts relating to such Accounts, or to deliver up as aforesaid all such Books, Papers, and Writings as aforesaid, then and in any of the Cases aforesaid, the said Justice may, and he is hereby authorized and required, by Warrant under his Hand and Seal, to commit such Officer or Person to the Common Gaol or House of Correction of the County or Place where he or she shall live or reside, there to remain, without Bail or Mainprize, until he or she shall have delivered up the Vouchers and Receipts relating thereto, and shall have paid all the Money which shall appear to be in the Hands of or owing from him or her, and the reasonable Charges of such Distress and Sale (if any) as shall in that respect have been made, or until he or she shall have compounded with the said Trustees for such Money and Charges, and paid the Composition Money to the said Trustees, or to such Person or Persons as they shall appoint to receive the same (and which Composition the said Trustees are hereby empowered to make), and shall have delivered up as aforesaid all such Books, Papers, and Writings as aforesaid, or have given Satisfaction in respect thereof to the said Trustees: Provided always, that no Person who shall be committed for want of sufficient Distress, shall be detained in Prison by virtue of this Act for any longer Space of Time than Six Calendar Months.

XV. Provided always, and be it further enacted, That it shall not Clerk rebe lawful for the said Trustees to appoint the Person who may be strained from appointed to act as their Clerk in the Execution of this Act, or the acting as Partner of any such Clerk, the Treasurer for the Purposes of this Treasurer, and vice Act, or to appoint the Person who may be appointed Treasurer, or the versa. Partner of any such Treasurer, the Clerk to the said Trustees for executing this Act; and if any Person shall act in both the Capacities of

Clerk and Treasurer for the Purposes of this Act, or if any Person being the Partner of any such Clerk shall act as Treasurer, or being the Partner of any such Treasurer shall act as Clerk in the Execution of this Act, every Person so offending shall, for every such Offence, forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same, to be recovered, with full Costs of Suit, in any of His Majesty's Courts at Westminster, by Action of Debt, or on the Case, or by Bill, Suit, or Information, wherein no Essoign, Protection, or Wager of Law, or more than one Imparlance shall be allowed.

Treasurer to give Security.

XVI. And be it further enacted, That the said Trustees shall, and they are hereby required to take such sufficient Security as they shall think fit from the Treasurer or Treasurers to be appointed for the Purposes of this Act, for the due and faithful Execution of his and their said Office and Offices, and may also, if they think fit, take such Security from any other Officer to be appointed by virtue of this Act.

Accounts of Receipts and Disbursements to be kept, which to the Inspection of the Trustees and Creditors.

XVII. And be it further enacted, That the said Trustees shall, and they are hereby required, from Time to Time, and at all Times during the Continuance of this Act, to order and direct a Book or Books to be provided and kept by their Clerk or Clerks for the Time being, in which Book or shall be open Books such Clerk or Clerks shall enter, or cause to be entered, true and regular Accounts of all Sums of Money received, paid, laid out, and expended, for and on account of the said Road, and of the several Articles, Matters, and Things for which Sums of Money have been disbursed, laid out, and paid; which Book or Books shall at all seasonable Times be open to the Inspection of the said Trustees, or any Creditor or Creditors on the Tolls hereby granted, without Fee or Reward; and the said Trustees or Creditors, or any of them, shall or may take Copies of or Extracts from the said Book or Books, or any Part or Parts thereof, without paying any thing for the same; and in case the said Clerk or Clerks shall refuse to permit, or shall not permit the said Trustees or such Creditors to inspect the same, or to take such Copies or Extracts as aforesaid, such Clerk or Clerks shall forfeit and pay any Sum not exceeding Ten Pounds, to be levied and recovered as herein-after mentioned.

Trustees may sue and be sued in the Name of their Clerk, &c.

XVIII. And be it further enacted, That the said Trustees may sue and be sued in the Name of any One of the said Trustees, or of their Treasurer or Treasurers, or of their Clerk or Clerks for the Time being, and that no Action or Suit to be brought or commenced by or against the said Trustees or any of them by virtue of this Act, in the Name of such Trustee, Treasurer or Treasurers, Clerk or Clerks, shall abate or be discontinued by the Death or Removal of such Trustee, Treasurer or Treasurers, Clerk or Clerks, but that One of the said Trustees, or the Treasurer or Treasurers, Clerk or Clerks for the Time being to the said Trustees, shall always be deemed the Plaintiff or Plaintiffs, Defendant or Defendants in such Action or Suit, as the Case shall be: Provided always, that every such Trustee, Treasurer or Treasurers, Clerk or Clerks, shall be reimbursed out of the Monies to be raised by virtue of this Act, all such Costs and Charges as he or they shall be put unto or become chargeable with by reason of his or their being so made Plaintiff or Plaintiffs, Defendant or Defendants.

And be it further enacted, That when and as often as any Collector or Receiver of the Tolls by this Act granted, shall neglect to perform, temporary or be incapable of performing his Duty, or shall abscond or absent himself, Collectors. any Two or more of the said Trustees (although not assembled at a Meeting of the said Trustees appointed by virtue of this Act) may discharge such Collector or Receiver so neglecting, or being incapable of performing his Duty, or absconding or absenting himself, and in such Case, and also in case any such Collector or Receiver of the Tolls shall die, the said Trustees, or any Two or more of them, shall and may nominate and appoint a proper Person to be a Collector or Receiver of the said Tolls, to continue until the then next Meeting of the said Trustees, in the Stead of such Collector or Receiver who shall so die or be discharged; and such Person so nominated and appointed shall have the like Power and Authority as the Person who shall so die or be discharged would have had, and shall be answerable and accountable in the same Manner in all respects as such Person would have been; and if any Collector or Receiver of the said Tolls, who shall be discharged from his Office by virtue of this Act, or the Wife or Widow, or any of the Children, Family, or other Representative or Representatives of any Collector or Receiver who shall die or be discharged, or any other Person shall refuse to deliver up the Possession of the Toll Gate or Toll House, or any of the Appurtenances thereof, for the Space of Two Days next after Demand thereof made, and Notice in Writing given for that Purpose, by any Two or more of the said Trustees, (although not assembled at a Meeting), or by the Clerk or Clerks or Treasurer or Treasurers to the said Trustees for the Time being, then and in any of the said Cases it shall be lawful for any Justice or Justices of the Peace for the said County, by Warrant under his or their Hand or Seal, or Hands and Seals, to order any Constable or other Peace Officer, with such Assistance as shall be necessary, to enter such House and Appurtenances, in the Day-time, and to remove the Person or Persons who shall be found therein, or in the Possession of such Toll Gate or Toll House, together with his, her, or their Goods, out of and from the same, and to put the said Trustees, or any of them, or such new appointed Collector or Receiver, into the Possession of such Toll Gate, Toll House, and Appurtenances.

XX. And be it further enacted, That the said Trustees shall and may, For erecting and they are hereby authorized and empowered, to erect, or cause to be Toll Gates. erected, any Turnpike or Turnpikes, Toll Gate or Gates, Bar or Bars, Chain or Chains, in, upon, or across any Part or Parts of the said Road, (except as herein-after is excepted), and upon the Sides thereof, across any Lane or Way that doth or shall lead into or out of the same, (except as herein-after is excepted, and provided such Lane or Way be not a Turnpike Road), and also to erect or provide a Toll House, with suitable Out-buildings and Conveniences, at or near each Toll Gate; and that the said Trustees shall and may, from Time to Time afterwards, remove, alter, or discontinue such Turnpikes, Toll Gates, Bars, Chains, or Toll Houses, or any of them, as they the said Trustees shall think expedient; and also shall and may take in and inclose from the Sides of the said Road convenient Garden Spots for the Toll Houses respectively, not exceeding One-eighth Part of an Acre to each Toll

No Toll Gate to:be:removed, nor any new Toll. Gate set up Notice.

XXI. Provided nevertheless, and be it further enacted, That no Removal, Alteration, or Discontinuance of any such Tumpike or Tumpikes, Toll Gate or Gates, Bar or Bars, Chain or Chains, shall be made, nor shall any fresh Turnpike or Turnpikes, Toll Gate or Gates, Bar or Bars, Chain or Chains, without Two be erected or set up, after the First Meeting of the said Trustees, in which any Turnpike or Turnpikes. Toll Gate or Gates, Bar or Bars, Chain or Chains, shall be ordered and directed to be erected and set up, unless Notice of the Intention to make such Removal or Alteration, or to erect or set up such fresh Turnpike or Turnpikes, Toll Gate or Gates, Bar or Bars, Chain or Chains, and of the Meeting to be holden for that Purpose, be given upon all the Toll Gates, which shall then be standing upon the said Road, at least Ten Days before such Meeting.

XXIII. Provided also, and be it further enacted, That no Turnpike or Turnpikes, Toll Gate or Toll Gates, Bar or Bars, Chain or Chains, shall be erected on any Part of the said Road or upon the Sides thereof, across any Lane or Way-leading into or out of the same, which shall lie West of the Extremity of Two Furlongs, to be measured from the Western Extremity of the South End of a certain Lane or Road now leading from the Upper Road leading from Shoreham Bridge, to and through the Parish and Village of Hove, and thence into the Parish and Town of . Brighthelmston aforesaid.

Toll Gates, Houses, &c. vested in Trustees.

XXIV. And be it further enacted, That the Right and Property of and in all the Turnpikes, Toll Gates, and Toll Houses, and the several Conveniences and Appurtenances thereto belonging, erected or made, or to be erected or made upon or on the Sides of the said Road, or any of them, or any Part thereof, and all Materials for building and repairing the same, and for repairing the said Road, or any Part thereof; and all Fences and Rails to be erected and set up by the said Trustees upon or on the Sides of the said Road, and all Mile Stones and Direction Posts to be set up or erected upon or on the Sides of the said Road, and all other Materials, Articles, and Things which shall be purchased, collected, or provided for the Purpose of the said Road, or of this Act, shall be vested in the said Trustees; and they are hereby empowered to sell or dispose of the same as they shall think proper, and to bring or cause to be brought any Action or Actions, or prefer or eause to be preferred and prosecuted any Bill or Bills of Indictment against any Person or Persons who shall break down or damage, steal or take away, any of such Turnpikes, Toll Gates, Toll Houses, Fences, Rails, Mile Stones, Direction Posts, Conveniences, Appurtenances, Materials, Articles, or Things, or disturb them the said Trustees, or their Agents or Servants, in the Possession thereof; in all which Actions or Bills of Indictment it shall be sufficient to state generally such Turnpikes, Toll Gates, Toll Houses, Fences, Rails, Mile Stones, Direction Posts, Conveniences, Appurtenances, Materials, Articles,

Articles, or Things, to be the Property of the Treasurer or Treasurers, Clerk or Clerks for the Time being to the said Trustees.

XXV. And be it further enacted, That it shall be lawful for the said Power to take Trustees, or any Person or Persons appointed by virtue of this Act Tolls. Collector or Collectors as aforesaid, to demand and take, at each and every Turnpike or Toll Gate erected by virtue of this Act, and from the Owner or Owners of, or Person or Persons using, leading, driving, or attending any Horse, Beast, Cattle, or Carriage, before any Horse, Beast, Cattle, or Carriage shall be permitted to pass through the same, (subject to the Provisions and Restrictions herein-after contained), the following Sums or Tolls, or such Sums or Sum, not exceeding the following Sums or Tolls respectively, as the said Trustees, at any of their Meetings, shall from Time to Time appoint or order; (that is to say),

For every Horse, Mule, or other Beast drawing any Coach, Berlin, Landau, Machine, Hearse, Chariot, Chaise, Caravan, Calash, Chaise Marine,

Chair or other such Carriage, the Sum of Three-pence:

For every Horse, Mule, or Pair of Oxen, Bullocks, or other Neat Cattle, drawing any Waggon, Wain, Dray, Cart, or other such Carriage with Wheels of less Breadth than Six Inches, the Sum of Threepence:

For every Horse, Mule, Ass, or Pair of Oxen, Bullocks, or other Neat Cattle, drawing any other Carriage of the like Nature, with Wheels of the Breadth of Six Inches or upwards, the Sum of Two-pence:

For every Horse, Mule, or Ass, laden or unladen, and not drawing, the Sum of One Penny:

For every Drove of Oxen, Cows, or Neat Cattle, the Sum of Ten-pence per Score, and so in proportion for any greater or less Number:

And for every Drove of Sheep, Lambs, or Swine, the Sum of Five-pence per Score, and so in proportion for any greater or less Number:

For every Horse or other Beast of Draught, drawing any Carriage or Carriages Carriages laden with Timber, Plank, Boards, Wood, Bricks or Tiles, laden with Iron in Bars, Gun Iron, or any other Iron, Hop Poles, Marl, Chalk Timber, &c. Marl, or Chalk Sand, Stones, Gravel, Coals or Culm, passing through to pay the said Turnpike or Turnpikes, Toll Gate or Toll Gates, Bar or Tolls. Bars, Chain or Chains, between the Twentieth Day of October and the First Day of April in every Year, Double the Tolls which the same would otherwise hereby be liable to pay at each such Turnpike or Turnpikes, Toll Gate or Toll Gates, Bar or Bars, Chain or Chains, through which such Carriage or Carriages so laden shall pass:

And upon Payment of any of the said Tolls, the Collector or Receiver shall deliver gratis to the Person paying such Toll a Note or Ticket denoting such Payment; and all such Notes or Tickets shall be provided by the said Trustees or their Lessees, and there shall be printed or written and specified thereon the Name of the Gate or Bar at which the Toll is received, and of the Gate or Gates or Toll Bars, if any, which shall be freed by such Payment.

XXVI. And be it further enacted, That the respective Sums of Money For Recovery hereby authorized to be taken as aforesaid shall be demanded and taken in of Tolls. the Name of or as Tolls, and shall be and are hereby vested in the said Trus-

tees, and shall be applied as herein-after is directed; and if any Person subject or liable to the Payment of any of the said Tolls shall, after Demand thereof made, neglect or refuse to pay the same, or any Part or Parts thereof, it shall be lawful for the Person or Persons authorized and appointed to collect such Tolls as aforesaid, by himself, or themselves, or taking such Assistance as he or they shall think necessary, to seize and distrain any Horse, Beast, Cattle, Carriage, or other Thing, upon or in respect of which any such Toll is hereby imposed, together with their respective Bridles, Saddles, Gears, Harness, or Accoutrements (except the Bridles or Reins of any Horse or other Beast separate from the Horse or Beast), or any Carriage, in respect of the Horses or Cattle drawing the Carriage on which such Toll is imposed, or any of the Goods or Chattels of the Person or Persons so neglecting or refusing to pay; and if the Toll, or any Part thereof, so neglected or refused to be paid, and the reasonable Charges of such Seizure and Distress, shall not be paid within the Space of Four Days next after such Seizure and Distress made, the Person or Persons so seizing and distraining may sell the Horse, Beast, Cattle, Carriages, or Things so seized and distrained, or a sufficient Part thereof, returning the Overplus of the Money arising by such Sale (if any), and what shall remain unsold, upon Demand, to the Owner thereof, after such Tolls, and the reasonable Charges occasioned by such Seizure, Distress, and Sale, shall be deducted.

For settling Disputes concerning the Tolls.

XXVII. And be it further enacted, That if any Dispute shall happen about the Amount of the Tolls due, or the Charges of making, keeping, or selling any Distress, such Dispute shall be settled and ascertained by some Justice of the Peace for the said County of Sussex, who, on Application made to him for that Purpose, shall examine the Matter on the Oath of the Parties, or other Witness or Witnesses, and shall determine the Amount of the Tolls due, and shall award such Costs and Charges to either Party, as to the said Justice shall appear right and proper; all which Costs and Charges shall and may be levied and recovered, in case of Non-payment thereof forthwith, by Distress and Sale of the Goods and Chattels of the Person or Persons liable to pay the same, by Warrant under the Hand and Seal of such Justice, rendering the Overplus (if any) on Demand, after deducting the Costs and Charges of making such Distress and Sale, to the Person or Persons whose Goods and Chattels shall be so distrained and sold.

XXVIII. And be it further enacted, That the said several Tolls shall commence and take effect at such Time, or respective Times, as the said Trustees shall at their First or any subsequent Meeting or Meetings think proper and direct.

XXXVII. And whereas no Cart or other Carriage drawn by One Horse Carriages or Two Oxen, at present is subject to be weighed, and great Injury may drawn by be done to the aforesaid Road from the heavy Loads carried thereby; be it therefore enacted. That it shall be lawful for the said Trustees to order or to be. cause any such Cart or other Carriage, although the same shall be drawn weighed. only by One Horse or Two Oxen, or other Neat Cattle, to be weighed at any Weighing Engine to be erected upon any Part of the said Road;

Penalty on evadingTolls.

XXXVIII. And be it further enacted, That if any Person or Persons shall ride, drive, go, or pass, with any Horse, Beast, Cattle, or Carriage, through or over any Gate, private Passage, Land, Ground, or Place, lying by the Side of or near to any Part of the said Road, (except the Owner or Occupier of such Land or other Premises, or any of his, her, or their Family or Servants); or if any Person or Persons owning or occupying any Land, Ground, or Place situate as aforesaid, (the same not being a public Highway or Road) shall knowingly or wilfully permit or suffer any other Person or Persons (except as aforesaid) to go or pass with any Horse, Beast, Cattle, or Carriage, through or over such Gate, private Passage, Land, Ground, or Place, in order or with intent thereby to evade the Payment of the said Tolls, or any Part thereof, or shall leave upon or near any Part of the said Road, any Horse or Horses, or other Beast or Cattle, or any Carriage chargeable with the Payment of any of the said Tolls, with intent to evade Payment of any of the said Tolls; or if any Person or Persons shall forcibly or fraudulently pass through any such Turnpike or Toll Gate with any Horse, or other Cattle or Beast, without Payment of Toll; or if any Person claiming any Exemption from the Payment of the Tolls hereby granted, or any Part thereof, shall refuse or decline to give his or her Name and Place of Residence to the Collector or Collectors of the Tolls, at any Gates or Gate at which such Exemption shall be claimed, or shall give a false Name or Place of Residence; all and every such Person or Persons shall, for each and every such Offence, forfeit and pay any Sum not exceeding Five Pounds, to be recovered in such Manner as herein-after provided for the Recovery of Penalties and Forfeitures; one Moiety whereof, when raised, shall be paid to the Informer, and the other Moiety to the Treasurer of the Road on which the Penalty shall be incurred, to be applied to the Purposes of this Act.

Authority of this Act, to begin to dig, gather, get, take, or carry away any Materials for constructing, making, or repairing the said Road, out of or from any inclosed Land or Ground, until after Six Days Notice in Writing, signed by the Surveyor, shall have been given to the Owner or Owners of the Premises from which such Materials are intended to be taken, or his known Agent, or to the Occupier of the Premises from which such Materials are intended to be taken, or left at the House or last or usual Place of Abode of such Owner or Occupier, to appear before any Two Justices of the Peace acting in and for the County where the Lands from whence such Materials are intended to be taken shall lie, to shew Cause why such Materials shall not be had therefrom; and in case such Agent, Owner, or Occupier shall attend pursuant to such Notice, but shall not shew sufficient Cause to the contrary, such Justices shall, if they think proper, authorize such Surveyor or other Person to dig, get, gather, take, and carry away such Materials, at such Time or Times as to such Justices shall seem proper; and if such Agent, Owner or Occupier shall neglect or refuse to appear by himself or herself, or his or her Agent, such Justices shall and may, upon Proof on Oath of the Service of such Notice, and which Oath they are hereby empowered to administer, make such Order therein as they shall think fit, as fully and effectually, to all Intents and Purposes, as if such Owner or Occupier, or his or her Agent, had attended.

LXXIII. And be it further enacted, That if any Person whomsoever Penalty on shall take away any Materials which shall be dug, gotten, or gathered taking away for the Repair or Use of the said Road, or shall raise or carry away any Materials out of, or otherwise interfere with or obstruct the working Surveyors. of any Pit or Quarry, which shall have been made and opened for the Purpose of getting Materials for constructing, making, and repairing the said Road, before the said Surveyors or their Workmen shall have discontinued working therein for the Space of Six Weeks, (except the Owner or Occupier of the Land in which such Pit or Quarry shall be made, as to Materials for his own private Use only, and not for Sale), every Person so offending shall for every such Offence forfeit and pay a Sum not exceeding Five Pounds.

Materials raised by

LXXIV. And be it further enacted, That in case the respective Surveyor Heaps of or Surveyors of the said Road, or any Undertaker or Undertakers for the Materials not Repairs thereof, or any Part thereof, or any Person acting by or under the Road. their Authority, shall lay or cause to be laid upon the said Road, or on the Sides thereof, any Heap of Stones or other Materials for the Repair thereof, or any Part thereof, and shall permit or suffer the same to remain longer than shall be necessary for spreading or laying such Stones or Materials over or upon the said Road, every such Surveyor, Undertaker, or Person offending shall, for every Offence, forfeit and pay any Sum not exceeding Forty Shillings.

LXXV. Provided always, and be it further enacted, That it shall and may Powers to be lawful for the said Trustees to contract and agree with any Person or contract for Persons whomsoever capable and willing to sell and demise, for the Pur- Land to get chase or Demise from him, her, or them, of and to hold any Land or Ground for the Purpose of digging Stone and Materials therefrom, for the Repairs or Use of the said Road, or any Part thereof, and Local.

at any Time afterwards to sell the Land of Ground so purchased, by public Auction or Tender: Provided always nevertheless, that the entering into any such Contract or Agreement as last aforesaid shall not be compulsory against any Person or Persons unwilling to enter into the same: Provided also, that the said Trustees shall not hold at any one Time or Period a greater Quantity of such Land or Ground in the whole than Six Acres.

No Floodgates or Obstructions in the Waterinjure the Road. take Stone, Sand, Drift, or Scrapings off the Road without Licence.

LXXVI. And be it further enacted, That if any Person shall erect or place any Sluice, Dam, Flood Gate, or other Obstruction in any Brook or Watercourse, whereby, or by Means whereof, the said Road, or any Part therecourses to be of shall be flooded, damaged, or injured, or rendered unsafe, or shall made so as to make, lay, or open any new Ditch, Drain, Pipe, or Watercourse, into the said Road, or take, remove, or carry away any Stone, Sand, Drift, or Scrapings, from off the said Road, or from off the Sides thereof, or from No Person to any Place or Places where the same shall have been laid or deposited by the said Trustees, or any Person or Persons employed by them, without Licence or Consent in Writing for that Purpose first had and obtained from the said Trustees, or their Surveyor, then, and in every such Case, it shall be lawful for the Surveyor to the said Trustees, and the several Workmen to be employed by him, to take down and remove every such Sluice, Dam, Floodgate, or other Obstruction, and to convert the Materials thereof for the Benefit of the said Road, and also to stop, fill up, and destroy all and every such Ditches, Drains, Pipes, and Watercourses; and the Person erecting or placing such Sluice, Dam, Flood-gate, or other Obstruction, or making, opening, deepening, widening, or taking, removing, or carrying away such Stone, Sand, Drift, or Scrapings, without such Consent or Licence as aforesaid, or causing or procuring the same so to be done, shall for every such Offence forfeit and pay to the said Trustees any Sum not exceeding Five Pounds, over and above the Costs and Charges of taking up and removing such Sluice, Dam, Floodgate, or other Obstruction, or filling up such Ditch, Drain, Pipe, or Watercourse, or pulling down or removing such Buildings, Walls, or other Fences as aforesaid:

Penalty for erecting En-, on the Side of Roads.

LXXVII. And be it further enacted, That if any Person shall encroach upon the said Road, by making or causing to be made any Dwelling croachments House or other Building, Hedge, Ditch, or other Fence (except Turnpike Houses or other Buildings erected by Order of the said Trustees), every Person so offending shall forfeit, for every such Offence, the Sum of Five Pounds to such Person as shall give Information of the same; and it shall be lawful for the said Trustees, by Order under their Hands, made at a Meeting, or some Adjournment thereof, directed to their Surveyor, to cause such Dwelling Houses, Buildings, Hedges, Ditches, or other Fences to be taken down or filled up at the Expence of the Person or Persons to whom the same shall belong; and it shall and may be lawful for any one or more Justice or Justices of the Peace in and for the County or Place where the Premises shall be situate, upon Proof thereof to him or them made upon Oath, which Oath any such Justice is hereby empowered to administer, to levy as well the Expences of taking down such Dwelling Houses, Buildings, Hedges, and Fences, and filling up of the Ditches aforesaid, as the Penalty hereby imposed, by Distress and Sale

of the Offender's Goods and Chattels, rendering the Overplus to the Owner or Owners, on Demand.

LXXVIII. And be it further enacted, That it shall be lawful for the said Preventing Trustees, or their Surveyor or Surveyors, and such Person or Persons Annoyances. as he or they shall appoint, from Time to Time to remove and prevent on the Road. all Annoyances by Timber, Stone, Carriages, Hovels, Linie, Mortar, Filth, Dung, Ashes, Rubbish, Straw, or other Things being laid on any Part of the said Road, or upon Open, Common, or Waste Land, within Thirty, Feet of the Centre thereof, and to dispose of the same for the Benefit of the said Road, in case the Owners thereof shall neglect to remove the same for the Space of Seven Days after Notice in Writing, signed by the Surveyor, given to such Owners for that Purpose; or in case the Owners are not known, after a like Notice affixed for Seven Days on the nearest Turnpike Gate; and to turn any Watercourses, Sinks, or. Drains running along, into, or out of the said Road to the Prejudice thereof, and to open, scour, cleanse, widen, or make deeper any Watercourses or Ditches adjoining or near thereto, and to make the same as deep and large as he or they shall think it necessary; and to cut down or lop any Branches, Shrubs, or Bushes growing on or over the said Road, or in the Hedges or Banks adjacent thereto (not being a Garden, Orchard, Plantation, Walk, or Avenue to a House, or any Trees being an Ornament or Shelter to a House), and to take and carry away the same; and to cut and reduce all such Hedges to the Height of Four Feet, in case the Owners or Occupiers of the Premises shall, for the Space of Seven Days next after Notice in Writing given for that Purpose by such Surveyor or Surveyors, neglect to top, lop, cut down, or remove such Branches, Shrubs, or Bushes, or to open, scour, cleanse, widen, or deepen such Watercourses or Ditches, or remove such other Annoyances, in such Manner as the said Trustees or the said Surveyor or Surveyors shall require, the Charges whereof to be settled by the said Trustees shall be reimbursed to such Surveyor or Surveyors by such Owners or Occupiers, and be recovered and applied in such Manner as the Penalties and Forfeitures imposed by this Act are herein-after directed to be recovered and applied; and if after the Removal of any of the said Annoyances any Person shall offend again in like Manner, every such Person shall, for every such Offence, forfeit and pay any Sum not exceeding Five Pounds.

LXXIX. And be it further enacted, That it shall be lawful for the Sur- Power to veyor or Surveyors of the said Road, and such Persons as they shall make Causeappoint by Order of the said Trustees, to make and keep in Repair, or ways, cause to be made and kept in Repair, any Causeway or Causeways for Drains, &c. the Use of Foot Passengers, in, upon, or on the Sides of the said Road, in such Manner as they shall think proper, and also to erect and set up Rails and Fences in, upon, or on the Sides of the said Road or any Part thereof, in such Manner as they shall think proper; and also to make and keep in Repair, or cause to be made and kept in Repair, Ditches or Drains in and upon the said Road, and also through any Ground lying contiguous or near thereto (not being a Garden, Orchard, Yard, Paddock, Planted Walk, or Avenue to any House, or any Piece of Ground planted and set apart as a Nursery for Trees), and to erect, rebuild, and keep in Repair all Bridges, Culverts, and Arches upon the said Road, or across

any of the Ditches, Watercourses, or Drains, where necessary; and also to make or cause to be made a Road through the Grounds adjoining to any ruinous or narrow Part of the said Road (not being the Site or Ground whereon any House or Houses stand, nor being a Yard, Garden, Orchard, Park, Paddock, planted Walk, or Avenue to any House, or any inclosed Ground planted and set apart as a Nursery for Trees), to be made use of by all Passengers, Cattle, and Carriages as a public Highway whilst the old Road is repairing or widening, and till such Time as it shall be convenient for Passengers and Carriages to pass along the same, making such Recompence to the Owners or Occupiers of such private Grounds' respectively for the Damages they shall or may thereby sustain, as shall. be adjudged reasonable by the said Trustees; and in case of any Difference concerning such Damages, between such Owners or Occupiers and such: Trustees, that then it shall and may be lawful for any Two or more Justices of the Peace acting in and for the County wherein such Grounds' shall be situate, on Fourteen Days Notice in Writing being given by either Party to the other, to settle, adjudge, and determine what Recompence shall be made to such Owners and Occupiers for the Damage they shall have sustained as aforesaid.

Roads to be measured and Mile Stones set up

LXXX. And be it further enacted, That the said Trustees shall cause the said Road to be measured, and Stones or Posts to be set up in or near the same, at the Distance of One Mile from each other, with Inscriptions thereon denoting the Number of Miles and Distance of Places, as they shall think proper; and also such and so many Direction Posts as they shall judge necessary or proper; and shall also set up, or cause to be set up, a Boundary Stone at the Termination of the said Road.

Penalty on Stones, riding, &c. upon Causeways, or committing any Annoyances upon the Road.

LXXXI. And be it further enacted, That if any Person or Persons shall, defacing Mile ride upon any Footpath or Causeway by the Side of the said Road, made or set apart for the Use or Accommodation of Foot Passengers, or shall lead. or drive, or permit any Horse, Swine, or Cattle, or Carriage of any Decription to pass or remain upon any such Footpath or Causeway, or shall cause any Injury or Damage to be done to the same, or the Hedges, Posts, Rails, or Fences thereof; or shall wilfully pull up or damage any of the Hedges, Posts, Rails, or Fences in, upon, or on the Sides of the said Road, or any Direction or Mile Post or Stone erected or fixed, or to be erected or fixed, in or near the Side or Sides of the said Road, or shall obliterate or deface any of the Letters, Figures, or Marks inscribed thereon, or shall wilfully damage any Bridge, Wall, or other Erection made or erected by the said Trustees, repaired or repairable by them; or. shall haul or draw, or cause to be hauled or drawn, upon any Part of the said Road any Timber, Stone, or other Thing, otherwise than upon, Wheel Carriages; or shall suffer any Timber, Stone, or other Thing which shall be carried upon Wheel Carriages, to drag or trail upon any Part of the said Road, to the Prejudice thereof; or shall, in or upon any Part of the said Road, or by the Side or Sides thereof, or in any exposed Situation near thereto, kill, slaughter, singe, scald, dress, or cut up any Beast, Swine, Calf, Lamb, or other Cattle; or if any Person driving any Horse or other Beast on the said Road, carrying Iron in Bars or Rods, or any other Matter or Thing, shall place such Bars or Rods, Matter or Thing, so that the same shall project more than Thirty Inches from

the Side of such Horse or other Beast, or so as in any Manner to obstruct or impede the Passage of any Person, or any Horse, Beast, or Carriage travelling along the said Road; or if any Hawker, Higler; Gipsey, or other Person or Persons travelling with any Machine, Vehicle, Cart, or other Carriage, with or without any Horse, Mule, or Ass, shall pitch any Tent or encamp upon or by the Sides of any Part of the said Road; or if any Blacksmith or other Person occupying a Blacksmith's Shop situate near the said Road, and having a Window or Windows fronting the said Road, shall not by good and close Shutters, every Evening after it becomes Twilight, bar and prevent the Light from such Shop shining into or upon the said Road; or if any Person or Persons shall make or assist in making any Fire or Fires, commonly called Bonfires; or shall set fire to, or let off or throw off any Squib, Rocket, Serpent, or Firework whatsoever, on any Part of the said Road, or within Eighty Feet of the Centre thereof; or shall blow or blast any Rock or Quarry on any Part of the said Road, or on the Sides thereof, or on the Banks thereof, or in any exposed Situation near thereto; or play at Football or any other Game or Games upon the said Road, or any Part thereof, to the Annoyance of any Passenger or Passengers; or if any Person shall leave any Waggon or other Carriage whatsoever (except in Case of Accident), upon any Part of the said Road, or on the Side or Sides thereof, without any proper Person in the sole Custody; or Care thereof, longer than may be necessary to load or unload the same, or shall not place the same, during the Time of loading or unloading thereof, as near to the Side of the Road as conveniently may be, either with or without any Horse or Beast of Draught harnessed or yoked thereto; or shall lay any Timber, Stone, Hay, Straw, Dung, Manure, Soil, Ashes, Rubbish, or other Matter or Thing whatsoever, upon any Part of the said Road, or on the Side or Sides thereof, or on the Footpaths or Causeways adjoining, to the Prejudice of such Road or Footways, or the Prejudice, Annoyance, or Interruption of the Persons travelling thereon; or if any Person driving any Pigs or Swine upon the said Road, shall suffer such Pigs or Swine to root up or damage the said Road, or any Part thereof, or the Fences, Hedges, or Banks on either Side thereof respectively; or if any Person shall, after having blocked or stopped any Cart or other Carriage in going up a Hill or rising Ground, cause or suffer to be or remain on the said Road or any Part thereof, the Stone or other Thing with which such Cart or other Carriage shall have been blocked or stopped; or if the Driver of any Waggon or other Carriage used for the carrying of Goods and Merchandize, shall ride on the Shafts or any other Part of such Waggon or other Carriage, or on any of the Horses drawing the same, upon any Part of the said Road; and if any such Person, meeting another Coach, Chaise, Waggon, Cart, or other Carriage, shall not keep his or her Carriage on the left or near Side of the said Road; or if any Person shall in any manner wilfully prevent any other Person or Persons from passing him or her, or any Coach, Chaise, Waggon, Cart, or other Carriage under his or her Care, upon the said Road; every Person offending in any of the Cases aforesaid, shall, for each and every such Offence, forfeit and pay any Sum not exceeding Five Pounds.

Gates to open inwards.

LXXXII. And be it further enacted, That no Door or Gate of any Building, Park, Paddock, Field, or Inclosure whatsoever, shall be made to open into or towards any Part of the said Road, or Footpaths belonging thereto, or be suffered to continue so to open, except the Hanging Post thereof shall be Thirty Feet at least from the Centre of any such Part of the said Road; and the Occupier or Occupiers of every Park, Paddock, Field, or Inclosure, having any Door or Gate opening towards the said Road, contrary to the Meaning of this Act, shall, within Fourteen Days after Notice to him, her, or them given, either personally or in Writing from the Surveyor of the said Road, cause such Gate to be hung, so that no Part of the Door or Gate when open shall project over any Part of the said Road, or any Footpath belonging thereto; and in Default thereof, the Surveyor of the said Road is hereby authorized to cause the Door or Gate to be hung according to the Intention of this Act; and the Person or Persons guilty of such Neglect or Default, shall upon Complaint made to any Justice or Justices of the Peace acting in and for the County and Place where such Neglect shall happen, and upon Conviction upon the Oath of One credible Witness, pay to such Surveyor such Sum as the said Justice or Justices shall direct, to defray the Expence of making the Alteration and hanging such Doors or Gates, and shall also forfeit and pay a further Sum not exceeding Forty Shillings for his, her, or their Neglect therein, to be fixed by and at the Discretion of the Justice or Justices before whom such Conviction shall be made.

Impounding Cattle stray-ing-on the Road.

LXXXIII. And be it further enacted, That, if any Horse, Swine, or other Beast or Cattle of any Kind, shall at any Time be found wandering, straying, or lying about the said Road, or any Part thereof, or by the Sides thereof (except where the same shall lead over any Commons or Waste Grounds), it shall and may be lawful to and for the Surveyor of the said Trustees for the Time being, or any other Person or Persons whomsoever, to seize and impound every such Horse, Swine, or other Beast or Cattle, in the Common Pound of the Parish, Township, Tything, or Place where the same shall be, or in such other Place as the said Trustees shall appoint, and the same there to detain until the Owner or Owners thereof shall, for every and each Horse, Swine, or other Beast or Cattle so impounded, pay the Sum of Ten Shillings to the Person impounding the same, together with the reasonable Charges and Expences of impounding and keeping the same; and in case the said Penalty, Charges, and Expences, shall not be paid within Ten Days after such impounding, it shall and may be lawful to and for the said Trustees to sell, or cause to be sold, every such Horse, Swine, or other Beast or Cattle, and the Money arising from such Sale, after deducting the said Penalty and Charges and Expences of impounding, keeping, and selling every such Horse, Swine, or other Beast or Cattle, shall be paid to the Person whose Property the same so sold shall appear to have been.

Punishment of Persons guilty of Pound Breach.

LXXXIV. And be it further enacted, That in case any Person or Persons shall release or attempt to release any Cow, Horse, Ass, Swine, or other Live Stock or Cattle, which shall be seized for the Purpose of being impounded, under the Authority of this Act; or shall release or attempt to release any Horse, Cow, Ass, Swine, or other Live Stock or Cattle, which shall

shall be impounded under the Authority of this Act, from the Pound or Place where the same shall be so impounded; or shall pull down, damage, or destroy the same Pound or Place, or any Part thereof, or any Lock or Bolt belonging thereto, or with which the same shall be fastened; or shall rescue or release, or attempt to rescue or release, any Distress or Levy which shall be made under the Authority of this Act, until or before such Cow, Horse, Ass, Swine, or other Live Stock or Cattle seized or so impounded, or such Distress or Levy so made, shall be discharged by due Course of Law, every Person so offending shall, upon Conviction thereof before any One of His Majesty's Justices of the Peace for the County or Place where the Offence shall have been committed, either upon the Confession of the Party or Parties offending, or upon the Oath of one credible Witness, and which Oath the said Justice is hereby authorized and empowered to administer, be committed by such Justice, by Warrant under his Hand and Seal, to the Common Gaol or House of Correction of the County or Place wherein the said Offence shall have been committed, there to remain without Bail or Mainprize for any Time not exceeding Three Calendar Months.

LXXXV. And be it further enacted, That all Owners, Occupiers, Persons liable Grantees, Trustees, Feoffees, and Committees of any Lands, Tenements, to repair Rents, or Annuities, or any Sum or Sums of Money which have been given Roads to or are liable to the maintaining or amending of any Part or Parts of the said Turnpike Road, or any Bridge or Bridges, or other necessary Things thereon, or on any Part or Parts thereof, shall still remain liable and chargeable to the Repair thereof, in such Manner, and to the same Extent, but not in any other Manner nor to any greater Extent than as they were liable and chargeable before the passing of this Act.

LXXXVI. And be it further enacted, That all Persons who by Law are or Statute Lashall be liable to do Statute Work, or are or shall be chargeable towards re-bour, how pairing or amending the said Road, or any Part thereof, shall still remain regulated. liable thereto in like Manner as heretofore; and it shall be lawful for any Two or more Justices of the Peace, within their respective Jurisdictions, and they are hereby empowered and required (upon Application made to them for that Purpose by the said Trustees, or by their Clerk or Clerks or Surveyor, by their Order) from Time to Time to adjudge, apportion, and determine what Part or Proportion, and how much of the Statute Work and Duty shall every Year be done or performed upon the said Road by the Inhabitants of the Parishes, Townships, Tithings, Hamlets, Districts, Divisions, or Places in which the said Road does lie, and other Persons so liable and chargeable as aforesaid, and also what Proportion and how much of the Money received by the Surveyor or Surveyors of the Highways, of every Person and of every such Parish, Township, Tithing, Hamlet, District, Division, or Place, in lieu of or as a Composition for such Statute Work or Duty, shall be by him, her, or them paid to the said Trustees, or their Treasurer; and in order thereunto it shall be lawful for such Justices, from Time to Time, to summon the Surveyor or Surveyors of the Highways for every such Parish, Township, Tithing, Hamlet, District, Division, or Place, to bring in Lists unto and before such Justices, at some Place and Time to be expressed in such Summons

(within Ten Days after the serving of such Summons), containing the Names of the several Persons who within such Parish, Township, Tithing, Hamlet, District, Division, or Place, are by Law subject and liable and chargeable to do and perform Statute Work or Duty for that Year, or to the Payment of any Money in lieu of or as a Composition for such Statute Work or Duty, distinguishing the Nature of the Work to be done, whether with Teams or Draughts or otherwise, and specifying the Amount of the respective Sums to be paid; which Lists of Names shall be made in such Manner, and under such Regulations and Restrictions, as is, are, or may be limited, directed, and appointed by any Law or Statute in force and effect for the Repair of the Public Highways; and out of such Lists the said Justices respectively shall or may allot, appoint, order, and direct such and so many of the Persons who shall appear to be subject or liable to Statute Work or Duty as aforesaid, to do and perform such Number of Days Statute Work or Duty as aforesaid, in every Year upon the said Road, as the said Justices shall think proper and reasonable, and the same shall be done on such Days and at such Times (not being Seed-time, Hay-time, or Harvest), and on such Part or Parts of the said Road, as the said Trustees, or their Surveyor or Surveyors for the Time being, shall from Time to Time order, direct, and appoint; and the said Trustees may also order, apportion, direct, and appoint the Persons who by such Lists shall appear to be subject or liable to the Payment of any Money in lieu of or as a Composition for Statute Work or Duty as aforesaid, to pay such Proportion thereof as the Justices shall think proper, to the Surveyor or Surveyors of every such Parish, Township, Tithing, Hamlet, District, Division, or Place, for the Time being, to be by him or them paid over to the said Trustees or their Treasurer, at such Time or Times as the said Trustees shall direct; and in Default of Payment thereof, the same shall or may be recovered by Distress and Sale of the Goods and Chattels of the respective Persons liable to the Payment thereof, in like Manner as any Penalty is by this Act authorized to be recovered; and each and every Person who shall neglect or refuse to do and perform such Statute Work as aforesaid (after Notice in Writing given to or left for him, her, or them, at his, her, or their last or usual Place or Places of Abode for that Purpose, signed by the Surveyor or Surveyors to the said Trustees), shall for every Day of his, her, or their Default, or the Default of any Labourer or Labourers, Team or Teams, Draught or Draughts, Horse or Horses, Beast or Beasts, to be provided by him, her, or them, be subject and liable to such Pains, Penalties, and Forfeitures, as such Person or Persons may be subject or liable to by any Law or Statute in force and effect for the Repair of the Public Highways; and if any Person who shall come to work as a Labourer, or who shall be sent with any Team or Draught, Horse or Beast, to work on the said Road, shall be found idle or negligent by any Surveyor to the said Trustees, such Surveyor is hereby empowered to remove and furn off the Person who shall be found idle or negligent as aforesaid; and in that Case the Person so coming to work, or sending such Labourer as aforesaid, shall be liable to the respective Forfeitures and Penalties aforesaid, as if he had neglected or refused to come, or to send a Labourer, or furnish such Team or Draught, Horse or Beast, to work on any Part of the said Road; and in case the said Surveyor or Surveyors of the Highways for

any of the said Parishes, Townships, Tithings, Hamlets, Districts, Divisions, or Places in which the said Road shall lie, shall refuse or wilfully neglect to give in such Lists as aforesaid, or shall knowingly or wilfully give in false or imperfect Lists, or shall refuse and neglect to collect and pay such Composition Money, or any Part thereof, in Manner aforesaid, every such Surveyor so offending shall, for every such Offence, forfeit and pay any Sum not exceeding Five Pounds; all which Forfeitures shall be paid to the Treasurer or Treasurers to the said Trustees, and applied towards amending the said Road.

LXXXVII. And be it further enacted, That it shall be lawful for the said Trustees may Trustees, and they are hereby authorized and empowered, to compound compound for and agree, by the Year or otherwise, with any of the Inhabitants or Oc- Statute Duty. cupiers of Lands, Tenements, or Hereditaments of or in any of the Parishes, Townships, Tithings, Hamlets, or Places in which the said Road shall lie and be situate, or with any Person or Persons whatever liable or chargeable in any Capacity to the repairing and amending the said Road, for a certain Sum of Money in lieu of the Whole or any Part of their Statute Work, or his, her, or their repairing and amending the said Road, or to compound with the Surveyor of the Highways for any such Parishes, Townships, Tithings, Hamlets, or Places, for the Whole or any Part of the Statute Work, or repairing and amending of the said Road, liable to be performed within the same respectively; all which Composition Monies shall be from Time to Time paid in advance, and shall be applied in repair of the said Road.

LXXXVIII. And be it further enacted, That the respective Surveyors of Surveyors, the Highways, or the Churchwardens or Overseers of the Poor, who shall pay any such Composition Money, shall be repaid or reimbursed the Composition Money paid by them respectively, with the Costs and Charges attending such Recovery, by the several Ways and Means, and in such Manner as by the Laws in being Surveyors of the Highways are to be paid or reimbursed the Monies by them expended in buying Materials for repairing the Highways.

LXXXIX. Forfeitures.

XCI. And be it further enacted, That all Penalties, Forfeitures, and Fines Penalties and hereby inflicted or authorized to be imposed, (the Manner of levying, recovering, and applying whereof is not herein otherwise directed) shall, upon Proof of the Offences respectively, before any Justice of the Peace for the County or Place where the Offence shall be committed (as the Case may require), either by the Confession of the Party offending, or by the Oath of any credible Witness or Witnesses, which Oath such Justice is hereby authorized to administer, be levied, together with the Costs attending the Information and Conviction, by Distress and Sale of the Goods and Chattels of the Party or Parties offending, by Warrant under the Hand and Seal of such Justice, (which Warrant such Justice is hereby empowered and required to grant); and the Overplus (if any) after such Penalties,

Penalties, Forfeitures, and Fines, and the Charges of such Distress and Sale are deducted, shall be returned upon Demand unto the Owner or Owners of such Goods and Chattels, and the Monies arising by such Penalties, Forfeitures, and Fines respectively, when levied, if not otherwise directed to be applied by this Act, shall be from Time to Time paid, One Moiety to the Informer and the other Moiety to the Treasurer or and Applica-Treasurers to the said Trustees, and applied for the Purposes of the said tion thereof. Road; and in case such Penalties, Forfeitures, and Fines, respectively, shall not be paid forthwith upon Conviction, then it shall and may be lawful for such Justice to order the Offender or Offenders so convicted to be detained in safe Custody, until Return can be conveniently made to such Warrant or Warrants of Distress, unless the said Offender or Offenders shall give sufficient Security, to the Satisfaction of such Justice, for his or their Appearance before him on such Day, or Days as shall be appointed for the Return of such Warrant or Warrants of Distress, such Day or Days not being more than Seven Days from the Time of taking any such Security, and which Security the said Justice is hereby empowered to take by way of Recognizance or otherwise; but if upon the Return of such Warrant or Warrants, it shall appear that no sufficient Distress can be had thereupon, then it shall be lawful for any such Justice of the Peace, and he is hereby authorized and required, by Warrant or Warrants under his Hand and Seal, to cause such Offender or Offenders to be committed to the Common Gaol of the County or Place aforesaid, or to any House of Correction within the same, there to remain without Bail or Mainprize for any Time not exceeding Three Calendar Months, unless such Penalties, Forfeitures, and Fines, and all reasonable Charges, shall be sooner paid and satisfied.

XCII. And be it further enacted, That it shall and may be lawful for For securing any of the said Trustees, or their Collectors, Surveyors, or other Officers retransient spectively, and such Person or Persons as they or any of them shall call to Offenders. their Assistance, without any Warrant or other Authority than this Act, to seize and detain any Person or Persons, (being unknown to such Trustees, Collectors, Surveyors, or other Officers) who shall commit any Offence or Offences against this Act, and take him, her, or them before any Justice or Justices of the Peace for the County or Place where the Offence or Offences shall be committed, or such Offender or Offenders shall be seized and apprehended; and such Justice and Justices shall and is and are hereby required to proceed and act with respect to such Offender or Offenders according to the Provisions of this Act.

XCIII. XCIV. And be it further enacted, That in case any Dispute, Suit, or Litigation shall arise touching or in anywise relating to the Tolls granted by this Act, the Person or Persons appointed to collect the same, or any other Person or Persons acting under the Authority of the Trustees, shall not be incompetent to give Evidence in any such Dispute, Suit, or Litigation, on account of his being appointed to collect such Tolls.

Proceedings not to be quashed for want of Form.

XCV. And be it further enacted, That no Order made touching or concerning any of the Matters in this Act contained, or any Proceeding to be had touching the Conviction of any Offender or Offenders against this Act, shall be quashed for want of Form, or be removed or removable by Certiorari, or any other Writ or Process whatsoever, into any of His Majesty's Courts of Record at Westminster; and that where any Distress shall be made for any Sum or Sums of Money to be levied by virtue of this Act, the Distress itself shall not be deemed unlawful, nor the Party or Parties making the same be deemed a Trespasser or Trespassers, on account of any Defect or Want of Form in the Summons, Conviction, Warrant of Distress, or other Proceedings relating thereto; nor shall the Party or Parties distraining be deemed a Trespasser or Trespassers ab initio, on account of any Irregularity which shall be afterwards done by the Party or Parties distraining, but the Person or Persons aggrieved by such Irregularity shall and may recover full Satisfaction for the special Damage (if any) in an Action upon the Case; but no Plaintiff or Plaintiffs shall recover in any such Action for such Irregularity as aforesaid, if Tender of sufficient Amends hath been made, for or on behalf of the Party distraining before such Action brought.

Persons aggrieved may appeal to Quarter Sessions.

XCVI. Provided always, and be it further enacted, That if any Person or Persons shall think himself, herself, or themselves aggrieved by any thing done in pursuance of this Act, and for which no particular Method of Relief hath been already appointed, such Person or Persons may appeal to the Justices of the Peace, at their next General Quarter Sessions of the Péace to be holden for the County or Place in which the Cause of Complaint shall arise (as the Case may be), unless such Complaint shall arise within Twenty-one Days preceding such Sessions, in which Case such Appeal may be brought at the Second Sessions after such Cause shall arise; such Appellant or Appellants first giving, or causing to be given, Fourteen Days Notice in Writing of his, her, or their Intention to bring such Appeal, and of the Matter thereof, to the Clerk or Clerks of the said Trustees, or other the Respondent or Respondents, and within Four Days after such Notice entering into a sufficient Recognizance before some Justice of the Peace for such County or Place (as the Case may be), with Two sufficient Sureties, conditioned to try such Appeal, and abide the Order of, and pay such Costs as shall be awarded by the Justices at such Sessions; and the said Justices at such Sessions, upon due Proof of such Notice being given

as aforesaid, and of the entering into such Recognizance, shall hear and finally determine the Cause and Matter of such Appeal in a summary Way, and award such Costs to the Party or Parties appealing or appealed against, as they the said Justices shall think proper; and the said Justices may, if they see Cause, by Order of such Sessions, mitigate, at their Discretion, any Fine, Penalty, or Forfeiture, and also may order such further Satisfaction to be made to the Party or Parties so injured, as they shall judge reasonable, or vacate or set aside the Conviction or Convictions, and set the Parties at Liberty, or otherwise may ratify or confirm the same, with such Costs as to them, in their Discretion, shall seem reasonable; and the Determination of the Justices at such Quarter Sessions shall be final, binding, and conclusive to all Intents and Purposes; and the said Justices may also at such Sessions, by their Order or Warrant, levy such Costs so awarded, by Distress and Sale of the Goods and Chattels of the Person or Persons who shall refuse to pay the same, and for Want of sufficient Distress, may commit the Person or Persons to the Common Gaol or House of Correction within the same County or Place (as the Case may be) where the Offence shall be committed, for any Time not exceeding the Term of Six Calendar Months, or until Payment of such Costs.

XCVII. And be it further enacted, That no Action or Suit shall be com- Limitation menced against any Person or Persons, for any thing done in pursuance of Actions. of this Act, until Fourteen Days Notice thereof shall be given to the Clerk or Clerks to the said Trustees, nor after sufficient Satisfaction, or a Tender thereof, hath been made to the Party or Parties aggrieved, nor after Three Calendar Months next after the Fact committed; and every such Action shall be laid and tried in the County where the Cause of Action shall have arisen, and not elsewhere; and the Defendant or Defendants in every such Action or Suit shall or may, at his and their Election, plead specially, or the General Issue, and give this Act and the special Matter in Evidence at any Trial to be had thereupon, and that the same was done in pursuance and by the Authority of this Act; and if the same shall appear to be so done, or that such Action or Suit shall be brought before Fourteen Days Notice thereof shall have been given as aforesaid, or after a sufficient Satisfaction made or tendered as aforesaid, or after the Time limited for bringing the same as aforesaid, or if such Action shall be brought in any other County, then the Jury shall find for the Defendant or Defendants; and upon such Verdict, or if the Plaintiff or Plaintiffs shall be nonsuited, or discontinue his, her, or their Action or Actions after the Defendant or Defendants shall have appeared, or if upon Demurrer Judgment shall be given against the Plaintiff or Plaintiffs, then the Defendant or Defendants shall and may recover Treble Costs, and have such Remedy for recovering the same, as any Defendant or Defendants hath or have in any Case by Law.

XCVIII. And be it further enacted, That this Act shall be deemed public Act. and taken to be a Public Act, and shall be judicially taken Notice of as such, by all Judges, Justices, and others, without being specially pleaded.

The Commencement and Continuance of Act. XCIX. And be it further enacted, That this Act shall commence upon the passing thereof, and shall from thenceforth continue to be in force for the Term of Twenty-one Years, and from thence to the End of the then next Session of Parliament.
