An Act to amend an Act passed in the Fifth Year of the Reign of His present Majesty, for the completing the Harbour of *Courtown*, near *Brenogue Head*, in the County of *Wexford*.

[17th June 1830.]

WHEREAS by an Act passed in the Fifth Year of His present Majesty, intituled *An Act for completing the Port or Harbour of Courtown at Brenogue Head, near Courtown, in the County of Wexford*, certain Persons therein named, and their Successors, were constituted Commissioners for the Purposes of the said Act, and formed into One Body Corporate by the Name of "The Commissioners of the Harbour of *Courtown*," with certain Powers and Provisoes therein further declared, and among other Things the following; that for the more speedily raising Money for defraying the Expences of the said Act, and for carrying the several Purposes thereof into complete Execution, it shall be lawful for the said Commissioners, or any Three or more of them, at any Meeting holden under or by virtue of the said Act, and they are thereby fully authorized and empowered, from Time to Time to borrow and take up at Interest any Sum or Sums of Money upon the Credit of the Rates or Duties thereby granted, so that no greater Sum than Six thousand Pounds shall be due and owing upon the Credit of the said Rates and Duties at any one Time, and by Writing under their Hands and Seals to mortgage and assign over the said Rates or Duties, or any Part thereof,

thereof, to the Person or Persons who shall advance and lend such Money, as the Security for such Money to be borrowed, together with Interest for the same : And whereas by a Deed of Indenture, bearing Date the Ninth Day of *February* One thousand eight hundred and twenty-eight, the said Commissioners did grant, mortgage, assign, and let over unto *William Holden* Esquire, Secretary to the Commissioners appointed to carry into execution an Act made in the Fifty-seventh Year of His late Majesty King *George* the Third, intituled *An Act to authorize the Issue of Exchequer Bills for carrying on public Works and Fisheries in the United Kingdom*, and further subsequent Acts amending the same, all the Rates, Duties, and Sums of Money which should thereafter accrue to the said Commissioners in respect of the Act aforesaid, as Security for the Repayment, with Interest, of the Sum of Six thousand Pounds in Exchequer Bills borrowed from and advanced by the said Commissioners for the Execution of the last-mentioned Act to the Commissioners of the Harbour of *Courtown* aforesaid, for the Execution of certain Works specified in the aforesaid Deed of Indenture : And whereas the Works so specified are now very nearly completed, but on account of the great Expence of the Works above what was expected at the Time of the Indenture aforesaid, and the Necessity of giving further Accommodation for the Shipping expected to frequent the Port, it has been found necessary to go to a greater Expence than the Sum of Six thousand Pounds so borrowed and expended ; and certain Persons have advanced, of their own proper Monies, certain Sums for the above Purposes, and are willing to expend a farther Sum for the completing and extending the said Harbour, provided Security could be granted upon the future Rates and Returns of the said Harbour, after the above Sum of Six thousand Pounds shall have been paid off with Interest, but which the said Commissioners of the Harbour of *Courtown* are not now empowered by Law to give : And whereas the completing and extending the Harbour would be a Work of the greatest Utility to the Inhabitants of the Counties of *Wicklow* and *Wexford*, and to all seafaring Persons navigating the Eastern Coast of *Ireland* ; and the Pier, Locks, and other Works now executed will require a constant Expenditure to keep them from Decay : And whereas the said recited Deed of Indenture, and the Principal Monies and Interest accruing thereon, are the primary Charges upon the Rates and Duties aforesaid : May it therefore please Your Majesty that it may be enacted ; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That so much and no more of the said recited Act of the Fifth of His present Majesty as limits the Monies to be borrowed and due at any one Time upon the Security of the said Rates and Duties to the Sum of Six thousand Pounds, shall be and the same is hereby repealed and made void ; and that from and after the passing of this Act the said Commissioners of the Harbour of *Courtown* shall be and are hereby fully authorized and empowered from Time to Time, for carrying the several Purposes of the said Act and of this Act into complete Execution, to borrow and take up at Interest any Sum or Sums of Money upon the Credit of the Rates and Duties granted by the said recited Act or by this Act,

So much of recited Act as limits the borrowing of Money to 6,000*l.* repealed ; and Authority given to borrow a larger Sum.

so that no greater Sum than Twenty thousand Pounds shall be due and owing upon the Credit of the same Rates and Duties at any one Time, and by Writing under their Hands and Seals to mortgage and assign over the said Rates or Duties, or any Part thereof, to the Person or Persons who shall advance and lend such Money, as the Security for such Money to be borrowed, together with Interest for the same ; and every such Agreement may be to the Form and Effect prescribed in the said recited Act.

II. And be it further enacted, That the said recited Act of the Fifth Year of the Reign of His present Majesty, and all and every the Powers, Provisoes, Authorities, and other Matters and Things therein contained, (save and except such of them, or such Part or Parts thereof, as are varied, altered, or repealed,) shall remain and continue in full Force and Effect, and be as good, valid, and effectual, to all Intents and Purposes, for carrying this Act into Execution, as if the same had respectively been repeated and re-enacted in the Body of this Act. Extending Provisions of former Act to this Act.

III. And be it further enacted, That all the Costs, Charges, and Expences of and incidental to the obtaining and passing this Act, and of carrying the same into effect, shall and may be defrayed and paid by the said Commissioners out of the Monies received or to be received by them under the Authority of the said recited Act and this Act, in preference to any other Payment. Expences of Act.

IV. And be it further enacted, That this Act shall be deemed and taken to be a Public Act, and shall be judicially taken notice of as such by all Judges, Justices, and others, without being specially pleaded. Public Act.
