

CHAPTER clxxiv.

An Act to confirm a Scheme of the Charity Commissioners A.D. 1911. for the application and management of the Charity in the city and county of Gloucester consisting of the yearly sum of eighty pounds applicable towards the reparation of the Bridge and Causeway lying between the said city and the village of Over.

[16th December 1911.]

Majesty of their proceedings during the year one thousand nine hundred and ten have reported that they have approved and certified a scheme for the application and management of the charity consisting of the yearly sum of eighty pounds applicable towards the reparation of the bridge and causeway lying between the said city and the village of Over on the west side of the said city under a scheme made for the Gloucester United Endowed Schools under the Endowed Schools Acts 1869 1873 and 1874 on the third day of May one thousand eight hundred and eighty-two and comprised in an Order made by the Charity Commissioners on the fifth day of May one thousand nine hundred and five under subsection two of section two of the Board of Education Act 1899:

And whereas it is expedient that the scheme as the same is fully set out and defined in the schedule to this Act should be confirmed:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

1. The said scheme is hereby confirmed Provided always Confirmation that nothing in this Act or in the said scheme shall be held to of scheme.

SCHEME FOR THE APPLICATION AND MANAGEMENT OF THE CHARITY IN THE CITY AND COUNTY OF GLOUCESTER CONSISTING OF THE YEARLY SUM OF EIGHTY POUNDS APPLICABLE TOWARDS THE REPARATION OF THE BRIDGE AND CAUSEWAY LYING BETWEEN THE SAID CITY AND THE VILLAGE OF OVER.

- 1. Union with Gloucester United Schools.—The above-mentioned yearly sum shall henceforth form part of the endowment of the Foundation called the Gloucester United Schools and comprised in a scheme of the Board of Education of the thirteenth February one thousand nine hundred and six as altered by a scheme of the same Board of the twenty-seventh May one thousand nine hundred and ten.
- 2. Exhibitions.—The said yearly sum shall be applied by the Governors of the said Foundation for or towards the maintenance of an exhibition in connection with the Crypt Grammar School in conformity with the provisions of clauses sixty-four and sixty-five of the said scheme of the thirteenth February one thousand nine hundred and six as altered as aforesaid.
- 3. Alteration of Scheme.—The Board of Education may from time to time in the exercise of their ordinary jurisdiction establish schemes for the alteration of any provisions of this scheme as if those provisions had been made by the founder in the case of a Foundation having a founder.
- 4. Questions under Scheme.—Any question as to the construction of this scheme or as to the regularity or the validity of any acts done or about to be done under this scheme shall be determined conclusively by the Board of Education upon such application made to them for the purpose as they may think sufficient.
