CHAPTER cxii.

An Act to confirm certain Pilotage Orders made A.D. 1921. by the Board of Trade under the Pilotage Act 1913 relating to pilotage in the Pilotage Districts of Barry Bristol Cardiff Gloucester Llanelly Newport Port Talbot and Swansea.

[19th August 1921.]

A7 HEREAS the Board of Trade have made the Pilotage Orders set forth in the Schedule hereto under the provisions of the Pilotage Act 1913 but the same do not take effect unless and until confirmed by Parliament:

And whereas it is expedient that the said Pilotage Orders should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

1. The Pilotage Orders as amended and set out in Confirmation the schedule hereto shall be and the same are hereby confirmed and all the provisions thereof shall have full validity and force.

2. Nothing contained in any Order confirmed by this Saving as Act shall render compulsory the pilotage of any ship carrying passengers and navigating to or from the Port of in certain Bristol in any waters lying to the west of an imaginary straight line drawn from Nash Point to Hurlstone Point in the Bristol Channel.

The limits of the Barry Pilotage District (herein-Pilotage after referred to as "the Pilotage District") shall be the waters District. of the Bristol Channel bounded seawards by an imaginary straight line drawn from the Lighthouse at Hartland Point to the Southern Lighthouse on Lundy Island and thence through Caldy Island Lighthouse to the mainland and landwards by an imaginary straight line drawn from Gold Cliff Point to Clevedon Pier Head Light but excluding all docks (but not any entrance basin or lock leading thereto) Provided always that nothing in this section shall extend to authorise a pilot licensed for the Pilotage District to pilot a vessel within any part of this area which lies within any Trinity House Outport District if such vessel is proceeding to or from or making use of a port in that district.
- 2. Pilotage shall not be compulsory in the Pilotage Pilotage not to District.

3.—(1) There shall be constituted for the Pilotage District Pilotage a Pilotage Authority which shall be a body corporate with Authority. perpetual succession and a common seal by the name of the Barry Pilotage Authority (hereinafter referred to as "the Authority") and shall consist of members appointed and elected as follows:---

- (a) Three members appointed by the Barry Railway Company;
- (b) Six members (hereinafter referred to as "shipowners" representatives") appointed by the Cardiff and Bristol Channel Incorporated Shipowners' Association or if at any time that body shall in the opinion of the Board of Trade cease to be fairly representative of the shipowners making use of Barry Docks then by such body or bodies representing shipowners as shall be nominated for the purpose by the Board of Trade;
- (c) Three members from among the five persons (hereinafter referred to as pilots' representatives") elected in manner hereinafter provided by the pilots licensed for the Pilotage District (hereinafter referred to as "licensed pilots") from among persons who either are or have been licensed pilots.
- (2) The members of the Authority shall be appointed and elected respectively at the times and in the manner in the Schedule hereto provided.

4. The chairman of the Authority shall be nominated by the Barry Railway Company from among the members appointed by them and shall remain in office until the next triennial appointment and election of members has taken place.

Proceedings of the Authority.

- 5.—(1) The chairman if present shall preside at every meeting of the Authority If the chairman is absent from any meeting such other member as the members then present choose shall preside.
- (2) Every question at a meeting of the Authority shall be decided by a majority of the votes of the members of the Authority present and voting on that question and in the case of equality of votes the person presiding at the meeting shall have a second or casting vote.
 - · (3) The quorum of the Authority shall be five.
- (4) No member of the Authority shall take part in any proceedings of the Authority relating to any question affecting himself personally.
- (5) Subject to the provisions of this Order the Authority may regulate their own procedure.
- (6) No act or proceeding of the Authority shall be invalid on account of any vacancy in their body or on account of the appointment election or ascertainment of any member having been defective.

Period of office.

6. Members of the Authority shall hold office from the date of their appointment or election respectively until such time as their successors may be appointed or elected respectively but shall be eligible for re-appointment or re-election respectively.

7. Until all the members of the Authority have been appointed or elected under the provisions of this Order the members of the existing Barry Pilotage Board (hereinafter referred to as "the Board") constituted under the Barry Dock and Railways Act 1889 shall be deemed to be members of the Authority as though they had been appointed or elected under the provisions of this Order.

Vesting of property.

8. All property (real or personal) rights easements and choses in action which immediately before the commencement of this Order belonged to or were vested in or enjoyed by the Board or by any person in trust for them or on their behalf shall be and the same hereby are vested in the Authority to the same extent and for the same estate and interest as the same were immediately before the commencement of this Order vested in the Board or any person in trust for them or on their behalf and may be held recovered and enjoyed accordingly.

9.—(1) If at the date of the commencement of this Order any proceeding or cause of action is pending or existing by or against the Board the same shall not abate discontinue or be in any way prejudicially affected by reason of anything in this Pending Order but the proceeding or cause of action may be continued proceeding prosecuted and enforced by or against the Authority as it might have been by or against the Board if this Order had not been made but not further or otherwise.

The Authority may from time to time if they think fit Power to purchase hire or build and equip maintain and work or enter provide or into agreement or arrangements with any persons for the supply arrange for use maintenance and working of such boats or vessels as in pilot boats. the opinion of the Authority may be required for the efficient working of the pilotage service If a majority of the pilots concerned object to the Authority exercising these powers or if a difference arises between the Authority and the pilots as to the conditions on which these powers should be exercised the matter shall be referred to the Board of Trade whose decision shall be final.

11. A pilot's licence granted by the Authority shall only Extent of entitle the holder to pilot a vessel which is bound to or from Barry pilote' Barry Docks but in the case of an incoming vessel bound to licences. Barry Roads for orders a statement by the officer in charge of the Barry Island Signal Station that the vessel will on arrival there be ordered to Barry Docks shall be sufficient authority for a Barry pilot to pilot the vessel.

12. When in any part of the Pilotage District in which Supersession concurrent jurisdiction is exercised by the Authority and any of pilots other Pilotage Authority or Authorities a ship bound for where con-Barry Docks is under the pilotage of a pilot licensed by any diction is such other Authority that pilot shall be superseded by a pilot exercised. licensed by the Authority on his offering his services and the pilotage rates payable shall be divided between the two pilots in such proportion as may in case of dispute be determined by the Authority.

Two or more Authorities may agree for joint pilotage service.

13. The Authority may at any time agree with any other Pilotage Authority having jurisdiction in the Bristol Channel to provide for a joint pilotage service for their respective districts in lieu of a separate pilotage service for each of such districts and thereupon such Authorities shall appoint some of their members to act as a joint committee and to consist of such number of persons and to exercise such of the powers exercisable by such Authorities and generally to act, in such manner as such Authorities shall from time to time direct and upon such terms and conditions as may be agreed upon between such Authorities.

Repeal.

14. Sections 13 and 15 to 19 of the Barry Dock and Railways Act 1889 and the provisions of the Bristol Channel Pilotage Act 1861 so far as they affect the Pilotage District and any other enactment or order relating to pilotage in the Pilotage District shall cease to have effect and shall for the purposes of Section 59 of the Pilotage Act 1913 be deemed to be superseded.

Date of commencement.

15. This Order shall come into force on the day when the Act confirming this Order is passed.

Short title.

16. This Order may be cited as the Barry Pilotage Order 1921.

SCHEDULE.

With respect to the appointment and election of the Authority the following provisions shall have effect that is to say:—

- 1. The persons to be appointed by the Barry Railway Company and the shipowners' representatives shall be appointed in the month of October in the year nineteen hundred and twenty-one and each third year thereafter.
- 2.—(1) The pilots' representatives shall be elected by the licensed pilots in the month of October in the year nineteen hundred and twenty-one and each third year thereafter.
- (2) For the purpose of electing the pilots' representatives the clerk to the board in the case of the first election and thereafter the secretary to the Authority shall send out by registered letter to all the licensed pilots a circular announcing an election and enclosing a list of persons qualified under this Order to be pilots' representatives a voting card and a stamped envelope addressed to himself in which the card when filled in is to be returned within twenty-one days of the issue of the circular.

(3) Every licensed pilot shall be entitled to vote for five A.I persons whose names are on the said list but shall not give more than one vote for any one person.

- (4) At the expiration of twenty-one days from the issue of the said circular the said clerk in the case of the first election and thereafter the said secretary shall examine the voting cards returned to him and shall prepare a list in order of the five persons who have received the greatest number of votes (any uncertainty by reason of two or more persons having received an equal number of votes being decided in favour of the licensed pilot or pilots having the longest service) and such persons shall thereupon be the pilots' representatives. This list shall be posted up in the pilots' office.
- (5) The first three pilots' representatives on the list referred to in the preceding subsection shall be members of the Authority but in the event of one or more of these being unable to attend any meeting of the Authority one or both as the case may be of the two other pilots' representatives may according to the order in which their names appear on the list attend take part in the proceedings and vote in his or their stead.
- 3. The costs charges and expenses of and preliminary and incidental to the election of pilots' representatives shall be paid by the Authority out of the pilot fund.
- 4. In the event of any vacancy among the appointed or elected members of the Authority arising otherwise than by effluxion of time the vacancy shall be filled as soon as may be thereafter in the manner prescribed for the triennial appointment or election but any person so appointed or elected shall hold office only until the next triennial appointment or election.

Limits of compulsory pilotage.

2. Pilotage shall be compulsory in that portion of the Pilotage District which lies eastwards of an imaginary line drawn from Gold Cliff Point to Clevedon Pier Head Light.

Pilotage Authority. 3. The Pilotage Authority for the Pilotage District shall be the Lord Mayor Aldermen and Burgesses of the City of Bristol (hereinafter referred to as "the Authority").

Pilotage Committee. 4.—(1) There shall be established a Pilotage Committee (hereinafter referred to as "the Committee") of the Authority consisting of members appointed and elected as follows:—

(a) Seven members appointed by the Authority from among their own members of whom one shall be nominated as chairman;

(b) Three members (hereinafter referred to as "shipowners representatives") appointed by the Bristol Steamship Owners' Association or if at any time that body shall in the opinion of the Board of Trade cease to be fairly representative of the shipowners using the Port of Bristol then by such body or bodies representing shipowners as shall be nominated for the purpose by the

The Authority may at any time agree with any other Pilotage Authority having jurisdiction in the Bristol Channel to provide for a joint pilotage service for their respective districts in lieu of a separate pilotage service for each of such districts and thereupon such Authorities shall appoint some of their members to act as a Joint Committee and to consist of such number of persons and to exercise such of the powers exercisable by such Authorities and generally to act in such manner as such Authorities shall from time to time direct and upon such terms and conditions as may be agreed upon between such Authorities.

Provision as to compention.

- 13.—(1) If it shall be proved to the satisfaction of an arbitrator to be appointed by the Board of Trade on the application in writing of not less than one third of such of the licensed pilots as were licensed prior to the commencement of this Order—
 - (a) that a diminution in the employment of or other loss to such pilots has occurred; and
 - (b) that such diminution or loss has been caused by the operation of this Order so far as it reduces the area within which prior to the commencement of this Order pilotage was compulsory and has not been adequately met by increased pilotage rates or by provisions for superannuation or otherwise;
